

# Ad Hoc Committee on Health Care Workforce

**PURPOSE:** The Committee shall research and make recommendations for the collection of publication relevant data concerning the health care professions workforce, including (1) the organization and administration of the data collection process; (2) identify costs and funding mechanisms related to data collection and reporting; and (3) means to provide appropriate oversight of the data collection process and fund expenditures. The Committee shall submit a report on its findings and recommendations on or before January 10, 2018 to the President of the Senate and the Speaker of the House of Representatives.
