- (24) The Commissions on Appellate and Trial Court Appointments has been consolidated within the Supreme Court Judicial Performance Review Special Line Item as of FY 1997.
- (25) The Commission on Judicial Conduct has been consolidated as a Special Line Item within the Supreme Court as of FY 1997.
- (26) Agriculture Employment Relations Board was placed in the Department of Agriculture's budget in FY 1997 and is funded from the General Fund.

- (30) School Facilities Board was created by Laws 1998, Chapter 1, 3rd Special Session, as amended by Laws 1998, Chapter 164. It replaces the State Board for School Capital Facilities and continues to distribute monies encumbered by the School Capital Facilities Board.
- (31) Prior to FY 1999, the Department of Veterans' Services was called the Veterans' Services Commission.
- (32) Laws 2000, Chapter 98 changed the name of the Arizona Council for the Hearing Impaired to the Commission for the Deaf and the Hard of Hearing.
- (33) FY 1999 expenditure of \$730,000 was for the Committee on Juvenile Justice.
- (34) Proposition 106, as passed in November 2000, allocated \$6,000,000 from the General Fund to the Independent Redistricting Commission.
- (35) The Advocate is statutorily established in the Legislative Council, except that the budget for the Advocate is statutorily required to be separate from the budget for the Legislative Council. Laws 2001, Chapter 5, 2nd Special Session amended Laws 2001, Chapter 236, 1st Regular Session to revert the entire FY 2002 appropriation for the Advocate for Private Property Rights. Laws 2002, Chapter 327, reverted the entire FY 2003 appropriation.
- (36) Laws 2002, Chapter 327 changed the name of the Board of Directors for Community Colleges to Arizona Community Colleges.
- (37) Laws 2002, Chapter 327 created the Division of Boxing Regulation within the Department of Racing to provide staff support to the Boxing Commission beginning in FY 2003.
- (38) Effective January 1, 2006, the State Banking Department was renamed to the State Department of Financial Institutions, pursuant to Laws 2004, Chapter 188, Section 3.
- (39) Effective June 30, 2006, the Department of Building and Fire Safety was renamed to the Department of Fire, Building and Life Safety, pursuant to Laws 2005, Chapter 245.
- (40) The State Capital Postconviction Public Defender Office was created by Laws 2006, Chapter 369 in FY 2007.
- (41) Laws 2008, Chapter 57 changed the name of the Board of Homeopathic Medical Examiners to the Board of Homeopathic and Integrated Medicine Examiners.
- (42) Laws 2008, Chapter 16 changed the name of the Naturopathic Physicians Board of Medical Examiners to the Naturopathic Physicians Medical Board.
- (43) Laws 2008, Chapter 309 changed the name of the Structural Pest Control Commission to the Office of Pest Management.
- (44) Monies for the Library and Archives are now shown as a division within the Secretary of State effective FY 2009.
- (45) State Forester is separately appropriated from the State Land Department starting in FY 2011. FY 2009 and FY 2010 have been adjusted for comparability.
- (46) Laws 2011, Chapter 27 (Consolidation Budget Reconciliation Bill) 1) transfers the functions of the Government Information Technology Agency to the Arizona Department of Administration (ADOA); 2) transfers the non-museum functions of the Department of Mines and Minerals into the Arizona Geological Survey. The museum functions had already been transferred to the Arizona Historical Society; 3) transfers the functions of ADOA Capital Police to the Department of Public Safety; 4) transfers the functions of the Biomedical Research Commission to the Department of Health Services.
- (47) Laws 2011, 2nd Special Session, Chapter 1 transfers most of the functions of the Department of Commerce to the Arizona Commerce Authority.
- (48) Any prior payments previously displayed as revenue transfers.
- (49) Deposits of \$250 million to the Budget Stabilization Fund in FY 2012 and \$200 million in FY 2013 are displayed as revenue transfers.
- (50) Laws 2012, Chapter 298 established the Automation Projects Fund, administered by the Arizona Department of Administration.
- (51) The Arizona Department of Administration distributes these monies to counties for maintenance of essential county services.
- (52) The FY 2014 Government Budget Reconciliation Bill (Laws 2013, 1st Special Session, Chapter 2), transfers all monies remaining in the separate subaccount established for the Board of Massage Therapy in the Naturopathic Physicians Medical Board Fund to the Board of Massage Therapy Fund established by A.R.S. § 32-4205, as added by Laws 2013, Chapter 108. This is effective retroactively to July 1, 2013.
- (53) The sum of \$25,000,000 is appropriated in FY 2015 from the State General Fund to the Department of Administration for costs associated with the establishment of the Department of Child Safety (DCS) and the relocation of the data center operated by the Department of Economic Security (DES).

- (54) Executive Order 2007-19 established the Arizona Commission of African-American Affairs. Laws 2010, Chapter 271 statutorily established the Arizona Commission of African-American Affairs under A.R.S. § 41-531. The FY 2015 budget appropriated \$125,000 directly to the commission as a newly-created budget unit. These funds will be used for start-up costs, and to provide the commission with ongoing staffing resources.
- (55) Laws 2014, 2nd Special Session, Chapter 1 removed the Division of Children, Youth and Families from DES and created a new stand-alone child welfare agency, the Department of Child Safety, starting in FY 2015. DES and DCS estimates have been adjusted back to FY 2013 for comparability.
- (56) The FY 2015 budget included \$1,000,000 from the General Fund for a one-time deposit to the Water Supply Development Revolving Fund. Laws 2007, Chapter 226 established the Water Supply Development Revolving Fund, but money has not been previously appropriated for the purpose of community lending. Monies in the fund are to be used to provide financial assistance to construct water supply projects to water providers in Arizona, particularly in rural areas, lacking sufficient water supplies to meet their long-term water demands.
- (57) Laws 2015, Chapter 19 (FY 2016 Agency Consolidation Budget Reconciliation Bill) merges the State Board of Appraisal into the Department of Financial Institutions effective July 3, 2015
- (58) Laws 2015, Chapter 15 (FY 2016 General Appropriation Act) transferred the State Board of Education out of the Department of Education into its own separate unit.
- (59) Laws 2015, Chapter 19 (FY 2016 Agency Consolidation Budget Reconciliation Bill) merges the Arizona Department of Racing to the Department of Gaming effective July 3, 2015
- (60) Laws 2016, Chapter 372 created the Office of Economic Opportunity through the consolidation of various agencies.
- (61) Laws 2016, Chapter 372 specifies that the Water Infrastructure Finance Authority and the Greater Arizona Development Authority will become part of the Arizona Finance Authority within the Office of Economic Opportunity beginning in FY 2017.
- (62) Laws 2016, Chapter 128 (FY 2017 Agency Consolidation Budget Reconciliation Bill) transfers the Department of Fire, Building and Life Safety to the Arizona Department of Forestry and Fire Management, the Arizona Department of Housing, and the State Real Estate Department, effective July 1, 2016.
- (63) Laws 2016, Chapter 145 renames the State Forester to the Arizona Department of Forestry and Fire Management and modifies the duties of the State Forester.
- (64) Laws 2016, Chapter 128 (FY 2017 Agency Consolidation Budget Reconciliation Bill) transfers the statutory responsibilities of the Arizona Geological Survey to the University of Arizona effective July 1, 2016. The FY 2017 Agency Consolidation Budget Reconciliation Bill also transfers the administrative and staff support for the Oil and Gas Conservation Commission, which was previously supplied by the Geological Survey, to the Department of Environmental Quality instead of the University of Arizona.
- The FY 2017 Agency Consolidation Budget Reconciliation Bill renames the Arizona Experience Museum the Mining, Mineral and Natural Resources Educational Museum and transfers the authority to operate and maintain the museum from the Arizona Historical Society to the Geological Survey. If sufficient monies are not raised by July 1, 2018 to sufficiently refurbish and open the museum, then the museum will revert back to the Arizona Historical Society in FY 2019.
- (65) Laws 2016, Chapter 150 repeals the 20-member Arizona Commission of Indian Affairs, and establishes the Governor's Office on Tribal Relations, effective July 1, 2016.
- (66) Laws 2015, Chapter 244 establishes the Weights and Measures Services Division within the Arizona Department of Agriculture (ADA) as of July 1, 2016. All authority, powers, duties and responsibilities previously granted to the Department of Weights and Measures are transferred to the new Division within the ADA, except for:
- Responsibilities relating to taxis, limousines and livery vehicles are transferred to the Arizona Department of Transportation.
 - Responsibilities relating to the Moving Truck Violation Enforcement Program are transferred to the Arizona Department of Public Safety.
