1 INFRASTRUCTURE IMPROVEMENTS IN A MANNER THAT IS PROPORTIONAL TO THE AMOUNT OF
2 NONSTATE FUNDS AS A PERCENTAGE OF TOTAL FUNDING.”

3 Page 7, line 21, strike “A” insert “THE”; strike “UNIVERSITY”

4 Line 22, strike “PROJECT” insert “OF BUILDINGS AND ASSOCIATED IMPROVEMENTS FOR
5 THE BENEFIT OF A UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF
6 REGENTS”

7 Line 24, strike the comma insert “:

8 1. “BUILDINGS AND ASSOCIATED IMPROVEMENTS FOR THE BENEFIT OF THE
9 UNIVERSITY” MEANS ANY BUILDING AND ASSOCIATED IMPROVEMENTS IF THE UNIVERSITY
10 UTILIZES AT LEAST EIGHTY PER CENT OF THE BUILDING AND ASSOCIATED IMPROVEMENTS
11 FOR ACADEMIC PURPOSES.
