2 "Section 1. Repeal

3 Senate Bill 1258, section 2, forty-ninth legislature, first regular
4 session, as transmitted to the governor, is repealed.

5 Sec. 2. Repeal

6 Senate Bill 1258, section 13, forty-ninth legislature, first regular
7 session, as transmitted to the governor, is repealed.

8 Sec. 3. Senate Bill 1258, section 15, forty-ninth legislature, first
9 regular session, as transmitted to the governor, is amended to read:

11 ~~A. Notwithstanding section 37-623.02, subsection D, paragraph 1,~~
12 ~~Arizona Revised Statutes, the sum of \$3,000,000 is transferred from the~~
13 ~~Arizona state parks board heritage fund established by section 41-502,~~
14 ~~Arizona Revised Statutes, to the fire suppression revolving fund established~~
15 ~~by section 37-623.02, Arizona Revised Statutes, on the effective date of this~~
16 ~~act.~~

17 A. DURING FISCAL YEAR 2009-2010, NOTWITHSTANDING SECTION 37-623.02,
18 SUBSECTION D, PARAGRAPH 1, ARIZONA REVISED STATUTES, UP TO \$3,000,000 MAY BE
19 TRANSFERRED FROM THE ARIZONA STATE PARKS BOARD HERITAGE FUND ESTABLISHED BY
20 SECTION 41-502, ARIZONA REVISED STATUTES, TO THE FIRE SUPPRESSION REVOLVING
21 FUND ESTABLISHED BY SECTION 37-623.02, ARIZONA REVISED STATUTES, FOR WILDLAND
22 FIRE SUPPRESSION OR OTHER UNPLANNED RISK EMERGENCY LIABILITIES. THE STATE
23 FORESTER SHALL NOTIFY THE DIRECTOR OF THE ARIZONA STATE PARKS BOARD AND THE
24 STATE TREASURER WHEN A LIABILITY HAS BEEN INCURRED AND THE STATE TREASURER
25 SHALL TRANSFER MONIES TO THE FIRE SUPPRESSION REVOLVING FUND ESTABLISHED BY
26 SECTION 37-623.02, ARIZONA REVISED STATUTES.

27 B. The monies transferred under subsection A of this section are in
28 lieu of any other monies that are made available from the state general fund

1 for fiscal year 2009-2010 for fire suppression by the state forester for the
2 purposes of section 37-623.02, Arizona Revised Statutes.

3 ~~C. Notwithstanding section 37-623.02, subsection I, Arizona Revised~~
4 ~~Statutes, if the unobligated balance of the fire suppression revolving fund~~
5 ~~exceeds two million dollars at the end of calendar year 2010, the excess~~
6 ~~shall be transferred to the Arizona state parks board heritage fund.~~

7 Sec. 4. State land department; fee revenue; trust management
8 fund deposit

9 Notwithstanding section 37-107, Arizona Revised Statutes, the sum of
10 \$600,000 in fee revenue collected pursuant to section 37-108, Arizona Revised
11 Statutes, shall be deposited in the trust land management fund established by
12 section 37-527, Arizona Revised Statutes, in fiscal year 2009-2010.

13 Sec. 5. Conditional enactment

14 This act does not become effective unless Senate Bill 1258, forty-ninth
15 legislature, first regular session, relating to environment budget
16 reconciliation, becomes law."
