AN ACT

AMENDING LAWS 2008, CHAPTER 285, SECTION 24; AMENDING LAWS 2008, CHAPTER 288, SECTION 13, AS AMENDED BY LAWS 2009, FIRST SPECIAL SESSION, CHAPTER 4, SECTION 7; AMENDING LAWS 2009, FIRST SPECIAL SESSION, CHAPTER 1, SECTIONS 4, 5 AND 7; REPEALING LAWS 2009, FIRST SPECIAL SESSION, CHAPTER 4, SECTION 10; MAKING APPROPRIATIONS, TRANSFERS AND BUDGET REDUCTIONS FOR FISCAL YEARS 2008-2009.

1 Be it enacted by the Legislature of the State of Arizona:

1 B. Agencies listed shall reduce expenditures from the listed funds
2 accordingly in order to ensure a sufficient fund balance for these fund
3 transfers.

4 C. The fund transfers in this section shall be made as soon as is
5 practicable to avoid a shortfall in each fund. On or before September 1,
6 2008, the governor's office of strategic planning and budgeting shall report
7 to the joint legislative budget committee on any fund transfers that have not
8 been fully made as of August 15, 2008. For each fund transfer not fully made
9 as of September 1, 2008, the report shall list when the fund transfer will be
10 completed or additional steps required, in addition to those authorized under
11 subsection D, to make the full fund transfer.

12 D. Notwithstanding any other law, to provide for effective continuity
13 of state operations a budget unit may request a temporary cash transfer from
14 one of its own funds to another of its own funds from the state comptroller
15 to accommodate a temporary cash flow issue. The state comptroller shall
16 coordinate all activity with the governor's office of strategic planning and
17 budgeting and shall notify the joint legislative budget committee staff of
18 any cash transfers pursuant to this section. This notice shall include a
19 monthly cash flow of all funds involved and shall include a plan for
20 returning the monies to their original fund. All monies temporarily used
21 shall be returned to the original fund no later than June 30, 2009. The
22 state comptroller shall file a final report on all activity under this
23 provision with the joint legislative budget committee staff and the
24 governor's office of strategic planning and budgeting no later than
25 August 1, 2009.

37 conditions. The administration shall assist the district in determining the

41 special health care district, ~~the administration shall deposit the monies in~~
42 ~~the state general fund.~~ IF THE CERTIFICATION IS EQUAL TO OR GREATER THAN
43 \$89,877,700, THE ADMINISTRATION SHALL DISTRIBUTE \$4,202,300 TO THE MARICOPA
44 COUNTY SPECIAL HEALTH CARE DISTRICT AND DEPOSIT THE BALANCE OF THE FEDERAL
45 FUNDS PARTICIPATION IN THE STATE GENERAL FUND. IF THE CERTIFICATION PROVIDED
