SENATE AMENDMENTS TO H.B. 2001  
(Reference to House engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 15, chapter 14, Arizona Revised Statutes, is amended  
3 by adding article 10, to read:

4 ARTICLE 10. CARRYING OF CONCEALED FIREARMS

5 15-1892. Carrying of concealed firearms by faculty members:  
6 definition

7 A. NOTWITHSTANDING ANY OTHER LAW, A FACULTY MEMBER MAY POSSESS A  
8 CONCEALED FIREARM ON THE GROUNDS OF A COMMUNITY COLLEGE UNDER THE  
9 JURISDICTION OF A COMMUNITY COLLEGE DISTRICT, A PROVISIONAL COMMUNITY COLLEGE  
10 UNDER THE JURISDICTION OF A PROVISIONAL COMMUNITY COLLEGE DISTRICT OR A  
11 UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF REGENTS IF THE  
12 FACULTY MEMBER POSSESSES A VALID PERMIT ISSUED PURSUANT TO SECTION 13-3112.

13 B. FOR THE PURPOSES OF THIS SECTION, "FACULTY MEMBER" MEANS A PERSON  
14 WHO IS EMPLOYED BY A COMMUNITY COLLEGE UNDER THE JURISDICTION OF A COMMUNITY  
15 COLLEGE DISTRICT, A PROVISIONAL COMMUNITY COLLEGE UNDER THE JURISDICTION OF A  
16 PROVISIONAL COMMUNITY COLLEGE DISTRICT OR A UNIVERSITY UNDER THE JURISDICTION  
17 OF THE ARIZONA BOARD OF REGENTS TO CONDUCT CLASSROOM OR TEACHING ACTIVITIES  
18 AND WHOSE TITLE INCLUDES PROFESSOR, ASSOCIATE PROFESSOR, ASSISTANT PROFESSOR,  
19 INSTRUCTOR OR LECTURER. FACULTY MEMBER DOES NOT INCLUDE ANY PERSON WHO IS IN  
20 A POSITION THAT IS DESIGNATED AS A VISITING, ADJUNCT, RESEARCH, CLINICAL,  
21 TEACHING ASSISTANT OR ASSOCIATE OR RESEARCH ASSISTANT OR ASSOCIATE POSITION."
