HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2136

(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 41, chapter 6, article 1, Arizona Revised Statutes,
3 is amended by adding section 41-1008.01, to read:

4 41-1008.01. State agency fee commission; membership; duties;
5 report

6 A. THE STATE AGENCY FEE COMMISSION IS ESTABLISHED CONSISTING OF THE
7 FOLLOWING MEMBERS:

8 1. SIX MEMBERS WHO ARE APPOINTED BY THE GOVERNOR AND WHO ARE PRIVATE
9 SECTOR PROFESSIONALS OR STATE AGENCY EXECUTIVES.

10 2. THREE MEMBERS WHO ARE APPOINTED BY THE PRESIDENT OF THE SENATE, NOT
11 MORE THAN TWO OF WHOM ARE MEMBERS OF THE SAME POLITICAL PARTY.

12 3. THREE MEMBERS WHO ARE APPOINTED BY THE SPEAKER OF THE HOUSE OF
13 REPRESENTATIVES, NOT MORE THAN TWO OF WHOM ARE MEMBERS OF THE SAME POLITICAL
14 PARTY.

15 4. THE DIRECTOR OF THE GOVERNOR'S OFFICE OF STRATEGIC POLICY AND
16 BUDGETING.

17 B. THE GOVERNOR SHALL APPOINT ONE MEMBER OF THE COMMISSION AS
18 CHAIRPERSON OF THE COMMISSION. COMMISSION MEMBERS SERVE AT THE PLEASURE OF
19 THAT PERSON'S APPOINTING OFFICER AND ARE NOT ELIGIBLE TO RECEIVE COMPENSATION
20 OR REIMBURSEMENT OF EXPENSES.

21 C. THE COMMISSION SHALL:

22 1. REVIEW ALL STATE AGENCIES AT LEAST ONCE IN EACH FIVE-YEAR PERIOD,
23 BEGINNING OCTOBER 1, 2011.

24 2. ESTABLISH A FEE REVIEW PROCESS FOR STATE AGENCIES.

25 3. ISSUE AN ANNUAL, COMPREHENSIVE REPORT THAT INCLUDES ALL OF THE
26 FOLLOWING:

27 (a) AN ANALYSIS OF THE FEES ASSESSED BY EACH OF THE REVIEWED AGENCIES.
28 THE ANALYSIS SHALL INCLUDE A COMPARISON OF THIS STATE'S AGENCIES WITH OTHER,

1 SIMILAR AGENCIES IN OTHER SOUTHWESTERN STATES AS WELL AS A COMPARISON WITH
2 NATIONWIDE TRENDS.

3 (b) AN ANALYSIS OF THE METHODS USED BY AGENCIES TO SET FEES.

4 (c) AN ANALYSIS OF THE EFFECTS THAT FEES CURRENTLY HAVE ON REGULATED
5 INDUSTRIES, BUSINESSES OR CONSUMER GROUPS FOR EACH AGENCY.

6 (d) A LIST OF AGENCIES TO BE REVIEWED IN THE FOLLOWING YEAR.

7 D. AT ITS FIRST MEETING, THE COMMISSION SHALL ADOPT BYLAWS TO GOVERN
8 ISSUES RELATED TO THE CONDUCT OF THE COMMISSION BUSINESS AND POTENTIAL
9 CONFLICTS OF INTEREST.

10 E. AGENCIES SELECTED FOR REVIEW BY THE COMMISSION SHALL COOPERATE WITH
11 THE COMMISSION AND SHALL PROVIDE INFORMATION AS REQUESTED BY THE COMMISSION.

12 F. THE COMMISSION MAY USE THE SERVICES OF THE STAFF OF THE GOVERNOR'S
13 OFFICE OF STRATEGIC PLANNING AND BUDGETING AS REQUIRED.

14 G. ON OR BEFORE OCTOBER 1, 2012, THE COMMISSION SHALL SUBMIT ITS FIRST
15 ANNUAL REPORT TO THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, THE PRESIDENT
16 OF THE SENATE AND THE GOVERNOR. THE COMMISSION SHALL PROVIDE A COPY OF THE
17 REPORT TO THE SECRETARY OF STATE.

18 Sec. 2. Delayed repeal

19 Section 41-1008.01, Arizona Revised Statutes, as added by this act, is
20 repealed from and after September 30, 2021."
