"Section 1. Section 15-1466, Arizona Revised Statutes, is amended to read:

15-1466. State aid; eligibility; limitations

A. Subject to legislative appropriation, the legislature shall determine and appropriate the amount of state aid each fiscal year to each district ~~possessing the qualifications as prescribed in this chapter~~ EQUAL TO A VOUCHER AMOUNT OF _____ PER FULL-TIME EQUIVALENT STUDENT. EACH STUDENT WHO IS ACCEPTED FOR ADMISSION IS ENTITLED TO A VOUCHER IN THE AMOUNT OF _____ TO BE USED FOR A PORTION OF THE PAYMENT OF TUITION AND FEES AT THAT COMMUNITY COLLEGE DISTRICT.

~~B. The state shall determine the amount of state aid, as prescribed in subsection D of this section, appropriated to each district for the fiscal year prior to the fiscal year for which the state aid is being calculated.~~

~~C. Each district qualified under this chapter shall have its state aid adjusted in an amount that reflects the growth or decrease in the full time equivalent student count of the district calculated as follows:~~

~~1. Calculate the growth or decrease in the actual, audited full time equivalent student count between the second and third most recent fiscal years prior to the fiscal year for which the state aid is being calculated for each district.~~

~~2. Calculate the average appropriation per full time equivalent student for all districts by dividing the amount determined in subsection B of this section by the actual, audited full time equivalent student count for all districts in the most recent fiscal year.~~

~~3. Multiply the amount calculated in paragraph 1 of this subsection by the average appropriation calculated in paragraph 2 of this subsection. This amount equals the adjustment required pursuant to this section.~~

~~D. The total amount appropriated to each district each fiscal year in accordance with this section shall serve as the amount of state aid to be adjusted in the next fiscal year. A district is eligible for growth funding pursuant to this section only for the portion of its most recent audited full-time student equivalent count that exceeds the audited full-time student equivalent count recorded for the district for the most recent fiscal year in which an adjustment was previously made pursuant to subsection C of this section.~~

~~E.~~ B. To be eligible for state aid, a district shall:

1. Be equipped with suitable buildings, equipment and campus.
2. Have at least three hundred twenty full-time equivalent students attending in the district.
3. Have complied with all of the requirements of the district board, including budgets and curriculum.

~~F.~~ C. The total amount of state monies that may be spent in any fiscal year by a district for operating state aid shall not exceed the amount appropriated or authorized by section 35-173 for that purpose. Notwithstanding section 15-1444, this section shall not be construed to impose a duty on an officer, agent or employee of this state to discharge a responsibility or to create any right in a person or group if the discharge or right would require an expenditure of state monies in excess of the expenditure authorized by legislative appropriation for that specific purpose, including any duties prescribed in an employment contract entered into pursuant to section 15-1444, subsection A, paragraph 6.

~~G. In addition to the formula to determine the state aid appropriations prescribed in this section, the state may pay additional amounts for state aid to a district based on requests included in the district's budget request.~~

1 ~~H.~~ D. This section does not entitle a community college operated by a
2 qualified Indian tribe to state aid for community colleges pursuant to this
3 chapter.

5 15-1601. State universities; location; faculty powers

6 A. ~~The Arizona board of regents shall maintain~~ State universities
7 **SHALL BE MAINTAINED** at Flagstaff in Coconino county, at Tempe in Maricopa
8 county, **AT MESA IN MARICOPA COUNTY** and at Tucson in Pima county, and the
9 universities are respectively designated northern Arizona university, Arizona
10 state university, **ARIZONA POLYTECHNIC UNIVERSITY** and the university of
11 Arizona. ~~The board shall maintain~~ An Arizona state university campus **SHALL BE**
12 **MAINTAINED** in western Maricopa county **AND** designated as Arizona state
13 university west campus, which shall be identified as a separate budget unit
14 in the general appropriations act. ~~The board shall maintain an Arizona state~~
15 ~~university campus in eastern Maricopa county designated as Arizona state~~

22 campus at Tempe shall provide administrative support for the Arizona state

25 B. The universities shall have colleges, schools and departments and
26 give courses of study and academic degrees as the board **OF TRUSTEES FOR THAT**
27 **UNIVERSITY** approves. Subject to the responsibilities and powers of the board
28 **OF TRUSTEES** and the university presidents, the faculty members of the
29 universities, through their elected faculty representatives, shall share
30 responsibility for academic and educational activities and matters related to
31 faculty personnel. The faculty members of each university, through their
32 elected faculty representatives, shall participate in the governance of their

2 university policy.

8 15-1621. Universities; boards of trustees; members; terms;
9 immunity

10 A. A SEPARATE BOARD OF TRUSTEES SHALL GOVERN EACH INDIVIDUAL PUBLIC
11 UNIVERSITY IN THIS STATE. THE PRESIDENT OF THE UNIVERSITY SHALL SERVE AS AN
12 EX OFFICIO MEMBER OF THE BOARD OF TRUSTEES FOR THAT UNIVERSITY. THE
13 PRESIDENT SHALL BE EXCLUDED FROM ANY DISCUSSION OR VOTING BY THE BOARD OF
14 TRUSTEES CONCERNING THE PRESIDENT'S SALARY AND OTHER FORMS OF COMPENSATION.
15 THE GOVERNOR SHALL SERVE AS AN EX OFFICIO MEMBER OF EACH BOARD OF TRUSTEES.
16 IF THE VOTERS FAIL TO APPROVE A CONSTITUTIONAL AMENDMENT TO ELIMINATE
17 REFERENCES TO THE ARIZONA BOARD OF REGENTS IN ARTICLE XI, SECTION 5,
18 CONSTITUTION OF ARIZONA, THE ARIZONA BOARD OF REGENTS SHALL APPOINT A MEMBER
19 OF THE ARIZONA BOARD OF REGENTS TO SERVE AS A MEMBER OF THE BOARD OF TRUSTEES
20 OF EACH UNIVERSITY.

21 B. APPOINTED MEMBERS OF EACH BOARD OF TRUSTEES SHALL BE APPOINTED BY

25 OATH OF OFFICE BEFORE ENTERING ON THE DUTIES OF THE MEMBER'S OFFICE.

26 D. MEMBERS OF EACH BOARD OF TRUSTEES ARE IMMUNE FROM PERSONAL
27 LIABILITY WITH RESPECT TO ALL ACTS DONE AND ACTIONS TAKEN IN GOOD FAITH
28 WITHIN THE SCOPE OF THEIR AUTHORITY DURING DULY CONSTITUTED REGULAR AND
29 SPECIAL MEETINGS WITH APPROVAL OF A MAJORITY OF THE BOARD OF TRUSTEES.

2 A. EACH UNIVERSITY BOARD OF TRUSTEES SHALL:

3 1. HAVE AND EXERCISE THE POWERS NECESSARY FOR THE EFFECTIVE GOVERNANCE
4 AND ADMINISTRATION OF THE UNIVERSITY UNDER ITS CONTROL.

5 2. APPOINT AND EMPLOY AND DETERMINE THE COMPENSATION OF A PRESIDENT
6 WITH SUCH POWER AND AUTHORITY AND FOR SUCH PURPOSES IN CONNECTION WITH THE
7 OPERATION OF THE UNIVERSITY AS THE BOARD DEEMS NECESSARY.

8 3. APPOINT AND EMPLOY AND DETERMINE THE COMPENSATION OF VICE
9 PRESIDENTS, DEANS, PROFESSORS, INSTRUCTORS, LECTURERS, FELLOWS AND SUCH OTHER
10 OFFICERS AND EMPLOYEES WITH SUCH POWER AND AUTHORITY AND FOR SUCH PURPOSES IN
11 CONNECTION WITH THE OPERATION OF THE UNIVERSITY AS THE BOARD DEEMS NECESSARY.

12 4. REMOVE ANY OFFICER OR EMPLOYEE OF THE UNIVERSITY WHEN THE INTERESTS
13 OF EDUCATION IN THIS STATE SO REQUIRE IN ACCORDANCE WITH THE BOARD'S
14 PERSONNEL RULES AND POLICIES.

15 5. FIX TUITIONS AND FEES TO BE CHARGED AND DIFFERENTIATE THE TUITIONS
16 AND FEES BETWEEN RESIDENTS, NONRESIDENTS, UNDERGRADUATE STUDENTS, GRADUATE
17 STUDENTS AND STUDENTS FROM FOREIGN COUNTRIES.

18 6. PURSUANT TO SECTION 35-115, SUBMIT A BUDGET REQUEST FOR THE
19 UNIVERSITY THAT INCLUDES THE ESTIMATED TUITION AND FEE REVENUE AVAILABLE TO
20 SUPPORT THE PROGRAMS OF THE UNIVERSITY AS DESCRIBED IN THE BUDGET REQUEST.
21 THE ESTIMATED AVAILABLE TUITION AND FEE REVENUE SHALL BE BASED ON THE TUITION
22 AND REGISTRATION FEE RATES IN EFFECT AT THE TIME THE BUDGET REQUEST IS
23 SUBMITTED WITH ADJUSTMENTS FOR PROJECTED CHANGES IN ENROLLMENT AS PROVIDED BY
24 THE BOARD OF TRUSTEES.

25 7. ESTABLISH CURRICULA AND DESIGNATE COURSES AT THE UNIVERSITY THAT IN
26 THE BOARD'S JUDGMENT WILL BEST SERVE THE INTERESTS OF THIS STATE.

27 8. AWARD SUCH DEGREES AND DIPLOMAS ON THE COMPLETION OF SUCH COURSES
28 AND CURRICULUM REQUIREMENTS AS THE BOARD DEEMS APPROPRIATE.

29 9. PRESCRIBE QUALIFICATIONS FOR ADMISSION OF ALL STUDENTS TO THE
30 UNIVERSITY.

1 10. ADOPT ANY ENERGY CONSERVATION STANDARDS ADOPTED BY THE DEPARTMENT
2 OF ADMINISTRATION FOR THE CONSTRUCTION OF NEW BUILDINGS.

3 11. EMPLOY ATTORNEYS FOR SUCH TIME AND PURPOSES AS THE BOARD REQUIRES
4 AND FIX AND PAY THEIR COMPENSATION.

5 12. ADOPT ANNUALLY AN OPERATING BUDGET FOR THE UNIVERSITY EQUAL TO THE
6 SUM OF APPROPRIATED GENERAL FUND MONIES AND THE AMOUNT OF TUITION,
7 REGISTRATION FEES AND OTHER REVENUES APPROVED BY THE BOARD AND ALLOCATED TO
8 THE UNIVERSITY OPERATING BUDGET.

9 13. IN CONSULTATION WITH THE STATE BOARD OF EDUCATION AND OTHER
10 EDUCATION GROUPS, DEVELOP AND IMPLEMENT A PROCESS TO AWARD HONORS
11 ENDORSEMENTS TO BE AFFIXED TO THE HIGH SCHOOL DIPLOMAS OF QUALIFYING HIGH
12 SCHOOL PUPILS AND TO BE INCLUDED IN THE TRANSCRIPTS OF PUPILS WHO ARE AWARDED
13 ENDORSEMENTS. THE BOARD OF TRUSTEES SHALL DEVELOP APPLICATION PROCEDURES AND
14 TESTING CRITERIA AND ADOPT TESTING INSTRUMENTS AND PROCEDURES TO ADMINISTER
15 HONORS ENDORSEMENT. IN ORDER TO RECEIVE AN HONORS ENDORSEMENT, A PUPIL MUST
16 DEMONSTRATE AN EXTRAORDINARY LEVEL OF KNOWLEDGE, SKILL AND COMPETENCY AS
17 MEASURED BY THE TESTING INSTRUMENTS ADOPTED BY THE BOARD OF TRUSTEES IN
18 MATHEMATICS, ENGLISH, SCIENCE AND SOCIAL STUDIES. ADDITIONAL SUBJECTS MAY BE
19 ADDED AT THE DETERMINATION OF THE BOARD OF TRUSTEES. THE HONORS ENDORSEMENT
20 PROCESS IS VOLUNTARY FOR PUPILS.

21 14. REQUIRE THE PUBLISHER OF EACH LITERARY AND NONLITERARY TEXTBOOK
22 USED IN THE UNIVERSITY TO FURNISH COMPUTER SOFTWARE IN A STANDARDIZED FORMAT
23 WHEN SOFTWARE BECOMES AVAILABLE FROM WHICH BRAILLE VERSIONS OF THE TEXTBOOKS
24 MAY BE PRODUCED.

25 15. IF THE UNIVERSITY PROVIDES A DEGREE IN EDUCATION, REQUIRE COURSES
26 THAT ARE NECESSARY TO OBTAIN A PROVISIONAL STRUCTURED ENGLISH IMMERSION
27 ENDORSEMENT AS PRESCRIBED BY THE STATE BOARD OF EDUCATION.

28 16. FOR EACH CLASSROOM ACQUIRE UNITED STATES FLAGS THAT ARE
29 MANUFACTURED IN THE UNITED STATES AND THAT ARE AT LEAST TWO FEET BY THREE
30 FEET AND HARDWARE TO APPROPRIATELY DISPLAY THE FLAGS, ACQUIRE A LEGIBLE COPY
31 OF THE UNITED STATES CONSTITUTION AND THE BILL OF RIGHTS, DISPLAY THE FLAGS
32 IN EACH CLASSROOM IN ACCORDANCE WITH TITLE 4 OF THE UNITED STATES CODE AND

1 DISPLAY A LEGIBLE COPY OF THE UNITED STATES CONSTITUTION AND THE BILL OF
2 RIGHTS ADJACENT TO THE FLAG.

3 17. TO FACILITATE THE TRANSFER OF MILITARY PERSONNEL AND THEIR
4 DEPENDENTS TO AND FROM THE PUBLIC SCHOOLS OF THIS STATE, PURSUE, IN
5 COOPERATION WITH THE STATE BOARD OF EDUCATION, RECIPROCITY AGREEMENTS WITH
6 OTHER STATES CONCERNING THE TRANSFER OF CREDITS FOR MILITARY PERSONNEL AND
7 THEIR DEPENDENTS.

8 18. REQUIRE THE UNIVERSITY TO POST PUBLIC NOTICES OF ALL OF ITS
9 EMPLOYMENT OPENINGS, INCLUDING THE TITLE AND DESCRIPTION, INSTRUCTIONS FOR
10 APPLYING AND RELEVANT CONTACT INFORMATION.

11 19. IN CONSULTATION WITH THE COMMUNITY COLLEGE DISTRICTS IN THIS STATE,
12 DEVELOP AND IMPLEMENT COMMON EQUIVALENCIES FOR SPECIFIC LEVELS OF ACHIEVEMENT
13 ON ADVANCED PLACEMENT EXAMINATIONS AND INTERNATIONAL BACCALAUREATE
14 EXAMINATIONS IN ORDER TO AWARD COMMENSURATE POSTSECONDARY ACADEMIC CREDITS AT
15 COMMUNITY COLLEGES AND THE UNIVERSITY.

16 B. EACH UNIVERSITY BOARD OF TRUSTEES SHALL ADOPT PERSONNEL RULES. ALL
17 NONACADEMIC EMPLOYEES OF THE UNIVERSITY ARE SUBJECT TO THESE RULES EXCEPT FOR
18 UNIVERSITY PRESIDENTS, UNIVERSITY VICE PRESIDENTS, UNIVERSITY DEANS, LEGAL
19 COUNSEL AND ADMINISTRATIVE OFFICERS. THE PERSONNEL RULES SHALL BE SIMILAR TO
20 THE PERSONNEL RULES UNDER SECTION 41-783. THE RULES SHALL INCLUDE PROVISIONS
21 FOR LISTING AVAILABLE POSITIONS WITH THE DEPARTMENT OF ECONOMIC SECURITY,
22 COMPETITIVE EMPLOYMENT PROCESSES FOR APPLICANTS, PROBATIONARY STATUS FOR NEW
23 NONACADEMIC EMPLOYEES, NONPROBATIONARY STATUS ON SUCCESSFUL COMPLETION OF
24 PROBATION AND DUE PROCESS PROTECTIONS OF NONPROBATIONARY EMPLOYEES AFTER
25 DISCHARGE. THE BOARD SHALL PROVIDE NOTICE OF PROPOSED RULE ADOPTION AND AN
26 OPPORTUNITY FOR PUBLIC COMMENT ON ALL PERSONNEL RULES PROPOSED FOR ADOPTION.

27 C. IN CONJUNCTION WITH THE AUDITOR GENERAL, EACH UNIVERSITY BOARD OF
28 TRUSTEES SHALL DEVELOP A UNIFORM ACCOUNTING AND REPORTING SYSTEM, WHICH SHALL
29 BE REVIEWED BY THE JOINT LEGISLATIVE BUDGET COMMITTEE BEFORE FINAL ADOPTION
30 BY THE BOARD. THE BOARD SHALL REQUIRE THE UNIVERSITY TO COMPLY WITH THE
31 UNIFORM ACCOUNTING AND REPORTING SYSTEM.

1 D. EACH UNIVERSITY BOARD OF TRUSTEES MAY EMPLOY LEGAL ASSISTANCE IN
2 PROCURING LOANS FOR THE UNIVERSITY FROM THE UNITED STATES GOVERNMENT. FEES
3 OR COMPENSATION PAID FOR SUCH LEGAL ASSISTANCE SHALL NOT BE A CLAIM ON THE
4 GENERAL FUND OF THIS STATE BUT SHALL BE PAID FROM MONIES OF THE UNIVERSITY.

5 E. THE BOARD OF TRUSTEES FOR THE UNIVERSITY OF ARIZONA SHALL APPROVE
6 OR DISAPPROVE ANY CONTRACT OR AGREEMENT ENTERED INTO BY THE UNIVERSITY OF
7 ARIZONA HOSPITAL WITH THE ARIZONA HEALTH FACILITIES AUTHORITY.

8 F. EACH UNIVERSITY BOARD OF TRUSTEES MAY ADOPT POLICIES THAT AUTHORIZE
9 THE UNIVERSITY TO ENTER INTO EMPLOYMENT CONTRACTS WITH NONTENURED EMPLOYEES
10 FOR PERIODS OF MORE THAN ONE YEAR BUT NOT MORE THAN FIVE YEARS. THE POLICIES
11 SHALL PRESCRIBE LIMITATIONS ON THE AUTHORITY OF THE UNIVERSITY TO ENTER INTO
12 EMPLOYMENT CONTRACTS FOR PERIODS OF MORE THAN ONE YEAR BUT NOT MORE THAN FIVE
13 YEARS, INCLUDING THE REQUIREMENT THAT THE BOARD OF TRUSTEES APPROVE THE
14 CONTRACTS.

15 G. EACH UNIVERSITY BOARD OF TRUSTEES MAY ADOPT A PLAN OR PLANS FOR
16 EMPLOYEE BENEFITS THAT ALLOW FOR PARTICIPATION IN A CAFETERIA PLAN THAT MEETS
17 THE REQUIREMENTS OF THE UNITED STATES INTERNAL REVENUE CODE OF 1986.

18 H. EACH UNIVERSITY BOARD OF TRUSTEES MAY ESTABLISH A PROGRAM FOR THE
19 EXCHANGE OF STUDENTS BETWEEN THE UNIVERSITY AND COLLEGES AND UNIVERSITIES
20 LOCATED IN THE STATE OF SONORA, MEXICO. THE PROGRAM MAY PROVIDE FOR IN-STATE
21 TUITION AT THE UNIVERSITY FOR FIFTY SONORAN STUDENTS IN EXCHANGE FOR SIMILAR
22 TUITION PROVISIONS FOR UP TO FIFTY ARIZONA STUDENTS ENROLLED OR SEEKING
23 ENROLLMENT IN SONORAN COLLEGES OR UNIVERSITIES. THE BOARD MAY DIRECT THE
24 UNIVERSITY TO WORK IN CONJUNCTION WITH THE ARIZONA-MEXICO COMMISSION TO
25 COORDINATE RECRUITMENT AND ADMISSIONS ACTIVITIES.

26 Sec. 5. Section 15-1661, Arizona Revised Statutes, is amended to read:

27 15-1661. Annual appropriation; enrollment audit; expenditure;
28 balance; salaries

29 A. There shall be appropriated in the general appropriation bill for
30 each fiscal year a sum of monies ~~not less than eighty five one hundredths of~~
31 ~~one mill on the dollar of the assessed valuation of all taxable property in~~
32 ~~the state for the improvement, support and maintenance of the institutions~~

~~under the Arizona board of regents' jurisdiction, including payment of salaries, current expenses, purchase of equipment, making necessary repairs, construction of new buildings, purchase of lands and in general for payment of all such expenses connected with the management of the institutions under the Arizona board of regents' jurisdiction. The department of revenue, upon compiling the aggregate assessed valuation of all taxable property within this state, shall compute the amount of monies so determined and certify such amount over its seal to the department of administration and the state treasurer~~ FOR THE PUBLIC UNIVERSITIES IN THIS STATE EQUAL TO A VOUCHER AMOUNT OF _____ PER FULL-TIME EQUIVALENT STUDENT. EACH STUDENT WHO IS ACCEPTED FOR ADMISSION IS ENTITLED TO A VOUCHER IN THE AMOUNT OF _____ TO BE USED FOR A PORTION OF THE PAYMENT OF TUITION AND FEES AT THAT UNIVERSITY.

B. The full-time equivalent student enrollment reported for the previous fiscal year by each university shall be audited annually by the auditor general. The auditor general shall report the results of the audit to the staffs of the joint legislative budget committee and the governor's office of strategic planning and budgeting on or before October 15 of each year. On or before July 21 of each academic year, each university shall provide for the previous fall semester a certified report to the auditor general of the number of full-time equivalent students calculated by the university and a separate report only for those students who meet the residency requirements prescribed in section 15-1802. The university's records used to calculate full-time equivalent student enrollment shall be provided to the auditor general in an electronic format prescribed by the auditor general. ~~Beginning in 2006,~~ Each university shall submit to the auditor general a summary of its full-time equivalent student enrollment accounting policies and procedures, compilation procedures and source records used for calculating full-time equivalent student enrollment. These accounting policies and procedures, compilation procedures and source records shall comply with policies developed ~~on or before June 30, 2006~~ by the ~~Arizona board of regents~~ BOARD OF TRUSTEES FOR THAT UNIVERSITY, in

1 consultation with the auditor general and reviewed by the joint legislative
2 budget committee. These policies shall include a review and recommendations
3 of the necessity of minimum requirements for students enrolled in classes to
4 qualify for appropriations pursuant to this section, including requirements
5 that the class be a for-credit course that is necessary for the completion of
6 a degree and that the student enrolled in the course be physically present in
7 this state at the time the course is conducted. The basic actual full-time
8 equivalent student enrollment shall be counted on the forty-fifth day after
9 the basic actual full-time equivalent student enrollment classes begin for
10 the fall and spring semesters, as published in the university catalogs, and
11 divided by two. The ~~Arizona board of regents~~ BOARD OF TRUSTEES FOR THAT
12 UNIVERSITY shall also make recommendations of whether each professor or
13 instructor should be required to review class rosters and make additions or
14 deletions as necessary. If so, class rosters that reflect enrollment as of
15 the forty-fifth day shall be provided by the registrar's office to each
16 professor or instructor for every class section. The class roster shall
17 indicate the course number, course title, time, instructor name and students
18 enrolled. On the forty-fifth day class rosters, each professor or instructor
