SENATE AMENDMENTS TO H.B. 2412
(Reference to House engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 39-203, Arizona Revised Statutes, is amended to
3 read:

4 39-203. Number of publications for compliance with requirement
5 of notice for specified time

6 A. When notice is provided by law to be given for a specified number
7 of days or weeks, if by publication in a daily paper, it shall be published
8 four days of the seven in the week, and if by publication in a weekly paper,
9 it shall be published one day in each week.

10 B. One insertion each week in papers published weekly, and four
11 insertions each week in papers published daily, shall constitute seven days'
12 notice.

13 C. THE PERSON RESPONSIBLE FOR PROVIDING THE NOTICE PURSUANT TO
14 SUBSECTION A OF THIS SECTION SHALL CAUSE THE NOTICE TO BE PUBLISHED IN THE
15 MOST APPROPRIATE NEWSPAPER THAT INFORMS THE TARGETED POPULATION AND THAT
16 WOULD NOTIFY THE MOST PEOPLE.

17 Sec. 2. Title 39, chapter 2, Arizona Revised Statutes, is amended by
18 adding article 3, to read:

19 ARTICLE 3. NOTICES THROUGH THE WORLDWIDE WEB

20 39-231. Database for public notices

21 A. THE DEPARTMENT OF ADMINISTRATION SHALL ESTABLISH AND MAINTAIN AN
22 ELECTRONIC DATABASE FOR PUBLIC NOTICES THAT ARE REQUIRED BY LAW TO BE
23 PUBLISHED. AFTER A NEWSPAPER INITIALLY PUBLISHES A NOTICE AS REQUIRED BY
24 LAW, THE NEWSPAPER SHALL FORWARD AN ELECTRONIC VERSION OF THAT NOTICE TO THE
25 DEPARTMENT OF ADMINISTRATION FOR STORAGE AND DISSEMINATION AS PROVIDED BY
26 THIS SECTION.

1 B. ANY PERSON OPERATING A DESIGNATED SITE ON A WORLDWIDE PUBLIC
2 NETWORK OF INTERCONNECTED COMPUTERS MAY ACCESS THE DATABASE MAINTAINED BY THE
3 DEPARTMENT AND MAY POST THE NOTICES ON THEIR NETWORK AT NO CHARGE."
