HOUSE BILL 2262

AN ACT

AMENDING SECTION 32-506, ARIZONA REVISED STATUTES; RELATING TO COSMETOLOGY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 32-506, Arizona Revised Statutes, is amended to
3 read:

4 32-506. Nonapplicability of chapter

5 This chapter does not apply to the following persons while in the
6 proper discharge of their professional duties:

7 1. Practices done for the treatment of physical or mental ailments or
8 disease by medical practitioners licensed pursuant to this title.

9 2. Commissioned physicians and surgeons serving in the armed forces of
10 the United States or other federal agencies.

11 3. Persons licensed pursuant to chapter 3 or 12 of this title.

12 4. Students attending schools licensed pursuant to this chapter while
13 they are on school premises during school hours.

14 5. Persons employed by theatrical groups who apply makeup, oils and
15 cosmetics.

16 6. Persons who sell makeup, oils and cosmetics and who apply such
17 products during the process of selling such products.

18 7. Shampoo assistants who shampoo hair under the direction of a
19 cosmetologist licensed pursuant to this chapter.

20 8. Services performed by and for persons in the custody of the state
21 department of corrections.

22 9. Persons who apply makeup, oils and cosmetics to patients in a
23 hospital, nursing home or ~~supervisory care home~~ RESIDENTIAL CARE INSTITUTION
24 with the consent of the patient and the hospital, nursing home or ~~supervisory~~
25 ~~care home~~ RESIDENTIAL CARE INSTITUTION.

26 10. Persons who provide a service that results in tension on hair
27 strands or roots by twisting, wrapping, weaving, extending, locking or
28 braiding, if the service does not include the application of dyes, reactive
29 chemicals or other preparations to alter the color of the hair or to
30 straighten, curl or alter the structure of the hair.

31 11. PERSONS WHO PROVIDE A SERVICE THAT RESULTS IN THE REMOVAL OF HAIR
32 FROM ITS FOLLICLE FROM AROUND THE EYEBROWS AND FROM OTHER PARTS OF THE FACE
33 WITH THE USE OF A SINGLE STRAND OF COTTON THREAD AND AN OVER-THE-COUNTER
34 ASTRINGENT, IF THE SERVICE DOES NOT USE CHEMICALS OF ANY KIND, WAX, OR ANY
35 IMPLEMENTS, INSTRUMENTS OR TOOLS TO REMOVE HAIR.
