AN ACT

MAKING CAPITAL OUTLAY APPROPRIATIONS FOR THE DIFFERENT DEPARTMENTS OF THE
STATE AND FOR STATE INSTITUTIONS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Capital outlay appropriations; major maintenance and
 3 repair of state buildings

4 A. Notwithstanding section 41-793.01, Arizona Revised Statutes, the
 5 amounts appropriated in this section are appropriated for fiscal year
 6 2012-2013 and shall be used by the applicable agency for major maintenance
 7 and repair activities for state buildings in accordance with title 41,
 8 chapter 4, article 7, Arizona Revised Statutes. Of the amounts appropriated
 9 to the department of administration, up to \$275,000 in personal services and
 10 employee-related expenditures for up to five FTE positions may be allocated
 11 each fiscal year until the building renewal projects are completed. All
 12 other monies appropriated in this section shall not be spent for personal
 13 services or employee-related expenditures or for maintenance contracts on
 14 building components and equipment without review by the joint committee on
 15 capital review. Any monies appropriated for building renewal in fiscal year
 16 2012-2013 that are unexpended or unencumbered on June 30, 2014 shall revert
 17 to the fund from which the monies were appropriated.

18 B. DEPARTMENT OF ADMINISTRATION \$10,372,600

20 Capital outlay stabilization fund \$10,372,600

21 The department of administration shall allocate \$1,700,000 for the
 22 purchase of a generator at the Arizona state hospital. The department of
 23 administration shall allocate the remaining monies to state agencies for
 24 necessary building renewal. If monies in the capital outlay stabilization
 25 fund are insufficient to fund the appropriation to the department of
 26 administration for building renewal, the appropriation to the department of
 27 administration shall be reduced by the difference between the amount
 28 appropriated to the department of administration from the capital outlay
 29 stabilization fund and the balance in the capital outlay stabilization fund.

34 Department of transportation:

35 1. Statewide highway construction \$270,194,000

36 Fund source:

37 State highway fund \$270,194,000

38 The amount appropriated for highway construction is from the state
39 highway fund for the planning and construction of state highways, including
40 the national system of interstate highways within this state, the state
41 primary or secondary system, the county primary or secondary system and urban
42 rural routes, the acquisition of rights-of-way, the cost of contracted field
43 administration and field engineering on construction projects and debt
44 service payments on bonds issued for highway construction. Any balances and
45 collections in the state highway fund in excess of the specific amounts

1 appropriated in the general appropriations act and in this act are
 2 appropriated to the department for the purposes provided in this paragraph.

3 The department of transportation shall annually report on or before
 4 September 1 to the joint committee on capital review on its actual prior
 5 year, estimated current year and upcoming budget year highway construction
 6 expenses from all fund sources, including appropriated monies, federal
 7 monies, local agency monies, state highway monies, bond proceeds and regional
 8 area road monies. The report shall delineate expenditures by each individual
 9 fund source.

10 2. Airport planning and development \$ 21,924,900

11 Fund source:

12 State aviation fund \$ 21,924,900

13 The amount is appropriated from the state aviation fund for the
 14 planning, construction, development and improvement of state, county, city or
 15 town airports as determined by the state transportation board. Any balances
 16 and collections in the state aviation fund in excess of the specific amounts
 17 appropriated in the general appropriations act and in this act are
 18 appropriated to the department of transportation for the purposes provided in
 19 this paragraph.

24 Sec. 6. Department of administration reports; FTE positions;
 25 reallocations

26 A. The department of administration shall report on the status of
 27 project-specific FTE positions for capital projects in its annual capital
 28 budget request.

29 B. The department of administration may allocate FTE positions
 30 authorized for specific projects to other projects in this act provided that
 31 funding for the FTE positions is cost allocated among the projects receiving
 32 benefit. The department of administration shall report any FTE position
 33 reallocations to the joint committee on capital review by December 31, 2012.

34 Sec. 7. Use of appropriations; limitation

35 Unless otherwise specified, the monies appropriated in this act shall
 36 not be spent for personal services or employee-related expenditures of state
 37 employees, excluding any services provided as part of the inmate construction
 38 program for correctional facilities.

39 Sec. 8. Lapsing; exemption

40 Unless otherwise specified, the appropriations made in this act do not
 41 lapse until the purpose for which the appropriation was made has been
 42 accomplished or abandoned, or the appropriation stands for a full fiscal year
 43 without an expenditure or an encumbrance.

1 Sec. 9. JCCR review

2 Pursuant to section 41-1252, Arizona Revised Statutes, the joint
3 committee on capital review shall review the scope, purpose and estimated
4 cost of a new capital project that has an estimated cost of more than
5 \$250,000.
