

## HOUSE FLOOR AMENDMENT EXPLANATION



Bill Number: **SB 1193**

Boyer Floor Amendment

---

As passed the Committee on Education, SB 1193 requires charter school sponsors to consider progress towards academic performance expectations as one of the most important factors in determining charter renewal and submit an annual report to the Office of the Auditor General (OAG).

The 17-Line Boyer Floor Amendment to the Education Committee Amendment to SB 1193 dated 3/26/15 at 8:15 A.M. makes the following changes:

- Directs OAG to prescribe the format for the required annual report and permits OAG to require the report to be submitted electronically.
- Removes the requirement for OAG to provide the reports with its findings to the Governor, Legislature and Secretary of State.
- Includes the President of the Senate, Speaker of the House and the Chairs of the House and Senate Education Committee's in the entities OAG is required to report noncompliance to.
- Makes technical changes.

2 Page 11, line 33, strike "MAKE" insert "SUBMIT"

3 Strike lines 45 through 48, insert:

4 "II. THE AUDITOR GENERAL SHALL PRESCRIBE THE FORMAT FOR THE ANNUAL  
5 REPORT REQUIRED BY SUBSECTION HH OF THIS SECTION AND MAY REQUIRE THAT THE  
6 ANNUAL REPORT BE SUBMITTED ELECTRONICALLY. THE AUDITOR GENERAL SHALL REVIEW  
7 THE SUBMITTED ANNUAL REPORTS TO ENSURE THAT THE REPORTS INCLUDE THE REQUIRED  
8 ITEMS IN SUBSECTION HH OF THIS SECTION AND SHALL MAKE THE ANNUAL REPORTS

11 "NONCOMPLIANCE OR"

12 Line 2, after "SUBMIT" insert "THE ANNUAL REPORT REQUIRED BY SUBSECTION HH OF  
13 THIS SECTION, ON OR BEFORE DECEMBER 31 OF EACH YEAR THE AUDITOR GENERAL SHALL  
14 REPORT TO THE GOVERNOR, THE PRESIDENT OF THE SENATE, THE SPEAKER OF THE HOUSE  
15 OF REPRESENTATIVES AND THE CHAIRS OF THE SENATE AND HOUSE EDUCATION  
16 COMMITTEES OR THEIR SUCCESSOR COMMITTEES, AND"
