

Thorpe Floor Amendment

The Thorpe floor amendment to the Appropriations Committee amendment: 1) defines *constitutionally nonenumerated federal land*, 2) removes provisions relating to the taxation of the constitutionally nonenumerated federal land, and 3) adds language excluding specific property from the bill provisions.

1 Page 1, line 4, after the semicolon strike remainder of line

2 Strike line 5, insert "applicability: definition"

3 Line 6, after "A." insert "FROM AND AFTER THE EFFECTIVE DATE OF THIS SECTION,";

4 after "SHALL" insert "ANNUALLY"

5 Line 7, after the first "STATE" insert "THROUGH SALE OR"

6 Strike lines 13 through 28, insert:

7 "C. THIS SECTION DOES NOT APPLY TO PROPERTY:

8 1. THAT IS HELD BY THE UNITED STATES FOR THE BENEFIT, INCLUDING WATER
9 RIGHTS, OF A FEDERAL RECLAMATION PROJECT OR MANAGED BY A POLITICAL
10 SUBDIVISION OF THIS STATE OR A SPECIAL TAXING DISTRICT ORGANIZED UNDER
11 TITLE 48.

12 2. ON WHICH PERMANENT IMPROVEMENTS ARE CONSTRUCTED OR THAT IS LEGALLY
13 ENCUMBERED.

14 3. THAT IS ASSOCIATED WITH ELECTRICAL POWER PROJECTS, INCLUDING
15 GENERATION, TRANSMISSION OR DISTRIBUTION.

16 D. FOR THE PURPOSES OF THIS SECTION, "CONSTITUTIONALLY NONENUMERATED
17 FEDERAL LAND" MEANS LAND THAT IS HELD BY THE FEDERAL GOVERNMENT AND THAT DOES
18 NOT SERVE A PURPOSE ENUMERATED IN THE UNITED STATES CONSTITUTION, INCLUDING
19 ARTICLE 1, SECTION 8, PARAGRAPH 17 OF THE UNITED STATES CONSTITUTION, AND:

20 1. INCLUDES:

21 (a) UNITED STATES BUREAU OF LAND MANAGEMENT HOLDINGS.

22 (b) NATIONAL FORESTS.

23 (c) WILDERNESS AREAS.

24 (d) WILDLIFE REFUGES.

- 1 (e) NATIONAL MONUMENTS.
2 (f) NATIONAL HISTORIC SITES.
3 2. DOES NOT INCLUDE:
4 (a) NATIONAL PARKS.
5 (b) INDIAN RESERVATIONS.
6 (c) FEDERAL MILITARY INSTALLATIONS.
7 (d) FEDERAL LANDS THAT CONTAIN PERMANENT IMPROVEMENTS SUCH AS FEDERAL
8 STRUCTURES FOR POST OFFICES, FEDERAL COURTS AND FEDERAL AGENCIES."
