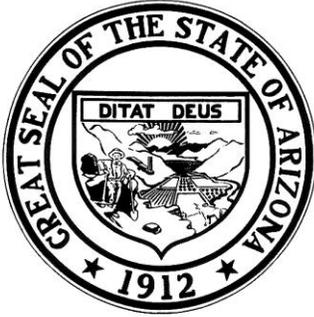


## HOUSE FLOOR AMENDMENT EXPLANATION



Bill Number: **HB 2410**

Stevens Floor Amendment

---

HB 2410 prohibits municipalities and their police departments from establishing traffic citation quotas and ranking or classifying peace officers based on this quota.

Your 2-page floor amendment extends this prohibition to counties and their sheriffs, and the Department of Public Safety and their officers. The amendment also replaces the word *citation* with *complaint*.
