## **FLOOR AMENDMENT EXPLANATION**

---

The Olson Floor amendment:

- Clarifies the Department of Juvenile Corrections (DJC) admission requirements.
- Requires DJC to annually assess a committed youth confinement cost sharing fee to each county.
- Provides counties with flexibility to meet the cost sharing requirements.
- Specifies legislative intent regarding the county contribution amount for committed youth confinement cost sharing.
- Makes technical changes.

OLSON FLOOR AMENDMENT

1 Page 1, strike lines 5 through 8, insert:

2 "A. A CHILD WHO IS ANY OF THE FOLLOWING SHALL NOT BE COMMITTED OR  
3 AWARDED TO THE DEPARTMENT OF JUVENILE CORRECTIONS:

4 1. ADJUDICATED DELINQUENT FOR AN OFFENSE THAT IS NOT A FELONY UNLESS  
5 THE CHILD HAS BEEN PREVIOUSLY ADJUDICATED DELINQUENT FOR AN OFFENSE THAT IS A  
6 FELONY OR IS SERIOUSLY MENTALLY ILL.

7 2. UNDER FOURTEEN YEARS OF AGE.

8 3. A DEPENDENT OR INCORRIGIBLE CHILD."

9 Page 2, lines 35 and 36, strike "joint legislative budget committee review;"

10 Strike lines 37 through 46, insert:

11 "A. THE DEPARTMENT SHALL ANNUALLY ASSESS A COMMITTED YOUTH CONFINEMENT  
12 COST SHARING FEE TO EACH COUNTY."

13 Reletter to conform

14 Page 3, between lines 13 and 14, insert:

15 "D. NOTWITHSTANDING ANY OTHER LAW, A COUNTY MAY MEET THE COST SHARING  
16 REQUIREMENTS OF THIS SECTION FROM ANY SOURCE OF COUNTY REVENUE DESIGNATED BY  
17 THE COUNTY, INCLUDING MONIES OF ANY COUNTYWIDE SPECIAL TAXING JURISDICTION IN  
18 WHICH THE BOARD OF SUPERVISORS SERVES AS THE BOARD OF DIRECTORS."

1 Page 4, line 24, strike "a"

2 Line 25, strike "request" insert "requests"; after "to" insert "a total of"

3 Line 31, strike "request" insert "requests"

4 Between lines 41 and 42, insert:

5 "Sec. 13. Legislative intent; county contribution amount for

6 committed youth in secure care facilities

7 It is the intent of the legislature that the amount of the annual  
8 committed youth confinement cost sharing fee that the director of the  
9 department of juvenile corrections must assess to each county for committed  
10 youth in secure care facilities pursuant to section 41-2832, Arizona Revised  
11 Statutes, is each county's proportional share of \$12,000,000, using  
12 population data from the most recent United States decennial census."
