SB 1012 (Chapter 59): executive session; school safety plans

Authorizes a public body to hold an executive session in order to discuss or consider matters related to school safety plans, programs or operations. Contains an emergency clause.

SB 1042 (Chapter 63): executive sessions; security plans

Allows a public body to hold an executive session in order to discuss or consult on matters related to security plans, procedures, assessments or measures relating to or having an impact on security or safety.

SB 1130 (Chapter 35): auditor general continuation.

Continues the Office of the Auditor General for 10 years, until July 1, 2030.

SB 1292 (Chapter 76): financial literacy; state treasurer; fund

Establishes the State Treasurer's Financial Literacy Fund and directs the State Treasurer to promote awareness of financial literacy to Arizona residents.

SB 1293 (Chapter 37): DOI; DFI; omnibus

Makes numerous changes to statute relating to the newly created Department of Insurance and Financial Institutions.

SB 1297 (Chapter 41): legislative council; continuation

Continues the Legislative Council for 10 years, until July 1, 2030.

SB 1303 (Chapter 77): annexation of territory; requirements

Prohibits a city or town from annexing territory if the unincorporated territory is completely surrounded by a combination of the annexing city or town and other cities or towns as a result of the annexation.

SB 1354 (Chapter 79): public retirement systems; prefunding plan

Outlines the requirements for the Arizona employers' pension prefunding plan that is established by this Act.

Blends previous revisions of statute and conforms them with the Arizona Constitution.

SB 1408 (Chapter 44): ombudsman-citizens aide; continuation; reports; assistants

Continues the Office of the Ombudsman-Citizens Aide for eight years, until July 1, 2028. Requires the Ombudsman-Citizens Aide to present its report summarizing the Office's activities during the previous fiscal year annually and stipulates that the Ombudsman-Citizens Aide must appoint one assistant who is an attorney to help investigate complaints.

Establishes the State Board of Investment as the trustee of the Family College Savings Program and transfers this program to the Office of the State Treasurer.
