**HB 2244 (Chapter 17): AHCCCS; dental services; Native American**

Requires the Arizona Health Care Cost Containment System to seek federal authorization to reimburse the Indian Health Services and tribal facilities to cover the cost of adult dental services.

**HB 2668 (Chapter 46): hospitals; unreimbursed costs; assessment; fund**

Establishes the Health Care Investment Fund (Fund) and requires the Director of the Arizona Health Care Cost Containment System to establish, administer and collect an assessment on hospital revenues for inpatient or outpatient services or both for purposes of the Fund.

**HB 2695 (Chapter 23): TANF; financial literacy education**

Permits the Department of Economic Security to allow a course in financial literacy and personal finance to qualify as a work activity as it relates to assistance.

**SB 1049 (Chapter 27): advisory council on aging**

Establishes the Advisory Council on Aging in the Governor's Office of Youth, Faith and Family.

**SB 1050 (Chapter 28): board of athletic training; continuation**

Continues the Arizona Board of Athletic Training for 8 years, until July 1, 2028.

**SB 1051 (Chapter 6): DHS; continuation**

Continues the Arizona Department of Health Services for 8 years, until July 1, 2028 and appropriates \$55,000,000 in FY 2020 from the Budget Stabilization Fund to the Public Health Emergency Fund to pay the expenses of public health emergency responses related to the coronavirus disease of 2019 (COVID-19).

**SB 1052 (Chapter 29): homeopathic board; continuation**

Continues the Board of Homeopathic and Integrated Medicine Examiners for 8 years, until July 1, 2028.

Continues the Board of Psychologist Examiners for 8 years, until July 1, 2028.

Continues the Commission for the Deaf and the Hard of Hearing for 8 years, until July 1, 2028.

Prescribes training and testing requirements for certification as an assisted living facility caregiver.

**SB 1523/HB 2764 (Chapter 4): mental health omnibus**

Grants the Department of Insurance authority to enforce mental health parity, establishes the Mental Health Parity Advisory Committee, the Suicide Mortality Review Team and the Children's Behavioral Health Services Fund (Fund), and appropriates funds to the Department of Insurance and the Fund.
