

Driving Under the Influence Data Collection Study Committee

PURPOSE: To: (1) gather information to understand current driving under the influence related data collection processes among the various law enforcement agencies, crime labs, prosecutorial offices and courts in this State; and (2) recommend data collection processes and systems and the necessary funding to centralize driving under the influence related data reporting and collection to guide the Legislature, law enforcement agencies, crime labs, prosecutorial offices and the courts in this State when developing policies to better enforce driving under the influence laws, reduce the number and impact of impaired drivers and educate the public on the consequences of driving while impaired. On or before December 16, 2022, the Committee shall submit a report regarding the Committee's activities and recommendations for administrative or legislative action to the Governor, the President of the Senate and the Speaker of the House of Representatives.
