

Joint Border Security Advisory Committee 2011

PURPOSE: To: (1) take testimony and other evidence regarding the international border with Mexico; (2) analyze border crossing statistics; (3) analyze related crime statistics; (4) make recommendations designed to increase border security; (5) administer and manage the construction and maintenance of the physical or virtual border fence, using technology to the maximum extent practicable; and (6) make other recommendations deemed essential by the Committee. Beginning November 30, 2011 and each month thereafter, the Committee shall submit a written report of its findings and recommendations to the Speaker of the House of Representatives, the President of the Senate and the Governor. The Committee shall provide a copy of the report to the Secretary of State.

Notes: The President of the Senate and the Speaker of the House of Representatives shall each appoint a Co-Chair of the Committee. The Committee shall meet on the call of the two Co-Chairs, but no more frequently than monthly. Notwithstanding any law to the contrary, the Committee may vote to go into executive session to take testimony or evidence it considers sensitive or confidential in nature, which if released could compromise the security or safety of law enforcement or military personnel or a law enforcement or National Guard law enforcement support operation.
