

La Paz County West Basin Water Users Study Committee

PURPOSE: To: (1) receive and analyze all groundwater withdrawal data developed by the Department of Water Resources; (2) make recommendations to the Director of Water Resources, including recommendations on programs and policies for the basin; (3) review and make recommendations to the Director of Water Resources regarding the independent consultant's report in which the independent consultant estimates the rate of groundwater depletion in the northwest basin planning area and estimates the number of years of groundwater that remains in the basin; and (4) submit a report of its recommendations to the Director of Water Resources, the Governor, the President of the Senate and the Speaker of the House of Representatives on or before December 31, 2021 and provide a copy of the report to the Secretary of State.
