

Legislative Governmental Mall Commission

PURPOSE: To: (1) develop, maintain, and amend, as necessary, a long-range general plan for the development of the governmental mall; (2) encourage public agencies to enter into intergovernmental agreements or contracts as necessary to implement the general plan; (3) review and approve or disapprove in writing requests for permission to develop structures or sites or award construction contracts for new buildings or improvements within the governmental mall; (4) review all planning activities within the governmental mall boundaries; and (5) publish an annual report on the issues brought before the Commission and its recommendations.

If a member of the Commission is more than one hundred years of age, five other members of the Commission constitute a quorum.
