Notes: On or before November 1, 2016, the Governor shall make one appointment to the Board from the list of nominees followed by one appointment made in turn from the President of the Senate and the Speaker of the House of Representatives until eight members are appointed to the Board. The eight members initially appointed to the Board shall elect a Chairperson who shall appoint the Advisory Committee. That Advisory Committee shall forward to the newly appointed board of trustees of the PSPRS at least five nominees who are qualified and willing to serve on the Board for the appointment of the ninth member of the Board. From that list of nominees, the newly appointed board of trustees of the PSPRS shall forward to the Governor at least three nominees for the appointment of the ninth member of the Board, which shall be made on or before December 1, 2016.
