## Peace Officer Employment Study Committee Recommendations Proposals

- 1. Support for the full funding of Arizona Peace Officer Standards and Training (AZPOST).
- Propose a statutory fee by percentage to be assessed on all RICO seizures by Arizona law enforcement agencies and approved by the courts to be dedicated to AZPOST for training only.
- Requiring that police departments hold an exit interview with all officers leaving their department.
- 4. More state funding for the School Resource Officers Program.
- 5. A mandated employee satisfaction survey.
- 6. Forming protect and serve care teams for law enforcement and their families. (Pastor Eric Jones presentation)
- 7. Recommend a dedicated funding resource from state surplus funds to be used for increasing staffing deficiencies for law enforcement.
- 8. Informing the local high schools about upcoming training exercises as a way to reach out to the youth.
- 9. A standardized formula to determine and report response times.

## Additional considerations

- A. Establish a 1.8 to 2.2 officer per 1000 population ration for urban environments. OR- exploration of a 5 min priority one response time as the standard for rural agencies. The definition of priority one would have to be agreed on.
- B. Annual or every two years audit to ensure compliance with recommendations. With a set percentage sanction of state shared revenues for non-compliance.
- C. Recommend to continue the Peace Officer Employment Study Committee.
