
2023 Arizona House Committee on International Trade Delegations to the United Kingdom, Romania and Canada






Delegation Meetings United Kingdom

Meeting and Tour of the U.S. Embassy London

The delegates launched the UK portion with a market briefing from the U.S. Embassy London diplomats on the political and economic situation of the United Kingdom from the viewpoint of the United States government. The briefing aimed to help legislators understand the challenges and opportunities that US businesses face when operating in the UK. Following the presentations, the delegates participated in a Q&A with representatives from the U.S. Embassy's Political, Economic, Public Affairs, Agriculture sections, U.S. Department of Commerce and Office of Defense Cooperation. Minister Counselor for Economic Affairs Virginia Murray moderated the briefing.




Westminster Tour and Roundtable Discussion

The delegation visited Westminster to gain a comprehensive and firsthand understanding of the inner workings of the UK's parliamentary body. This visit offered a unique opportunity for the legislators to delve into the intricate processes, procedures, and mechanisms that govern the UK's legislative affairs. Rt. Honorable Lord Thomas McNally hosted a roundtable discussion with the lawmakers to further the Arizona-UK bilateral relationship, explore legislative partnerships, and discuss the alignment of industries and policies.

Blick Rothenberg Luncheon


Blick Rothenberg hosted the delegation for a luncheon meeting that included stakeholders from British private industry. Blick Rothenberg is a firm that provides international tax, accounting, and business advisory services. Among the topics discussed were opportunities for U.S. businesses expanding globally, as well as UK outbound initiatives. The goal of the meeting was to educate legislators on the tax laws and regulations for international businesses operating in both the UK and the U.S. in addition to successful trade office foundations as Arizona plans to open a trade office in the UK.













Delegation Outcomes United Kingdom

International Collaborations and Partnerships

Efforts have been made to strengthen ties and collaborations with various international entities, such as Axon UK, US Embassy London, U.S. Commercial Service, Avnet, UK Department of Trade and Business, King's College, and Terra Quantum. These collaborations involve meetings, introductions, and consultations aimed at fostering partnerships in trade, defense, education, and technology.

Arizona-UK Trade and Investment Expansion

There is a notable focus on expanding Arizona's trade and investment opportunities with the UK. Activities include advancing Memorandums of Understanding (MOUs), and discussing models of implementation for the Arizona trade and Foreign Direct Investment (FDI) office in the UK. This encompasses engagements with government bodies, academic institutions, and businesses.

Promotion of Arizona Tourism and Aviation Opportunities

Initiatives are underway to promote Arizona's tourism and explore aviation opportunities. This involves collaboration with entities such as British Airways (BA) to discuss tourism promotion within the global commercial airlines industry and assess opportunities for expanding direct flights into Europe and globally. Additionally, preparations have been made for meetings with Arizona aviation entities and relevant organizations to explore expansion possibilities.





Delegation Summary

Romania 🚺

The delegation continued their international mission to Romania, an Eastern European country with growing strategic importance, especially due to the ongoing war in Ukraine. Romania's geographic location makes it a key player logistically not just today, but also when the full restructuring of Ukraine will commence. As Arizona plans to open a trade office in Romania, the lawmakers made the most of the opportunity to meet with cabinet members, business leaders and attended the Three Seas Initiative Business Forum, where Chairman David Cook spoke on clean energy. 


Meeting with Brasov Mayor Allen Coliban






Romania 📗

Three Seas Initiative

The Three Seas Initiative was launched in 2015 as a forum to advance the development of infrastructure in the 12 Central and Eastern European countries in the EU, Austria, Bulgaria, Croatia, Czechia, Estonia, Hungary, Latvia, Lithuania, Poland, Romania, Slovakia, and Slovenia. The Government of Romania invited Arizona's International Trade Committee to attend and participate in the conference. Chairman David Cook of the International Trade Committee was invited to speak on Arizona's role in the clean energy economy.







Delegation Outcomes Romania

Enhanced Arizona-Romania Trade and Partnerships

Various initiatives have been undertaken to strengthen trade and partnerships between Arizona and Romania. This includes email and virtual meeting introductions with entities such as the U.S. Commercial Service in Bucharest, Invest Brasov, Schaeffler Romania SRL, Benchmark Electronics, and Hidroelectrica Romania. Bilateral visits by Romanian officials, including Parliamentarian Cristian Bacanu and Mayor Ciprian Ciucu, aim to advance Arizona-Romania bilateral trade.

Collaboration in Innovation and Technology

Efforts have been made to foster collaboration in innovation and technology. This involves email and virtual meeting introductions for Minister of Research, Innovation and Digitalization, as well as the Head of IT Commission and Group of MPs, with entities like the ACA, AZ Tech Council, and Arizona's innovation schools. Talks on drafting bilateral trade/FDI MOU between Arizona and Romania have also been initiated.

Sector-Specific Collaborations

Targeted collaborations in specific sectors have been identified. This includes connections with the Romanian American Chamber of Commerce (RACC) focusing on AI and IT sectors, startup ecosystems, and upcoming meetings with the AZ Tech Council. Additionally, efforts to identify areas for cooperation in hydroelectric projects, mining, clean energy, and workforce development programs involve entities such as Hidroelectrica Romania, the Ministry of Energy, and the Ministry of Economy, Entrepreneurship, and Tourism. Cooperation in AI, IT, and defense/cybersecurity sectors is also being explored with the EU Cybersecurity Center and the Walter Tosto facility.




Meeting with Bombardier


Delegation Highlights Canada [*]

The focus is on sectors such as AI, technology, aerospace, mining, and infrastructure, with an emphasis on identifying areas for cooperation and knowledge-sharing.

Strengthening Trade Relations and Investments

Activities are underway to strengthen trade relations and attract investments. This includes preparations for email and virtual introductions with entities such as TSX, Li-Cycle, OMERS, BMO, and various Canadian government representatives. The objective is to promote discussions on capital investments, infrastructure projects, and opportunities in sectors like public transit, water conservation, agriculture, mining, and forestry.



Arizona trade with Australia, 2022













I. Overview of International Trade Missions 2023

A. Context: International Trade Plan

The House of Representatives has been reaching out to organizations in Arizona to open discussion on an International Trade Plan (Plan). This comes following the establishment of the Arizona House Committee on International Trade, with Representative David Cook as Chair and Representative Justin Wilmeth as Vice-Chair. Working closely with Speaker Ben Toma, the Chairman addressed the Plan for conducting international trade. This Plan has been presented to and received positive feedback by organizations whose expertise provide insights and data-driven decision-making for the committee members. These areas of expertise include but are not limited to, international affairs, local private and public partnerships and global business.

On April 10, 2023, the Plan was adopted unanimously by the House Committee on International Trade.

The objectives of the Plan were to:

- 1. Strengthen bilateral ties with existing international partners;
- 2. Attract more Foreign Direct Investment (FDI) to Arizona; and
- 3. Extend Arizona's international reach for sustaining a resilient and growing economy.

The Plan's trade and FDI missions were to gather information, investigate possible opportunities and, if necessary, travel and connect with counterparts for the potential establishment of Arizonan international trade and FDI offices.

These trade opportunities and missions targeted the following countries in 2023 with their respective intended and hopeful long-term outcomes:

- · Canada:
 - o Implement a regional trade office in Canada, with the potential of extending others throughout eastern and western Canada in the future.
- United Kingdom (UK):
 - o Implement a regional trade office in the UK and adopt a draft Memorandum of Understanding (MOU) on trade and priority sectors for collaboration between the state of Arizona and the UK.

Romania:

O Attend the Three Seas Initiative summit on September 5th and 6th, assess the growth of the Romanian market and the overall Eastern European region for a potential regional trade office in Eastern Europe, including the Balkan states, the Black Sea, Adriatic and Baltic seas and undertake preparations for Chairman Cook's speech at a subpanel on energy during the Three Seas Initiative Business Forum.

B. Dates, Locations of Trade Missions and Delegations

The first International Trade Mission was a two-week travel plan in two sequences:

- 1. Mission to London, UK:
 - Dates: August 29th through September 4th.
- 2. Mission to Bucharest and Brasov, Romania:
 - Dates: September 4th through 9th.

The second International Trade Mission was an eight-day travel plan to Canada in the following order:

- Mission to Ottawa, Montréal and Toronto:
 - Dates: September 19th through 27th.

Stakeholders:

The Phoenix Committee on Foreign Relations (PCFR) has signed a Master of Services Agreement with the Arizona House of Representatives to support members of the delegations with the logistics and coordination of the delegations' itineraries and agendas throughout the trade and FDI missions to the UK, Romania and Canada, as approved by the Chairman of the House Committee on International Trade or designee of the missions.

Additionally, pertinent stakeholders supported the delegations throughout these missions, including the UK Honorary Consul in Arizona, the British Consulate General in Los Angeles, the Arizona Technology Council, the Arizona District Export Council, the Romanian Embassy in Washington DC, the Romanian Government, the Canada Arizona Business Council, the Consulate General of Canada in Los Angeles, the Québec Government Office in Los Angeles, the Provinces of Ontario and Québec Governments and the US Embassies in London, Bucharest and Ottawa as well as the US Consulates in Montréal and Toronto.

II. United Kingdom Trade Mission

A. Summary

In 2021, Arizona exports to the UK were valued at over \$582 million and imports were at \$862 million. According to the ACA's data report, the UK was Arizona's 9th largest export market in 2021. The most significant exports and imports in terms of dollar value were in aerospace products and parts (\$184m in Arizonan exports and \$118m in UK imports). According to D&B Hoovers, there are more than 400 business establishments in Arizona with an ultimate parent company in the UK.

The Arizona delegation to the UK met with key stakeholders involved in bilateral trade and investment between the United States (US) and the UK. Among these stakeholders were included Arizonan companies with investments in the UK, particularly in the semiconductor industry, the US Commercial Service team located at the US Embassy in London, representatives from His Majesty's Government of the UK, King's College professors and economic development organizations (EDOs) such as British American Business and Blick Rothenberg.

These meetings helped the delegation assess the political, economic and social conditions of the UK market and allowed the delegation to gather data points and relevant connections which would enable further collaboration with Arizonan entities such as the Arizona Commerce Authority (ACA) into determining how, where and when to implement a regional trade and FDI office in the UK.

III. Romania Trade Mission

A. Summary

In 2019, exports and imports between Arizona and Romania were valued at \$38 million and \$8 million respectively. Although these numbers were not seen as high, Romania is today one of the fastest growing economies in Europe. According to the World Bank, its economy recovered at 5.9% in 2021 and performed better-than-expected in the first half of 2022, with a growth of 5.8%. This comes despite a significant pick-up in inflation, the COVID-19 pandemic and now the war in Ukraine. The growth is mainly fueled by increased activity in commerce and services, as private consumption remained the main engine of the economy. The Information, Communication and Technology (IT&C) sector contributed greatly to this growth. According to Reuters, Romania more recently stands to receive up to €30 billion (approx. \$32.87 billion) worth of grants and loans until 2026 out of the European Union's (EU) €724 billion Recovery and Resilience Facility, designed to help economies' post-pandemic rebound. Moreover, European Investment Bank officials stated that Romania has a strong pool of renewable energy and has capability to achieve full energy independence, becoming a net importer of energy and capturing EU funds for transportation and infrastructure projects. To add up, Romania has developed a program called State Aid, which allows FDI of over €5 million (approx. \$5.49 million) to be eligible to receive up to 50% of the investment amount Romanian government funding support. Romania is at the crossroads of Eastern Europe, well positioned for Ukraine's reconstruction phase, having direct access to the Black Sea that is connected to Central Europe with the Danube river and several other important growing economies ranging from the Baltic states to Greece, including Türkiye.

In this context, 12 Eastern European countries have formed up the Three Seas Initiative. The Three Seas countries represent almost a third of the EU and are home to 111 million people. However, figures from 2018 show that their average gross domestic product (GDP) per capita is just 78% of the EU average. At the same time, the average economic growth in the 12 countries from 2015 to 2019 was 3.5% compared to 2.1% in the EU. The International Monetary Fund forecast that the Three Seas countries' average GDP growth was about 3.3% (in the last 5 years) compared to an average of 1.6% for the EU as a whole. The Three Seas countries output a total turnover of €225.6 billion (approx. \$239.4 billion), with a territory spanning 1.2 million square kilometers (approx. 463,323 square miles), which represents roughly 30% of the EU. Recently, the Three Seas countries need more than €500 billion (approx. \$530.5 billion) for infrastructure investments.

The trade and FDI mission to Romania not only was designed to assess the Romanian market, but also to attend the Three Seas Initiative summit that was hosted in Romania and explore the overall economic, social and security dynamics of Eastern Europe and how a conglomerate of emerging economies in this region may bring future growth to Arizona.

The Arizona delegation to Romania met with key stakeholders involved in bilateral trade and investment between the US and Romania. Among these stakeholders were included Arizona-based high-tech manufacturing company Benchmark, the US Commercial Service team located at the US Embassy in Bucharest, the Romanian Minister of Research, Innovation and Digitalization, the Minister of Economy, Entrepreneurship and Tourism and the Minister of Energy, the Mayor of Braşov and his economic development team, the Romanian American Chamber of Commerce and Three Seas Summit entities such as global energy sector leadership and the EU Cybersecurity Center focused on EU's and NATO's cybersecurity and AI development efforts.

These meetings helped the delegation assess the political, economic and social conditions of the Romanian and Eastern European market and allowed the delegation to gather data points and relevant connections which would enable further collaboration with Arizonan entities such as the ACA into determining how, where and when to implement a potential regional trade and investment office in Romania.

IV. Canada Trade Mission

A. Summary

With over \$2.3 billion of exports to Canada and \$2.33 billion of imports in 2021, the Arizona-Canada binational Terms of Trade of 98.71% was in near perfect equilibrium and is today one of the most important economic exchanges in terms of value for Arizona. This makes Canada Arizona's largest FDI contributor, with an approximate cumulative sum of \$1.12 billion from Canadian companies investing in Arizona over the last 6 years. Moreover, almost 50% of all funding for the mining sector in Arizona comes from Canadian entities.

The Arizona delegation to Canada met with key stakeholders involved in bilateral trade and investment between the US and Canada. Among these stakeholders were included economic development agencies such as Invest Ottawa, Investissement Québec and Invest Montréal, meeting with the US Ambassador at the US Embassy in Ottawa and the US Consul General in Montréal, meetings with aerospace and defense stakeholders such as Bombardier and Aero Montréal, the Ontario Legislative Assembly and key financial institutions such as CDPQ, OMERS, OTPP and BMO Capital Markets.

These meetings helped the delegation assess the political, economic and social conditions of Canada and the provinces of Québec and Ontario and allowed the delegation to gather data points and relevant connections which would enable further collaboration with Arizonan entities such as the ACA in determining how, where and when to implement a regional trade and investment office in Canada.

I. Proposal - International Trade Plan 2024

A. Statement

The Chairman of the House Committee on International Trade, Mr. David Cook, with approval from Speaker Ben Toma, announced an International Trade committee hearing scheduled to take place on Tuesday, December 12th, 2023, at 10:00 AM on the House Floor.

The House Committee on International Trade (Committee) unanimously adopted the International Trade Plan for the year 2023 on April 10, 2023. The Plan laid the groundwork for enacting trade and foreign direct investment (FDI) missions. These missions were conducted by members of the Committee, staff supporting the members and Arizonan non-governmental entities with business and logistical expertise on international trade and investment.

Now, an International Plan for the year 2024 (Plan 24) is currently being discussed.

B. Objectives and Mission of Plan 24

The objectives of Plan 24 are to:

- 1. Strengthen bilateral ties with existing international partners;
- 2. Attract more Foreign Direct Investment (FDI) to Arizona; and
- 3. Extend Arizona's international reach for sustaining a resilient and growing economy.

Plan 24's mission is for the Committee to gather information, investigate possible opportunities and, if necessary, travel and connect with foreign counterparts for the potential establishment of Arizonan international trade and FDI offices.

C. Stakeholder Meetings

The Committee has been conducting stakeholder meetings and consultations with entities such as, but not limited to, the:

- Arizona Commerce Authority (ACA);
- Greater Phoenix Economic Council (GPEC);
- Phoenix Committee on Foreign Relations (PCFR);
- Arizona Technology Council; and
- Global Ties Arizona.

Plan 24 outlines a requirement to continue engaging with organizations such as those outlined above to drive the objectives and mission of Plan 24. Additional stakeholder organizations may be included as the Committee moves forward.

D. Countries for Consideration

As a result of these meetings and consultations, the Chairman, the Vice-Chair and members of the Committee have identified the following countries where Plan 24 may be implemented:

- 1) Australia;
- 2) India;
- 3) Indonesia;
- 4) Japan; and
- 5) New Zealand.

More data and information about these countries are outlined in the <u>Appendices</u> section at the end of Plan 24.

E. ACA International Trade Offices

Plan 24 intends to utilize ACA's support and data resources for driving the objectives and mission of Plan 24. Details about ACA's international trade offices have been shared by the ACA as follows:

In terms of financing, there is no uniformity relating to the cost or funding of the offices. The pricing of each office attempts to reflect the country's market size and the requisite scope of the operation.

Currently, there are seven trade offices globally administered by the ACA. Three are located in Mexico (Mexico City, Chihuahua and Guanajuato). There is one office in Tel Aviv, Israel. Last year, a Europe office opened in Frankfurt, Germany. More recently this year, the offices in South Korea and Taiwan have opened.

According to ACA, funding is used not only to cover a contractor/team in-country and office rental, but also to assist Arizonan companies (particularly small and medium-sized companies) to benefit from the offices through participation in trade shows and business-to-business (B2B) and business-to-government (B2G) trade missions. Such initiatives give Arizona companies the opportunity to connect with potential sales channel partners (distributors and representatives) and end-buyers and -users.

The ACA staffs the offices with in-country consultants who are selected through a competitive bid process. In the case of the Europe office based in Germany, the contractor is a consulting firm that also has European offices in Paris, London, Dublin and Belfast, which provides wider Europe coverage and assistance for Arizona.

Funding for trade offices covers the following:

- 1) Consultant/contractor's professional fees;
- 2) Office rental and related office expenses; and
- 3) Essential travel by office personnel to carry out contractors' dual tasks of trade/export assistance to Arizona companies and FDI.

Funding is also utilized for booth space and associated costs to enable Arizona companies (particularly small and medium-sized) to participate at key international trade shows/expos in the various country markets as well as to participate in B2B/B2G trade missions.

The breakdown of these costs varies depending upon each office location, factoring in disparate costs of primarily professional fees and rents. The ACA states a trade office that is underfunded and thus does not enable Arizona company B2B/B2G activity in a country is not going to be able to deliver the requisite value.

According to ACA, the ideal scenario for selecting a country is to marry the intention and wisdom of the Governor, the Legislature, and the ACA's international trade and investment team. ACA argues that it is best not to designate the actual city in the legislative appropriation language. This would allow for some potentially important flexibility that would factor in changes in safety and security in a city or region of a country, and perhaps most importantly where ultimately the best consultant/contractor is based in the country. For example, with the Germany office, key considerations were Frankfurt's position as the largest financial hub in continental Europe, the strong interconnectivity throughout Europe provided by Frankfurt's international airport, and the ease of access to both Berlin and Munich in Germany, among other considerations. In the case of Taiwan, the city of Taipei is the economic and political capital of the country. In the case of South Korea, Seoul is the economic and political capital of the country.

F. Government Relations, Regulation & Tourism

As agreed by members of the Committee and Chairman Cook, Plan 24 should address whether there are state or federal regulations hindering international trade and businesses conducting trade and whether Arizona could facilitate trade business. Examples of barriers can be, but are not limited to, seasonal limitations, customs border, taxes for certain products and/or services, travel distances and cultural variations per each region targeted.

Part of Plan 24 is to advance tourism in Arizona. As such, the Committee agreed to consider boosting the tourism sector, in addition to establishing new trade and FDI routes. Some examples can be considered such as:

- Having the Arizona Office of Tourism (AOT) develop an international advertising strategy program like its <u>domestic program</u>;
- Promoting the Appreciate AZ program; or
- Engaging in spreading cultural awareness for the local diaspora such as during annual foreign festivals.

Plan 24 should also encompass and integrate AOT's strategic plan for increasing flight bookings, average spend and frequency of positive international article coverage by expanding marketing campaigns to larger tour operators. Moreover, Phoenix Sky Harbor International Airport conducts a strategy to capture more international direct flights to increase the diversity of Arizona's product offerings. For instance, Condor Airlines, which operates direct flights from Phoenix to Frankfurt, Germany, has seen its services grow to three times weekly in 2023, compared to twice weekly in 2022. Moreover, international arrivals at Sky Harbor have increased by 12.9% during January-September 2023, compared to the same period in 2019, according to a press release by Sky Harbor.

G. Outcome of Plan 24

The outcome of Plan 24 is to enhance Business-to-Business, Business-to-Government and Government-to-Government relations with existing partners, including facilitating trade, exploring cost-saving projects for state government, local municipalities and cities and optimizing Public Private Partnership opportunities for a sustainable and resilient Arizonan economy.

Arizona-Australia Trade and FDI Profile 2023-10:



Arizona-Australia Trade and FDI Profil

With over \$474 million of exports to Australia and \$88 million of imports in 2022, the Arizona-Australia binational ToT of 538.64% represented a positive Balance of Trade (BoT) for the state of Arizona. In other words, Australia inputs significant revenues for the state of Arizona.

According to the ACA's Trade and FDI Profile 2023-10, Australia ranked 16th among Arizona's export markets, with a 95.7% increase in exports between 2017 and 2022. Arizona's sources of exports in 2022 were the 4th largest for pharmaceuticals and medicines (\$18m) and for agriculture and construction machinery (\$17m). Australia was also the 5th largest for computer equipment (\$43m) and 6th largest for audio and video equipment (\$12m). Compared to other US states, Arizona was 1st in hardware, 2nd for audio and equipment and 3rd for aerospace products and parts (\$196m; top export in terms of value) exports to Australia. Another significant source of exports was from navigational, measuring, electromedical and control instruments (\$36m).

The report also indicated that Australia was numbered 31st as an import source for Arizona. The main source of import in 2022 was from miscellaneous manufactured commodities (\$10m). Among US states, Arizona imported the most ventilation, heating, air-conditioning and commercial refrigeration equipment (\$4m) and the 4th-most communications equipment (\$8m).

As a result of the trade and FDI mission to the United Kingdom (UK), the Arizona House Committee learnt more about AUKUS, which is the Trilateral Security Partnership Between Australia, the UK and US. According to the US Department of Defense, AUKUS intends to strengthen the ability of each country by supporting security and defense interests. The partnership is designed to optimize ongoing bilateral ties and to promote deeper information and technology sharing. It also acts as a catalyst for fostering deeper integration of security and defense-related science, technology, industrial bases and supply chains. Among key economic activities under AUKUS is the procurement process for Australia to acquire nuclear-powered submarines. The state of Arizona's strength in its aerospace and defense sector represents an alignment of AUKUS goals.

The first charging sites are scheduled to be operational within 18 months. Evie's US market expansion is being backed by Brisbane-based St Baker Energy Innovation Fund.

GroundProbe is the brand most trusted by mining and civil operators globally and has invested \$19m in Arizona on manufacturing activities in the industrial equipment sector.
4.	Arizona Lithium	Arizona Lithium is a lithium exploration and development company with its head office in Perth, Western Australia. Arizona Lithium trades on the Australian Stock Exchange under the symbol AZL. The

		company is currently exploring and developing its two main projects: The Big Sandy project in Arizona and the Prairie Lithium project in Saskatchewan, Canada. The company also has Bureau of Land Management claims for exploration near Lordsburg, New Mexico, USA. Arizona Lithium's main office and Lithium Research Center (LRC) in North America are located in Tempe, Arizona, with a field office in Saskatchewan. The firm invested so far \$12.5m in Arizona.
5.	Removify	The firm provides the world's number 1 solution for online content removal. It has invested \$5.7m invested in Arizona in their business services sector.
6.	Archistar	Archistar is an Australian property intelligence platform, has secured \$10.4m in Arizona in its latest funding round from several investors including NAB Ventures, as it looks to expand its product offering and launch in the US. The expansion plan also encompassed a first acquisition by securing Snaploader, which provides clients interactive 3D experiences for real estate to simplify the selling and marketing process.
7.	ASL	ASL, based in Brisbane, Australia, provides testing, inspection, certification, and verification services out of over 370 sites across 65 countries. The company initially provided analytical chemistry services for the oil shale and mineral exploration industries and grew steadily in its first decade of operations. For a variety of industries, has two personal care and over the counter drug and personal care product testing facilities in Phoenix, an equipment reliability testing facility in Phoenix, an environmental testing facility in Tucson and a geochemistry testing facility in Tucson.

Enhance Government Regulation Relations

Most goods imported into the US go through the Australia Free Trade Agreement (AUFTA). Goods flowing through AUFTA are free of duty and merchandise processing fee (MPF). As of January 1, 2022, all AUFTA goods are duty free, according to the US Customs and Border Protection webpage. AUFTA is an example of ways for reducing trade regulatory barriers on a national level.

The State of Arizona could help identify which Australian products are not listed within AUFTA and for those currently in the list, could support increasing flow of trade. Part of this process may help reduce unknown MFPs and/or other tariffs on long distance supply chains seen on container shipments.

Another G2G approach for enhancing relations that the Committee identified would be to focus on the security pacts spanning the Oceania/Pacific regions, namely on AUKUS.

Tourism and Australian Community in Arizona

According to AOT's International Visitation to Arizona report, in 2019 there were 70,680 Australian visitors in Arizona. This number steadily increased by approximately 30% from 2015 to 2019 before a sharp decline due to the pandemic.

Furthermore, Arizonan academic institutions provide several learning and cultural immersive programs to students interested in traveling to Australia. For example, University of Arizona (UoA) holds study abroad <u>programs</u> for its students called "Explore Programs Oceania". ASU's Global Flex <u>program</u> also encompasses countries such as Australia.

Arizona-India Trade and FDI Profile 2023

With over \$265 million of exports to India and \$538 million of imports to Arizona in 2022, the negative BoT for Arizona illustrates how much trade is coming into the region for the local Indian diaspora. This is mainly due to a significant rise in imports over the last three years, with a 132.9% increase from 2020 to 2022, whereas exports contracted slightly by 17.44% since 2020 to 2022. However, exports overall increased by 68.3% and imports by 125.7% from 2017 to 2022, according to the ACA's Trade and FDI Profile 2023-08.

In 2022, India ranked 21st among Arizona's export markets, being 3rd for semiconductors and other electronic components (\$35m) exports and being the 4th largest market for other agricultural products (\$22m). The most significant export source to India was from aerospace products and parts (\$51m), which was the main driver for the spike of Arizona exports to India in 2019 (record \$817m total exports). Another important source of exports to India was from navigational, measuring, electromedical and control instruments (\$35m).

In 2022, India was Arizona's 14th largest import source, India being the largest source for other agricultural products (\$68m); the most significant import in terms of value. Other significant import sources were from semiconductors and other electronic components (\$44m), miscellaneous manufactured commodities (\$26m) and aerospace products and parts (\$25m). In the same year, India was also the 3rd largest source of import for pesticides, fertilizers and other agricultural chemicals (\$14m).

According to a Sustainomics newsletter, India's overall exports have been experiencing significant growth as one of the main emerging economies of the World (i.e., India is part of the BRICS; Brazil, Russia, India, China and South Africa; these nations are described as fast-growing economies). In 2023, India is set to reach a new high of \$770 billion in growth, a 13.84% year-toyear increase. The US continued to be India's largest merchandise export destination, with exports worth \$78.31 billion, a more than 2% increase from last year. The World Trade Organization (WTO) has forecasted a 1.7% growth in global merchandise trade volume for 2023, lower than the previous year's 2.7% growth. However, WTO expects it to increase again in 2024, with a projected growth of 3.2%. An Asian Development Bank report estimates that the manufacturing sector in India is expected to drive this growth, with greater exports anticipated in 2024-25. The report also showcases the potential for contact-intensive sectors such as tourism, which could boost services export. Moreover, the Indian government's Production-Linked Incentive scheme is expected to enhance the competitiveness of Indian companies and expand their global footprint, particularly in sectors such as electronics and solar panels. Nevertheless, potential risks have been identified albeit the positive outlook of trade growth, including geopolitical tensions, food insecurity, potential financial instability, and increasing levels of debt.

Enhance Government Relations

According to a White House join statement between the US and India on June 22, 2023, the US-India bilateral trade exceeded \$191 billion in 2022, nearly doubling from 2014. A US-India Commercial Dialogue and CEO Forum in March in New Delhi saw leaders encouraging respective industries to act on the recommendations from the CEOs for greater engagement and technical cooperation to build resilient supply chains for emerging technologies, clean energy technologies and pharmaceuticals. Promoting innovative digital economy, lowering barriers to trade and investment and harmonizing standards and regulations and work towards skilling workforces were other key components of conversation. At the national level, leaders support continued active engagement between the US Treasury Department and the Indian Ministry of Finance under the Economic and Financial Partnership dialogue. For instance, an existing Memorandum of Understanding framework encourages the US Federal Insurance Office and the Insurance Regulatory and Development Authority of India to advance areas of mutual interest in the insurance sector.

Moreover, India is a member of the Indian Ocean Rim Association (IORA) at which the US is a dialogue partner. IORA is a dynamic inter-governmental organization aimed at strengthening regional cooperation and sustainable development within the Indian Ocean region. In 2021, the US also joined the International Solar Alliance headquartered in India, which is an action-oriented, member-driven, collaborative platform for increased deployment of solar energy technologies as a means for bringing energy access, ensuring energy security and driving energy transition in its member countries. First Solar Power India, with its parent company originally headquartered in Arizona, invested \$176m between 2016 and 2023 in the renewable energy sector of India.

B2G opportunities may also occur between Arizona and India. For instance, Crescendo Worldwide, originally from India, is an International Trade and Investment generating organization working with 80+ countries and their Government agencies for trade and investment development. They have helped facilitate over \$65 billion of FDI and \$35 billion in trade. Crescendo Worldwide is currently working in with the Greater Seattle Partners, the latter announcing that Earth Care Equipments Private Limited, India's leading manufacturer of Organic Waste Converters, will establish its first North American location in Seattle. Recent Washington State green initiatives including passage of House Bill 1799 requiring diversion of organic materials away from landfill disposal played a significant role to enabling this particular Indian FDI. Multinational B2G/B2B organizations such as Crescendo Worldwide are highly interested in trade and FDI opportunities with the state of Arizona.

Tourism and Indian Community in Arizona

According to AOT's International Visitation to Arizona report, in 2019 there were 31,880 Indian visitors. This number increased by approximately 17.12% from 2015 to 2019 before a decline during the pandemic.

Indians are the 3rd largest immigration population in Arizona. According to the India Association of Phoenix, the growing Indian community in the cities of Gilbert, Chandler, Tempe and Scottsdale are in proximity to corporations like Intel and Microchip Technology Inc. There are about 45,000 Indian families living in Arizona, most of them working in IT or healthcare. As such, Arizona has seen a number of Hindu temples and Sikh gurdwaras being established. Moreover, the Indian community hosts several important Indian religious and cultural festivals such as the Holi festival in March of every year.

Appendix D: Indonesia - Data and Information

Arizona-Indonesia Trade and FDI Profil

In 2022, Arizona's total exports to Indonesia were \$95 million and total imports from Indonesia were at \$149 million, according to ACA's Trade and FDI Profile 2023-04. This accounted for 0.3% of the state's total exports and 0.4% of total imports, making Indonesia 33rd among Arizona's export markets and 24th in imports. As such, with a ToT of 63.76% and a negative BoT for Arizona (importing more than exporting), Arizona's trade with Indonesia was stable and growing, with both exports and imports having increased by 90.6% and 130.2% respectively over the past five years.

In 2022, the greatest export source to Indonesia in terms of value were aerospace products and parts (\$41m, representing about 43% of total exports). Indonesia was Arizona's 2nd largest export market for sawmill and wood products and 3rd largest export market for metalworking machinery (\$3m). Compared to other US states, Arizona exported the most other textile products, the 2nd most aerospace products and parts and semiconductors and other electronic components (\$6m) and 3rd most other fabricated metal products (\$8m).

Arizona's 2nd largest import market in 2022 for converted paper products (\$52m; representing more than 1/3rd of total imports) and 3rd largest for footwear was from Indonesia (\$13m) were from Indonesia. Among other significant import sources from Indonesia were apparel products (\$23m) and transportation equipment not elsewhere specified (\$23m).

With a population of 275.8 million, a 137.2 million labor workforce and a trade surplus of \$54.46 billion in 2022, Indonesia is a member of the Association of Southeast Asian Nations (ASEAN). ASEAN is a political and economic union of 10 states in Southeast Asia and includes some of the fastest emerging economies in the World, with Indonesia being one of the most significant in the region.

According to the World Bank's semi-annual Indonesia Economic Prospects June 2023 report, economic growth in Indonesia is projected to stabilize to 4.9% in 2023 from 5.3% last year. With inflation easing more quickly than initially anticipated thanks to the decline in global oil prices, Indonesia has also seen improved harvest, government interventions to ease supply bottlenecks, notably for food, and the appreciation of the Rupiah (Indonesia's local currency). Growth is expected to be supported by private consumption, while exports are projected to decelerate with easing commodity prices and global demand. According to an ASEAN <u>briefing</u>, Indonesia's government also is prioritizing the development of the country's special economic zones (SEZs), with a total of 20 SEZs identified across the country's 17,000 islands and maritime channels. This is a priority policy with the aim of attracting over \$50 billion in foreign investment over the next decade, particularly for SEZ-oriented manufacturing.

According to <u>Business Indonesia</u>, Indonesia possesses a wealth of mineral resources. Compared to the world's total reserves, the country is ranked 1st for nickel, 2nd for tin, 5th for gold, 6th for bauxite, 6th for coal and 7th for copper. It is home to thousands of mining companies

practicing world-class safety and environmental standards, has an abundance of cost-effective labor and, more recently, has implemented competitive tax-incentives for mining companies engaged in establishing a downstream industry for the extracted raw materials. Moreover, Indonesia's mining sector has created a great amount of traction for foreign investors. For example, a Reuters report illustrates that a British consortium, which includes mining giant Glencore will invest around \$9 billion in Indonesia's mining and electric vehicle battery sectors. The resource-rich country intends to attract a host of multinational firms. Indeed, Indonesia has the world's biggest nickel reserves and is keen to develop downstream industries with the ultimate aim of producing batteries and vehicles for the world's biggest electric car manufacturers. More importantly for Arizona, Freeport Indonesia has invested \$575m in the last 6 years, creating 270 jobs within the metals manufacturing industry, tying back into the mining supply chains.

Best Time for Travel

The best time to travel to Indonesia is from June to September when the weather is pleasant with a fair possibility of rainfall. Being a subtropical region, the weather in Jakarta is warm and humid throughout the year.

Enhance Government Relations

According to the US Department of State, Indonesia is the world's 3rd largest democracy, largest Muslim-majority country, the 7th largest economy by purchasing power and a leader in ASEAN. It possesses the world's greatest marine biodiversity and its 2nd greatest terrestrial biodiversity. Indonesia also borders the South China Sea, which has the world's busiest sea lanes (more than \$5 trillion in cargo and as much as 50% of the world's oil tankers pass through the South China Sea every year). A G2G engagement between the state of Arizona and Indonesia can help improve bilateral relationships by engaging in the same manner as the national level and by iterating Arizona's and Indonesia's geostrategic positioning in the globe and how both nations can create resilient and secured supply chains.

In 2010, the US and Indonesia launched a Comprehensive Partnership to foster consistent high-level engagement on democracy and civil society, education, security, resilience and mitigation, maritime, energy and trade issues. In 2015, this engagement was upgraded to encompass the US-Indonesia Strategic Partnership, extending cooperation to issues of regional and global significance. Approximately 14,700 Indonesians are alumni of USG-sponsored exchange programs. Since 1952, more than 2,800 Indonesians and 1,200 Americans have received Fulbright scholarships to study, teach, or pursue important research and professional projects. Nearly 40,000 Indonesians are members of the Young Southeast Asian Leaders Initiative (YSEALI) Network, the

largest number from any ASEAN country. Each year, US Mission Indonesia sends as many as 200 emerging Indonesian leaders to the US to participate in a broad range of youth exchange programs, and approximately 7,500 Indonesians undertake study in the US. Arizona's higher education institutions can play a vital role in fostering programs and student exchanges with Indonesia's academia sector and Ministry of Education to promote knowledge-sharing and willingness to cooperation in various socio-economic sectors.

The Indonesian government is currently working on various G2G/G2B projects and looking at investment for the development of Nusantara. The Capital City of Nusantara is the future capital of Indonesia, scheduled to be inaugurated on 17 August 2024, coinciding with Indonesian Independence Day, Nusantara will replace Jakarta as the national capital, a position the latter city has held since the country's independence in 1945. The site is situated on the east coast of the island of Borneo, specifically in the province of East Kalimantan. The city is expected to encompass an area of 990 square miles, surrounded by hilly landscapes, a forest, and a natural bay. The project is estimated to be worth \$35 billion and will be finished in five phases. Phase one began in August 2022. Around 150,000 to 200,000 workers from around Indonesia participated in this project with an additional workforce around the Nusantara region to ensure the participation of local workers. The project is expected to be fully finalized in 2045, with Phase five being the last. The National Development Planning Ministry estimated the relocation cost to be \$32.7 billion and that the government intended to cover 19% of the cost, the remainder coming mainly from public-private partnerships and direct investment by both state-owned enterprises and the private sector. At the same time, \$40 billion will be allocated to saving Jakarta from sinking in the next decade, which has also been widely reported as the fundamental underlying cause for the relocation of the capital.

Indonesian defense spending is expected to increase as well, from approximately \$8.8bn to \$9.7bn by 2028, according to a <u>GlobalData</u> forecast. Being one of the emerging defense spenders in South Asia, its GDP has grown to an average of 2.9% annually. Given this steady economic growth led by a stabilized government, national security has become a top priority for the world's largest archipelagic nation. For example, military fixed-wing aircraft is the biggest sector attracting the most funding, worth an estimated \$22.7bn between 2023 and 2028.

Indonesian Community in Arizona

According to a ZipAtlas statistic, there are currently over 3,000 Indonesians living in Arizona.

Furthermore, Arizona is home to the Indonesian Student Association at the UoA and is the organization initiated by Indonesian students that actively takes part and conducts events, both on and off campus. There were around 200 Indonesian students who have studied at UoA from the late 1990s to early 2000s. Some of them now are Indonesian families who live and work in Tucson. Now with a new generation and cohort of Indonesian students, there is a growth of prospective Indonesian students who plan to study at UoA.

Appendix E: Japan - Data and Information

Arizona-Japan Trade and FDI Profil

According to the ACA's Trade and FDI Profile 2023-08, there were over \$879 million of exports to Japan and \$1.43 billion of imports. The Arizona-Japan binational Terms of Trade (ToT) was 61.13%, ranking Japan 7th among Arizona's export markets. Arizona was ranked 2nd for metal ore exports to Japan and Japan was Arizona's second largest export market for pharmaceuticals and medicines. Arizona's leading export sources were aerospace products and parts (\$225 million) and navigational, measuring, electromedical and control instruments (\$117 million).

In 2022, Japan ranked 5th for Arizona in imports, with top import sources being industrial machinery (\$625 million), semiconductors and other electronic components (\$269 million) and basic chemicals (\$117 million).

Overall, between 2017 and 2022, exports have increased by 45.5% and imports by 34.1%, thus showing the growing trend for economic activity, trade and investment between Arizona and Japan. Prior to the beginning of the pandemic, Arizonan imports from Japan were valued at \$2.1 billion in 2019. However, since the pandemic, this number has been averaging annually \$1.4 billion.

Today, Arizona does not have a regional trade and FDI office in Japan. The Committee's Plan 24 envisions prioritizing Japan. According to Reuters and AP, Japan's Defense Ministry requested a \$53 billion defense spending boost for 2024, a 12% increase following the Prime Minister's adoption for a new strategy under the five-year plan, whereby Japan is planning to spend \$315 billion through 2027. This makes Japan the world's 3rd biggest spender after the United States and China. Moreover, the Japan External Trade Organization (JETRO) has been a key played in attracting potential Japanese startups and investors into the Arizona market, particularly in the semiconductor market as part of the effort to complement supply chains for TSCM's \$40 billion investment fab project in Phoenix.

Enhance Government Regulation Relations

On October 17-18, the Consulate General of Japan in Los Angeles joined the Japanese semiconductor delegation in Arizona, coordinated by JETRO Los Angeles. As Arizona is becoming a major hub to a well-established semiconductor ecosystem, JETRO Los Angeles invited Japanese companies that are keen to study possibilities of business expansion or investment in Arizona to participate in this event. 27 Japanese companies (37 delegates total) joined the mission to better understand the investment, business and living environment in the Greater Phoenix area. More information on this can be found on the webpage of the Consulate of Japan in Los Angeles.

The committee considers that part of G2G and G2B enhancement with Japan could focus on the semiconductor's silicon supply chain environment, whereby vendors and third-party manufacturers can be encouraged to set up shop in and around the main semiconductor giants such as TSCM, Intel or ON Semiconductor. Furthermore, engaging in investment and regulatory export/import discussions with Japanese counterparts and Arizona's local US Commercial Service's offices would facilitate exploring ways to facilitate flow of volume and FDI for a Korea-Japan town. This town would bring a resilient community specialized in the manufacturing sector and spur further growth in innovation and R&D parks. Moreover, it could potentially nurture talent attraction and retention for high-skilled labor.

Tourism and Japanese Community in Arizona

According to AOT's International Visitation to Arizona report, in 2019 there were 80,970 Japanese visitors in Arizona. This number steadily increased by 47.8% from 2015 to 2019 before a sharp decline due to the pandemic.

The Japanese community in Arizona is showcased at various activities and cultural sites. For example, the Japanese Friendship Garden is located in downtown Phoenix where citizens can learn about Japanese culture and history. Furthermore, the Arizona Matsuri is a two-day festival featuring the culture of Japan. The Arizona Matsuri is a non-profit organization, whose Steering Committee members are drawn from the Arizona Buddhist Temple, the Phoenix Himeji Sister City Committee, the Japanese American Citizens League, the Japanese Friendship Garden of Phoenix, the Japanese Business Association of Arizona, the Japanese Culture Club of Arizona and interested individuals. The Matsuri is the means for the Arizona Matsuri to fulfill its mission of introducing the arts and culture of Japan to Arizona. The next Japanese festival organized by Arizona Matsuri will take place on February 24-25, 2024.

With over \$122 million of exports to New Zealand (NZ) and \$23 million of imports in 2022, the Arizona-NZ binational ToT of 530.43% inputs important economic value to the state of Arizona. According to the ACA's Trade and FDI Profile 2023-10, NZ ranked 32nd among Arizona's export markets. Across US states, Arizona was 5th for aerospace products and parts exports to NZ (\$89m; top export in terms of value). The rise of exports in aerospace products and parts led to a 129.4% increase in exports to NZ from 2017 to 2022. Among other export sources to NZ were animal foods (\$3m) and miscellaneous manufactured commodities (\$3m).

NZ was Arizona's 3rd largest import source for nonmetallic minerals. Top import sources from NZ in 2022 were beverages (\$6.4m) and communications equipment (\$3.2m).

According to an <u>Economist Intelligence data profile</u>, NZ's economy will return to growth following a recession in early 2023. However, expansion will remain below its long-term average until 2024. Consumer price inflation will ease gradually in late 2023 as global commodity prices moderate. The Reserve Bank of NZ will maintain its policy rate at 5.5% until late 2024, when inflationary pressures are decisively suppressed.

Enhance Government Relations & Business Facilitation

According to NZ's Ministry of Foreign Affairs and Trade, NZ and the US as close strategic partners, established the New Zealand United States (NZUS) Council in 2001, with the aim to foster and develop a strong and mutually beneficial relationship. NZUS advocates for growing trade and

economic links between the two countries and works closely with its American equivalent, the United States New Zealand (USNZ) Council.

NZ is an active participant for socio-economic development across the Pacific region. For example, the World Bank indicated that the Papua New Guinea and the Pacific Islands Umbrella Facility (PPIUF) will be functioning until at least 2031 and will support World Bank projects across the Pacific through a commitment of \$73.6 million from the Australian Government and \$20.8 million from the NZ Government. These commitments are expected to grow to a combined estimated \$200 million by 2031 as projects evolve and expand.

Tourism and New Zealand Community in Arizona

Tourism and awareness of each nation's cultural and economic prospects can be promoted through higher education institutions. For example, according to NZ's Ministry of Foreign Affairs and Trade, New Zealanders over the age of 18 who are students or recent graduates can apply for a 12-month working holiday visa for the US. Moreover, UoA offers for example several programs in Australia and NZ, representing an opportunity to experience the Oceania region where students can study and explore another part of the world, and vice-versa. This generates economic activity for regions, favoring sectors such as the tourism and hospitality industries.

In 2022, the Consul General of NZ in Los Angeles visited Arizona to explore opportunities for discussion on fostering trade and economic collaboration between Arizona and NZ. Among common subjects for improving bilateral ties, the Consul General identified areas for socioeconomic cooperation between the indigenous communities of NZ and Arizona. NZ has a long history of independent Māori leadership and work on international indigenous issues and rights. The Treaty of Waitangi (or *Te Tiriti o Waitangi*) underscores NZ's international cooperation, requiring consultation, engagement and protection of Māori interests. As such, NZ's Ministry of Foreign Affairs and Trade has recently sought to integrate Māori worldviews and *mātanranga Māori* (Māori knowledge) into foreign policy and development cooperation (more on this in an OECD report). As a result of this policy, NZ is able to engage in cross-indigenous cooperation across various partner nations to promote more robust partnerships based on shared values and an equal footing, cultural heritage tourism strategies and indigenous economic inclusion. For instance, Canada and NZ signed the Indigenous Collaboration Arrangement.

The Committee assesses the possibility to adopt a similar approach that could be taken for the 17 federally recognized tribes within the borders of Arizona and five more in Arizona whose territory spans multiple states, making Arizona the 3rd largest Native American population of any US state.
