Representative Friese suggested changes by adding new language to the potential Committee recommendations.

The Committee discussed and offered comments for the recommendations mentioned above.

**Representative Griffin moved that the Joint Ad Hoc Committee on Legislative Oversight of Emergency Executive Powers recommend to the full legislature the consideration and adoption of legislation limiting the length of a state of emergency proclamation by the Governor without Legislative approval.**

**The motion CARRIED by voice vote.**
