### AN ACT

AMENDING SECTION 41-1231, ARIZONA REVISED STATUTES; AMENDING TITLE 41,  
CHAPTER 7, ARTICLE 8.1, ARIZONA REVISED STATUTES, BY ADDING SECTION  
41-1231.01; AMENDING SECTIONS 41-1232.02, 41-1232.03 AND 41-1239, ARIZONA  
REVISED STATUTES; RELATING TO REGULATION OF LOBBYISTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 41-1231, Arizona Revised Statutes, is amended to  
3 read:

4 41-1231. Definitions

5 In this article, unless the context otherwise requires:

6 1. "Authorized lobbyist" means any person, other than a designated  
7 lobbyist or lobbyist for compensation, who is employed by, retained by or  
8 representing a principal with or without compensation for the purpose of  
9 lobbying and who is listed as an authorized lobbyist by the principal in its  
10 registration pursuant to section 41-1232.

11 2. "Authorized public lobbyist" means a person, other than a  
12 designated public lobbyist, who is employed by, retained by or representing a  
13 public body, with or without compensation, for the purpose of lobbying and  
14 who is listed as an authorized public lobbyist by the public body in its  
15 registration pursuant to section 41-1232.01.

16 3. "Designated lobbyist" means the person who is designated by a  
17 principal as the single point of contact for the principal and who is listed  
18 as the designated lobbyist by the principal in its registration pursuant to  
19 section 41-1232.

20 4. "Designated public lobbyist" means the person who is designated by  
21 a public body as the single point of contact for the public body and who is  
22 listed as the designated public lobbyist by the public body in its  
23 registration pursuant to section 41-1232.01.

24 5. "EDUCATIONAL EVENT":

25 (a) MEANS THE AMOUNT OF ANY EXPENSE PAID OR INCURRED FOR ENTRANCE  
26 FEES, LODGING, FOOD AND BEVERAGE, TRAVEL AND OTHER EXPENSES FOR THE STATE  
27 OFFICER'S OR EMPLOYEE'S ATTENDANCE AT AN EVENT, COMMITTEE, MEETING,  
28 CONFERENCE OR SEMINAR, INCLUDING MEETINGS OF STATE, REGIONAL OR NATIONAL  
29 ORGANIZATIONS OR THEIR COMMITTEES CONCERNED WITH LEGISLATIVE OR GOVERNMENTAL  
30 ACTIVITIES, IF ATTENDANCE AT THE EVENT IS PRIMARILY FOR AN EDUCATIONAL  
31 PURPOSE IN CONNECTION WITH THE STATE OFFICER'S OR EMPLOYEE'S LEGISLATIVE OR  
32 OFFICIAL DUTIES.

33 (b) DOES NOT INCLUDE EXPENDITURES FOR ENTERTAINMENT UNLESS IT IS A  
34 SPECIAL EVENT.

35 ~~5-~~ 6. "Entertainment" means the amount of any expenditure paid or  
36 incurred for admission to any sporting or cultural event or for participation  
37 in any sporting or cultural activity.

38 ~~6-~~ 7. "Expenditure" means a payment, distribution, loan, advance,  
39 deposit or gift of money or anything of value and includes a contract,  
40 promise or agreement, whether or not legally enforceable, to make an  
41 expenditure that provides a benefit to an individual state officer or state  
42 employee and that is incurred by or on behalf of one or more principals,  
43 public bodies, lobbyists, designated public lobbyists or authorized public  
44 lobbyists.

1           ~~7.~~ 8. "Family gift" means a gift, ~~to a state officer or employee or a~~  
2 ~~member of the officer's or employee's household from a principal, lobbyist,~~  
3 ~~designated public lobbyist or authorized public lobbyist who is a relative of~~  
4 ~~the state officer or employee or a member of the household of the state~~  
5 ~~officer or employee if the donor is not acting as the agent or intermediary~~  
6 ~~for someone other than a person covered by this paragraph~~ DEVISE OR  
7 INHERITANCE FROM A STATE OFFICER'S OR EMPLOYEE'S SPOUSE, CHILD, PARENT,  
8 GRANDPARENT, GRANDCHILD, BROTHER, SISTER, PARENT-IN-LAW, BROTHER-IN-LAW,  
9 SISTER-IN-LAW, NEPHEW, NIECE, AUNT OR UNCLE OR THE SPOUSE OF THAT INDIVIDUAL  
10 OR A MEMBER OF THE HOUSEHOLD OF THE STATE OFFICER OR EMPLOYEE IF THE DONOR IS  
11 NOT ACTING AS THE AGENT OR INTERMEDIARY FOR A PERSON OTHER THAN A PERSON  
12 COVERED BY THIS PARAGRAPH.

13           ~~8.~~ 9. "Food ~~or~~ AND beverage" means the amount of any expenditure paid  
14 or incurred NOT TO EXCEED TWENTY-FIVE DOLLARS PER MEAL for food ~~or beverages~~  
15 AND BEVERAGE for a state officer or employee provided at a location at which  
16 the principal, public body, lobbyist, designated public lobbyist or  
17 authorized public lobbyist who made the expenditure is present BUT DOES NOT  
18 INCLUDE FOOD AND BEVERAGE PROVIDED AT AN EDUCATIONAL EVENT, SPEAKING  
19 ENGAGEMENT OR SPECIAL EVENT.

20           ~~9.~~ 10. "Gift" means a payment, distribution, expenditure, advance,  
21 deposit or donation of money, ENTERTAINMENT, any intangible personal property  
22 or any kind of tangible personal or real property. ~~For purposes of this~~  
23 ~~article gift does not include:~~

24           ~~(a) A gift, devise or inheritance from an individual's spouse, child,~~  
25 ~~parent, grandparent, grandchild, brother, sister, parent in law,~~  
26 ~~brother in law, sister in law, nephew, niece, aunt, uncle or first cousin or~~  
27 ~~the spouse of any such individual if the donor is not acting as the agent or~~  
28 ~~intermediary for someone other than a person covered by this subdivision.~~

2 ~~state officer or state employee to signify the honorary recognition of a~~  
3 ~~service or other notable accomplishment.~~

4 ~~(g) Informational material such as books, reports, pamphlets,~~

6 ~~(h) An item that is not used and that is returned within fifteen days~~  
7 ~~of receipt to the donor or that is delivered within fifteen days of receipt~~  
8 ~~to a charitable organization and that is not claimed as a charitable~~  
9 ~~contribution for state or federal income tax purposes.~~

10 ~~(i) A campaign contribution that is properly received and reported as~~  
11 ~~required by law.~~

12 ~~(j) An item that is given to a state officer or employee if the state~~  
13 ~~officer or employee gives an item of approximately the same value to the~~  
14 ~~giver of the item at the same time that the item is given or on a similar~~  
15 ~~occasion as the one that prompted the original item to be given.~~

16 ~~(k) Gifts of a personal nature that were customarily received by an~~  
17 ~~individual from the donor before the individual became a state officer or~~  
18 ~~employee.~~

19 ~~(l) An item that is given to the general public at an event.~~

20 ~~10.~~ 11. "Legislation" means bills, resolutions, memorials, amendments,  
21 nominations and other matters that are pending or proposed in either house of  
22 the legislature of this state ~~or for the purposes of bonding lobbying for any~~  
23 ~~matter pending or proposed before a school district governing board.~~

24 ~~11.~~ 12. "Lobbying" means attempting to influence the passage or defeat  
25 of any legislation by directly communicating with any legislator, ~~or in the~~  
26 ~~case of bonding, lobbyists directly communicating with any school district~~  
27 ~~employee or a school district governing board member~~ or attempting to  
28 influence any formal rule making proceeding pursuant to chapter 6 of this  
29 title or rule making proceedings that are exempt from chapter 6 of this title  
30 by directly communicating with any state officer or employee. Lobbying does  
31 not include:

32 (a) Interagency communications between state agency employees.

33 (b) Communications between a public official or employee of a public  
34 body, designated public lobbyist or authorized public lobbyist and any state  
35 officer, except for a member of the legislature, or an employee of the  
36 legislature.

37 (c) Oral questions or comments made by a person to a state officer or  
38 employee regarding a proposed rule and made in public at a meeting or  
39 workshop that is open to the public and that is sponsored by a state agency,  
40 board, commission, council or office.

41 ~~12.~~ 13. "Lobbyist" means any person, other than a designated public  
42 lobbyist or authorized public lobbyist, who is employed by, retained by or  
43 representing a person other than himself, with or without compensation, for  
44 the purpose of lobbying and who is listed as a lobbyist by the principal in  
45 its registration pursuant to section 41-1232. Lobbyist includes a lobbyist

1 for compensation, designated lobbyist and authorized lobbyist. ~~Lobbyist~~  
2 ~~includes attorneys whose practice involves bonding, underwriters of bonds and~~  
3 ~~investment bankers whose business includes bonding.~~

4 ~~13.~~ 14. "Lobbyist for compensation" means a lobbyist who is  
5 compensated for the primary purpose of lobbying on behalf of a principal and  
6 who is listed by the principal in its registration pursuant to section  
7 41-1232.

8 15. "NONRECREATIONAL TRAVEL AND LODGING" MEANS THE AMOUNT OF ANY  
9 EXPENDITURE PAID OR INCURRED FOR TRAVEL OR LODGING, OR BOTH, RELATED TO A  
10 FACT-FINDING OR EDUCATIONAL TRIP MADE IN CONNECTION WITH THE LEGISLATIVE OR  
11 OFFICIAL DUTIES OF THE STATE OFFICER OR EMPLOYEE AND NOT PRIMARILY FOR A  
12 RECREATIONAL PURPOSE.

13 ~~14.~~ 16. "Person" means an individual, partnership, committee,  
14 association or corporation and any other organization or group of persons,  
15 except legislators and political parties qualified for representation on the  
16 ballot pursuant to section 16-801 or 16-804.

17 ~~15.~~ 17. "Personal hospitality" means hospitality, meals, beverages,  
18 transportation or lodging furnished but not commercially provided by a person  
19 on property or facilities owned or possessed by the person or the person's  
20 family.

21 ~~16.~~ 18. "Principal" means any person, other than a public body, that  
22 employs, retains, engages or uses, with or without compensation, a lobbyist.  
23 Principal includes any subsidiary of a corporation.

24 ~~17.~~ 19. "Public body" means the Arizona board of regents, a university  
25 under the jurisdiction of the Arizona board of regents, the judicial  
26 department, any state agency, board, commission or council, any county, any  
27 county elected officer who elects to appoint a designated public lobbyist or  
28 any city, town, district or other political subdivision of this state that  
29 receives and ~~utilizes~~ USES tax revenues and that employs, retains, engages or  
30 uses, with or without compensation, a designated public lobbyist or  
31 authorized public lobbyist.

32 ~~18.~~ 20. "Public official" means a person who is duly elected,  
33 appointed or retained through election to an elected state, county or local  
34 office.

35 ~~19.~~ 21. "Single expenditure" means an expenditure that provides a  
36 benefit of more than twenty dollars to an individual state officer or state  
37 employee and that is incurred JOINTLY OR INDIVIDUALLY by or on behalf of one  
38 or more principals, public bodies, lobbyists, designated public lobbyists or  
39 authorized public lobbyists.

40 ~~20.~~ 22. "Speaking engagement":

41 (a) Means the amount of any expense paid or incurred for entrance fees,  
42 lodging, food and beverage, entertainment, travel and other expenses for the  
43 state officer's or employee's attendance at an event, committee, meeting,  
44 conference or seminar, including meetings of state, regional or national  
45 organizations or their committees concerned with legislative or governmental

1 activities if the state officer or employee participates in the event as a  
2 speaker or panel participant by presenting information relating to the state  
3 officer's or employee's legislative or official duties or by performing a  
4 ceremonial function appropriate to the state officer's or employee's  
5 position.

6 (b) Does not include expenditures for an honorarium or any other  
7 similar fee paid to a speaker.

8 ~~21.~~ 23. "State employee" means an employee of the legislature, a  
9 university under the jurisdiction of the Arizona board of regents, the  
10 judicial department or a state office, agency, board, commission or council.

11 ~~22.~~ 24. "State officer" means a person who is duly elected, appointed  
12 or retained through election to any state office, or a member of any state  
13 board, commission or council, and includes a member of the legislature.

14 Sec. 2. Title 41, chapter 7, article 8.1, Arizona Revised Statutes, is  
15 amended by adding section 41-1231.01, to read:

16 41-1231.01. Gift ban; principals and lobbyists; exemptions

17 A. A PRINCIPAL OR LOBBYIST OR ANY OTHER PERSON ACTING ON BEHALF OF A  
18 PRINCIPAL OR LOBBYIST SHALL NOT GIVE A GIFT TO ANY STATE OFFICER OR STATE  
19 EMPLOYEE AND A STATE OFFICER OR STATE EMPLOYEE SHALL NOT ACCEPT A GIFT FROM A  
20 PRINCIPAL OR LOBBYIST.

21 B. A PUBLIC BODY, DESIGNATED PUBLIC LOBBYIST OR AUTHORIZED PUBLIC  
22 LOBBYIST OR ANY OTHER PERSON ACTING ON BEHALF OF A PUBLIC BODY, DESIGNATED  
23 PUBLIC LOBBYIST OR AUTHORIZED PUBLIC LOBBYIST SHALL NOT GIVE A GIFT TO ANY  
24 MEMBER OR EMPLOYEE OF THE LEGISLATURE AND A MEMBER OR EMPLOYEE OF THE  
25 LEGISLATURE SHALL NOT ACCEPT A GIFT FROM A PUBLIC BODY, DESIGNATED PUBLIC  
26 LOBBYIST OR AUTHORIZED PUBLIC LOBBYIST OR ANY OTHER PERSON ACTING ON THEIR  
27 BEHALF. THIS SUBSECTION DOES NOT APPLY TO GIFTS GIVEN BY A PUBLIC BODY,  
28 DESIGNATED PUBLIC LOBBYIST OR AUTHORIZED PUBLIC LOBBYIST TO AN EMPLOYEE OF A  
29 PUBLIC BODY, IF THE EMPLOYEE IS NOT A PUBLIC OFFICIAL OR A MEMBER OF THE  
30 HOUSEHOLD OF A PUBLIC OFFICIAL OR IF THE GIFT IS ACCEPTED ON BEHALF OF THE  
31 PUBLIC BODY AND REMAINS THE PROPERTY OF THE PUBLIC BODY.

32 C. FOR THE PURPOSES OF THIS ARTICLE, A GIFT DOES NOT INCLUDE ANY OF  
33 THE FOLLOWING:

34 1. SALARY, COMPENSATION OR EMPLOYER REIMBURSED EXPENSES LAWFULLY PAID  
35 TO A STATE OFFICER OR EMPLOYEE.

36 2. A FAMILY GIFT.

37 3. AN AWARD OR PRIZE THAT IS GIVEN TO COMPETITORS IN A CONTEST OR  
38 EVENT THAT IS OPEN TO THE PUBLIC, INCLUDING A RANDOM DRAWING.

39 4. A CAMPAIGN CONTRIBUTION THAT IS PROPERLY RECEIVED AND REPORTED BY  
40 THE STATE OFFICER AS REQUIRED BY LAW.

41 5. ANY DISCOUNT OR OTHER BENEFIT THAT IS OFFERED TO A STATE OFFICER OR  
42 EMPLOYEE ON THE SAME CONDITIONS AS OFFERED TO THE PUBLIC, TO A CLASS  
43 CONSISTING OF ALL STATE OFFICERS AND EMPLOYEES OR TO A GROUP OR CLASS IN  
44 WHICH MEMBERSHIP IS UNRELATED TO BEING A STATE OFFICER OR EMPLOYEE.

45 6. AN EDUCATIONAL EVENT OR SPEAKING ENGAGEMENT.

1           7. EXPENSES RELATING TO A SPECIAL EVENT OR FUNCTION TO WHICH ALL  
2 MEMBERS OF THE LEGISLATURE, EITHER HOUSE OF THE LEGISLATURE OR ANY COMMITTEE  
3 OF THE LEGISLATURE ARE INVITED AND THAT ARE PROPERLY REPORTED AS PRESCRIBED  
4 IN SECTION 41-1232.02, SUBSECTION F OR SECTION 41-1232.03, SUBSECTION F.

5           8. FLOWERS.

6           9. FOOD AND BEVERAGE.

7           10. INFORMATIONAL MATERIAL, INCLUDING A BOOK, CALENDAR, PAMPHLET,  
8 PERIODICAL, REPORT OR VIDEOTAPE.

9           11. AN ITEM THAT IS NOT USED AND THAT IS RETURNED WITHIN FIFTEEN DAYS  
10 OF RECEIPT TO THE DONOR OR THAT IS DELIVERED WITHIN FIFTEEN DAYS OF RECEIPT  
11 TO A CHARITABLE ORGANIZATION AND THAT IS NOT CLAIMED AS A CHARITABLE  
12 CONTRIBUTION FOR STATE OR FEDERAL INCOME TAX PURPOSES.

13           12. AN ITEM THAT IS GIVEN TO A STATE OFFICER OR EMPLOYEE IF THE STATE  
14 OFFICER OR EMPLOYEE GIVES AN ITEM OF APPROXIMATELY THE SAME VALUE TO THE  
15 GIVER OF THE ITEM AT THE SAME TIME THAT THE ITEM IS GIVEN OR ON A SIMILAR  
16 OCCASION AS THE ONE THAT PROMPTED THE ORIGINAL ITEM TO BE GIVEN.

17           13. AN ITEM OF A PERSONAL NATURE THAT WAS CUSTOMARILY RECEIVED BY AN  
18 INDIVIDUAL FROM THE DONOR BEFORE THE INDIVIDUAL BECAME A STATE OFFICER OR  
19 EMPLOYEE.

20           14. AN ITEM THAT IS GIVEN TO THE GENERAL PUBLIC AT AN EVENT.

21           15. AN ITEM OF NOMINAL VALUE SUCH AS A GREETING CARD, BASEBALL CAP,  
22 T-SHIRT, MUG OR PEN.

23           16. NONRECREATIONAL TRAVEL OR LODGING, OR BOTH.

24           17. PERSONAL HOSPITALITY.

25           18. A PLAQUE OR OTHER FORM OF RECOGNITION SIMILAR TO A PLAQUE GIVEN TO  
26 A STATE OFFICER OR STATE EMPLOYEE TO SIGNIFY THE HONORARY RECOGNITION OF A  
27 SERVICE OR OTHER NOTABLE ACCOMPLISHMENT.

28           19. PROFESSIONAL OR CONSULTING SERVICES THAT ARE RENDERED ON MATTERS  
29 DIRECTLY RELATED TO HOLDING PUBLIC OFFICE, BEING A CANDIDATE FOR PUBLIC  
30 OFFICE OR BEING A STATE EMPLOYEE AND THAT ARE NOT RENDERED TO OBTAIN A  
31 BENEFIT FOR ANY REGISTERED PRINCIPAL, PUBLIC BODY, LOBBYIST, DESIGNATED  
32 PUBLIC LOBBYIST OR AUTHORIZED PUBLIC LOBBYIST OR THE CLIENTS OF A PRINCIPAL  
33 OR LOBBYIST.

34           Sec. 3. Section 41-1232.02, Arizona Revised Statutes, is amended to  
35 read:

36           41-1232.02. Expenditure reporting; principals and lobbyists;  
37 gifts

38           A. Each principal shall report annually all single expenditures,  
39 whether or not the expenditures were made in the course of lobbying. These  
40 single expenditures shall be itemized separately, and each itemization shall  
41 include the date of the expenditure, the amount of the expenditure, the name  
42 of each state officer or employee receiving or benefitting from the  
43 expenditure, the category of the expenditure and the name of the lobbyist or  
44 other person who made the expenditure on behalf of the principal. In  
45 addition each principal shall report annually the aggregate of all

1 expenditures of twenty dollars or less received by or benefitting a state  
2 officer or employee, whether or not the expenditures were made in the course  
3 of lobbying. The report shall be filed by March 1 and shall list the annual  
4 expenditures made on behalf of the principal. If March 1 is a Saturday,  
5 Sunday or other legal holiday, the report shall be filed on the next business  
6 day.

7 B. Each lobbyist for compensation and designated lobbyist shall report  
8 quarterly all single expenditures incurred in the preceding calendar quarter  
9 by the lobbyist for compensation or designated lobbyist, whether or not the  
10 single expenditures were made in the course of lobbying. These single  
11 expenditures shall be itemized separately, and each itemization shall include  
12 the date of the expenditure, the amount of the expenditure, the name of the  
13 state officer or employee receiving or benefitting from the expenditure, the  
14 category of the expenditure and the principal on whose behalf the expenditure  
15 was made. If the expenditure was made by the lobbyist and was not made on  
16 behalf of a principal, it shall be itemized separately. The quarterly report  
17 shall be filed no later than the last day of the month following the end of  
18 the calendar quarter, unless the last day of the month is a Saturday, Sunday  
19 or other legal holiday. In that case, the report shall be filed on the next  
20 business day.

21 C. Each lobbyist for compensation and designated lobbyist shall also  
22 report quarterly the aggregate of all expenditures of twenty dollars or less  
23 received by or benefitting a state officer or employee, whether or not the  
24 expenditures were made in the course of lobbying. The report shall list  
25 separately the aggregate of expenditures made on behalf of each principal and  
26 the aggregate not made on behalf of any principal. In the fourth calendar  
27 quarter, these expenditures shall also be listed by cumulative total for the  
28 calendar year. Each quarterly lobbyist report shall include all reportable  
29 expenditures made by any employee of the lobbyist for compensation or  
30 designated lobbyist, regardless of whether that employee is listed as a  
31 lobbyist on any registration filed by a principal engaging the lobbyist. The  
32 quarterly report shall be filed no later than the last day of the month  
33 following the end of the calendar quarter, unless the last day of the month  
34 is a Saturday, Sunday or other legal holiday. In that case, the report shall  
35 be filed the next business day.

36 D. The reports required by subsections A and B of this section shall  
37 identify each single expenditure according to the following categories:

- 38 1. Food ~~or beverages~~ AND BEVERAGE.
- 39 2. AN EDUCATIONAL EVENT OR A speaking engagement.
- 40 3. NONRECREATIONAL travel and lodging.
- 41 4. Flowers.

42 ~~5. Other expenditures.~~

43 E. Expenditures by principals and lobbyists, ~~such as~~ INCLUDING those  
44 for the lobbyist's personal sustenance, office expenses, filing fees, legal  
45 fees, employees' compensation, lodging and travel, are not required to be



1 reported. In addition, expenditures by a principal or a lobbyist for family  
2 gifts, personal hospitality or those items excluded from the definition of  
3 gift pursuant to section ~~41-1231, paragraph 9, subdivision (a), (c), (d),~~  
4 ~~(f), (g), (h), (i), (j), (k) or (l)~~ 41-1231.01, SUBSECTION C, PARAGRAPHS 1  
5 THROUGH 5, 10 THROUGH 15, 17 AND 19 are not required to be reported.

6 F. All expenditures incurred by a principal or lobbyist in the case of
