HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2028

(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Arizona board of regents; support and maintenance;  
3 supplemental appropriation reduction; transfer;  
4 appropriation

5 A. In addition to the reductions made pursuant to Laws 2009, first  
6 special session, chapter 1, section 3, the sum of \$100,000,000 is reduced  
7 from the appropriation made from the state general fund in fiscal year  
8 2008-2009 to the Arizona board of regents for the support and maintenance of  
9 institutions under its jurisdiction and is transferred to the state general  
10 fund. The Arizona board of regents shall reduce funding to the institutions  
11 under its jurisdiction in proportion to the state general fund appropriation  
12 received by each institution.

13 B. In addition to any other amounts appropriated to the Arizona board  
14 of regents for fiscal year 2009-2010, the sum of \$100,000,000 is appropriated  
15 from the state general fund in fiscal year 2009-2010 to the Arizona board of  
16 regents to be distributed for the support and maintenance of institutions  
17 under its jurisdiction in two equal payments on or before August 1, 2009 and  
18 September 1, 2009. The Arizona board of regents shall distribute the monies  
19 appropriated in this subsection to the institutions under its jurisdiction in  
20 an amount equal to the reduction made pursuant to subsection A of this  
21 section.

22 Sec. 2. Department of education; school districts; state aid  
23 apportionment; supplemental appropriation reduction;  
24 transfer; fiscal year 2008-2009

25 Notwithstanding any other law, the sum of \$300,000,000 is reduced from  
26 appropriations made from the state general fund in fiscal year 2008-2009 to  
27 the department of education and the superintendent of public instruction for  
28 basic state aid and additional state aid to school districts and is  
29 transferred to the state general fund. The appropriation reduction required

1 by this section does not apply to charter schools or to school districts that  
2 qualify for an exemption from the general budget limit either for pupils in  
3 kindergarten programs and grades one through eight or for pupils in grades  
4 nine through twelve, or both, pursuant to section 15-949, Arizona Revised  
5 Statutes.

6 Sec. 3. Department of education; federal education stabilization  
7 fund; supplemental appropriation reduction; transfer;  
8 legislative intent; fiscal year 2008-2009

9 A. Notwithstanding any other law, if this state receives federal  
10 assistance from the federal education stabilization fund, the sum of  
11 \$250,000,000 is reduced from appropriations made from the state general fund  
12 in fiscal year 2008-2009 to the department of education and is transferred to  
13 the state general fund.

14 B. It is the intent of the legislature that in fiscal year 2008-2009,  
15 \$250,000,000 will be disbursed from the federal education stabilization fund  
16 to the department of education in order to restore the funding reduction made  
17 in subsection A. These monies shall be disbursed in accordance with the  
18 provisions of the American recovery and reinvestment act of 2009."
