SENATE AMENDMENTS TO S.B. 1205

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 15, chapter 1, article 1, Arizona Revised Statutes,
3 is amended by adding section 15-108, to read:

4 15-108. Public classrooms; federal standards for media
5 broadcasts concerning obscenity, indecency and
6 profanity; violations; definition

7 A. IF A PERSON WHO PROVIDES CLASSROOM INSTRUCTION IN A PUBLIC SCHOOL
8 ENGAGES IN SPEECH OR CONDUCT IN A CLASSROOM SETTING THAT WOULD VIOLATE THE
9 STANDARDS ADOPTED BY THE FEDERAL COMMUNICATIONS COMMISSION CONCERNING
10 OBSCENITY, INDECENCY AND PROFANITY IF THAT SPEECH OR CONDUCT WERE BROADCAST
11 ON TELEVISION OR RADIO:

12 1. FOR THE FIRST OR SECOND OCCURRENCE, THE SCHOOL, AT A MINIMUM, SHALL
13 ISSUE A WARNING TO THE PERSON. THIS PARAGRAPH DOES NOT PROHIBIT A SCHOOL
14 AFTER THE FIRST OCCURRENCE FROM SUSPENDING OR TERMINATING THE EMPLOYMENT OF
15 THAT PERSON.

16 2. FOR THE THIRD OCCURRENCE, THE SCHOOL SHALL SUSPEND THE PERSON, AT A
17 MINIMUM, FOR ONE WEEK OF EMPLOYMENT, AND THE PERSON SHALL NOT RECEIVE ANY
18 COMPENSATION FOR THE DURATION OF THE SUSPENSION. THIS PARAGRAPH DOES NOT
19 PROHIBIT A SCHOOL AFTER THE SECOND OCCURRENCE FROM SUSPENDING THE PERSON FOR
20 A LONGER DURATION OR TERMINATING THE EMPLOYMENT OF THAT PERSON.

21 3. FOR THE FOURTH OCCURRENCE, THE SCHOOL SHALL SUSPEND THE PERSON, AT
22 A MINIMUM, FOR TWO WEEKS OF EMPLOYMENT, AND THE PERSON SHALL NOT RECEIVE ANY
23 COMPENSATION FOR THE DURATION OF THE SUSPENSION. THIS PARAGRAPH DOES NOT
24 PROHIBIT A SCHOOL AFTER THE THIRD OCCURRENCE FROM SUSPENDING THE PERSON FOR A
25 LONGER DURATION OR TERMINATING THE EMPLOYMENT OF THAT PERSON.

1 4. FOR THE FIFTH OCCURRENCE, THE SCHOOL SHALL TERMINATE THE EMPLOYMENT
2 OF THE PERSON. THIS PARAGRAPH DOES NOT PROHIBIT A SCHOOL AFTER THE FIRST,
3 SECOND, THIRD OR FOURTH OCCURRENCE FROM TERMINATING THE EMPLOYMENT OF THAT
4 PERSON.

5 B. FOR THE PURPOSES OF THIS SECTION, "PUBLIC SCHOOL" MEANS A PUBLIC
6 PRESCHOOL PROGRAM, A PUBLIC ELEMENTARY SCHOOL, A PUBLIC JUNIOR HIGH SCHOOL, A
7 PUBLIC MIDDLE SCHOOL OR A PUBLIC HIGH SCHOOL IN THIS STATE."
