

PROPOSED AMENDMENT  
SENATE AMENDMENTS TO S.B. 1205  
(Reference to printed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 15, chapter 1, article 1, Arizona Revised Statutes,  
3 is amended by adding section 15-108, to read:

4 15-108. Public classrooms; federal standards for media  
5 broadcasts concerning obscenity, indecency and  
6 profanity; violations; definition

7 A. IF A PERSON WHO PROVIDES CLASSROOM INSTRUCTION IN A PUBLIC SCHOOL  
8 ENGAGES IN SPEECH OR CONDUCT THAT WOULD VIOLATE THE STANDARDS ADOPTED BY THE  
9 FEDERAL COMMUNICATIONS COMMISSION CONCERNING OBSCENITY, INDECENCY AND  
10 PROFANITY IF THAT SPEECH OR CONDUCT WERE BROADCAST ON TELEVISION OR RADIO:

11 1. FOR THE FIRST OCCURRENCE, THE SCHOOL, AT A MINIMUM, SHALL ISSUE A  
12 WARNING TO THE PERSON. THIS PARAGRAPH DOES NOT PROHIBIT A SCHOOL AFTER THE  
13 FIRST OCCURRENCE FROM SUSPENDING OR TERMINATING THE EMPLOYMENT OF THAT  
14 PERSON.

15 2. FOR THE SECOND OCCURRENCE, THE SCHOOL SHALL SUSPEND THE PERSON, AT  
16 A MINIMUM, FOR ONE WEEK OF EMPLOYMENT, AND THE PERSON SHALL NOT RECEIVE ANY  
17 COMPENSATION FOR THE DURATION OF THE SUSPENSION. THIS PARAGRAPH DOES NOT  
18 PROHIBIT A SCHOOL AFTER THE SECOND OCCURRENCE FROM SUSPENDING THE PERSON FOR  
19 A LONGER DURATION OR TERMINATING THE EMPLOYMENT OF THAT PERSON.

20 3. FOR THE THIRD OCCURRENCE, THE SCHOOL SHALL SUSPEND THE PERSON, AT A  
21 MINIMUM, FOR TWO WEEKS OF EMPLOYMENT, AND THE PERSON SHALL NOT RECEIVE ANY  
22 COMPENSATION FOR THE DURATION OF THE SUSPENSION. THIS PARAGRAPH DOES NOT  
23 PROHIBIT A SCHOOL AFTER THE THIRD OCCURRENCE FROM SUSPENDING THE PERSON FOR A  
24 LONGER DURATION OR TERMINATING THE EMPLOYMENT OF THAT PERSON.

25 4. FOR THE FOURTH OCCURRENCE, THE SCHOOL SHALL TERMINATE THE  
26 EMPLOYMENT OF THE PERSON. THIS PARAGRAPH DOES NOT PROHIBIT A SCHOOL AFTER

1 THE FIRST, SECOND OR THIRD OCCURRENCE FROM TERMINATING THE EMPLOYMENT OF THAT  
2 PERSON.

3 B. FOR THE PURPOSES OF THIS SECTION, "PUBLIC SCHOOL" MEANS A PUBLIC  
4 PRESCHOOL PROGRAM, A PUBLIC ELEMENTARY SCHOOL, A PUBLIC JUNIOR HIGH SCHOOL, A  
5 PUBLIC MIDDLE SCHOOL OR A PUBLIC HIGH SCHOOL IN THIS STATE."
