HOUSE OF REPRESENTATIVES AMENDMENTS TO S.B. 1432

(Reference to Senate engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 13-2904, Arizona Revised Statutes, is amended to
3 read:

4 **13-2904. *Disorderly conduct; classification***

5 A. A person commits disorderly conduct if, with intent to disturb the
6 peace or quiet of a neighborhood, family or person, or with knowledge of
7 doing so, such person:

- 8 1. Engages in fighting, violent or seriously disruptive behavior; or
9 2. Makes unreasonable noise; or

10 3. Uses abusive or offensive language or gestures to any person
11 present in a manner likely to provoke immediate physical retaliation by such
12 person; or

13 4. Makes any protracted commotion, utterance or display with the
14 intent to prevent the transaction of the business of a lawful meeting,
15 gathering or procession; or

16 5. Refuses to obey a lawful order to disperse issued to maintain
17 public safety in dangerous proximity to a fire, a hazard or any other
18 emergency; or

19 6. Recklessly handles, displays or discharges a deadly weapon or
20 dangerous instrument.

21 B. A PERSON COMMITS DISORDERLY CONDUCT IF THE PERSON INTENTIONALLY
22 ENTERS A PUBLIC RESTROOM, BATHROOM, SHOWER, BATH, DRESSING ROOM OR LOCKER
23 ROOM AND A SIGN INDICATES THAT THE ROOM IS FOR THE EXCLUSIVE USE OF PERSONS
24 OF ONE SEX AND THE PERSON IS NOT LEGALLY CLASSIFIED ON THE PERSON'S BIRTH
25 CERTIFICATE AS A MEMBER OF THAT SEX.

26 C. SUBSECTION B OF THIS SECTION DOES NOT APPLY TO A PERSON WHO ENTERS
27 A PUBLIC RESTROOM, BATHROOM, SHOWER, BATH, DRESSING ROOM OR LOCKER ROOM AND

1 WHO IS OF A DIFFERENT SEX THAN THAT INDICATED ON THE SIGN IF THE PERSON IS
2 ANY OF THE FOLLOWING:

- 3 1. ENTERING AS PART OF THE PERSON'S JOB RESPONSIBILITIES.
4 2. ENTERING TO GIVE AID OR ASSISTANCE TO ANOTHER PERSON.
5 3. A CHILD WHO NEEDS ASSISTANCE.
6 4. PHYSICALLY DISABLED.

7 B. D. Disorderly conduct under subsection A, paragraph 6 is a class 6
8 felony. Disorderly conduct under subsection A, paragraph 1, 2, 3, 4 or 5 **OR**
9 **SUBSECTION B** is a class 1 misdemeanor.

10 Sec. 2. Emergency

11 This act is an emergency measure that is necessary to preserve the
12 public peace, health or safety and is operative immediately as provided by
13 law."
