1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 11-138, Arizona Revised Statutes, is amended to
3 read:

4 11-138. Report by political action committees
5 ~~Campaign committees~~ A POLITICAL ACTION COMMITTEE, as defined in section
6 16-901, promoting or opposing the formation of new counties under this
7 article shall register with and report to the secretary of state and
8 otherwise comply with the requirements of title 16, chapter 6 regarding the
9 election under section 11-137.

10 Sec. 2. Section 13-3302, Arizona Revised Statutes, is amended to read:

11 13-3302. Exclusions

12 A. The following conduct is not unlawful under this chapter:

- 13 1. Amusement gambling.
14 2. Social gambling.
15 3. Regulated gambling if the gambling is conducted in accordance with
16 the statutes, rules or orders governing the gambling.
17 4. Gambling that is conducted at state, county or district fairs and
18 that complies with section 13-3301, paragraph 1, subdivision (d).

19 B. An organization that has qualified for an exemption from taxation
20 of income under section 43-1201, subsection A, paragraph 1, 2, 4, 5, 6, 7, 10
21 or 11 may conduct a raffle that is subject to the following restrictions:

22 1. The nonprofit organization shall maintain this status and no
23 member, director, officer, employee or agent of the nonprofit organization
24 may receive any direct or indirect pecuniary benefit other than being able to
25 participate in the raffle on a basis equal to all other participants.

26 2. The nonprofit organization has been in existence continuously in
27 this state for a five year period immediately before conducting the raffle.

28 3. No person except a bona fide local member of the sponsoring
29 organization may participate directly or indirectly in the management, sales
30 or operation of the raffle.

31 4. Nothing in paragraph 1 or 3 of this subsection prohibits:

32 (a) A licensed general hospital, a licensed special hospital or a
33 foundation established to support cardiovascular medical research that is
34 exempt from taxation of income under section 43-1201, subsection A, paragraph
35 4 or section 501(c)(3) of the internal revenue code from contracting with an
36 outside agent who participates in the management, sales or operation of the
37 raffle if the proceeds of the raffle are used to fund medical research,
38 graduate medical education or indigent care and the raffles are conducted no
39 more than three times per calendar year. The maximum fee for an outside
40 agent shall not exceed fifteen percent of the net proceeds of the raffle.

41 (b) An entity that is exempt from taxation of income under section
42 43-1201, subsection A, paragraph 4 or section 501(c)(3) of the internal
43 revenue code and that has at least a twenty-year history of providing
44 comprehensive services to prevent child abuse and to provide services and
45 advocacy for victims of child abuse from contracting with an outside agent

1 who participates in the management, sales or operation of the raffle if the
2 proceeds of the raffle are used to provide comprehensive services to prevent
3 child abuse and to provide services and advocacy for victims of child abuse
4 and the raffles are conducted no more than three times per calendar year.
5 The maximum fee for an outside agent shall not exceed fifteen percent of the
6 net proceeds of the raffle.

7 C. A state, county or local historical society designated by this
8 state or a county, city or town to conduct a raffle may conduct the raffle
9 subject to the following conditions:

10 1. No member, director, officer, employee or agent of the historical
11 society may receive any direct or indirect pecuniary benefit other than being
12 able to participate in the raffle on a basis equal to all other participants.

13 2. The historical society must have been in existence continuously in
14 this state for a five year period immediately before conducting the raffle.

15 3. No person except a bona fide local member of the sponsoring
16 historical society may participate directly or indirectly in the management,
17 sales or operation of the raffle.

18 D. A nonprofit organization that is a booster club, a civic club or a
19 political club or political organization ~~as defined in section 16-901~~ THAT IS
20 FORMALY AFFILIATED WITH AND RECOGNIZED BY A POLITICAL PARTY IN THIS STATE
21 may conduct a raffle that is subject to the following restrictions:

22 1. No member, director, officer, employee or agent of the club or
23 organization may receive any direct or indirect pecuniary benefit other than
24 being able to participate in the raffle on a basis equal to all other
25 participants.

26 2. No person except a bona fide local member of the sponsoring club or
27 organization may participate directly or indirectly in the management, sales
28 or operation of the raffle.

29 3. The maximum annual benefit that the club or organization receives
30 for all raffles is ten thousand dollars.

31 4. The club or organization is organized and operated exclusively for
32 pleasure, recreation or other nonprofit purposes and no part of the club's or
33 organization's net earnings inures to the personal benefit of any member,
34 director, officer, employee or agent of the club or organization.

35 Sec. 3. Section 15-424, Arizona Revised Statutes, is amended to read:
36 15-424. Election of governing board members; terms; statement
37 of contributions and expenditures

38 A. A regular election shall be held for each school district at the
39 time and place, and in the manner, of general elections as provided in
40 title 16.

41 B. Except as provided in subsection C of this section and sections
42 15-429 and 15-430, the term of office for each member shall be four years
43 from January 1 next following the member's election.

44 C. At the first general election held for a newly formed district,
45 three members shall be elected. The candidate receiving the highest number

1 of votes shall be elected to a four year term, and the candidates having the
2 second and third highest number of votes shall be elected to two year terms.
3 A district increasing its governing board to five members shall elect at the
4 next general election members in the following manner:

5 1. If one of the previous three offices is to be filled, the three
6 candidates receiving the highest, the second highest and the third highest
7 number of votes shall be elected to four year terms.

8 2. If two of the previous three offices are to be filled, the
9 candidates receiving the highest, the second highest and the third highest
10 number of votes shall be elected to four year terms. The candidate receiving
11 the fourth highest number of votes shall be elected to a two year term.
12 Thereafter all such offices shall have four year terms.

13 D. If only one person files ~~or no person files~~ a nominating petition
14 or nomination paper for a write-in candidate for an election to fill a
15 district office, the board of supervisors no earlier than seventy-five days
16 before the election may cancel the election for the position and appoint the
17 person who filed the nominating petition or nomination paper to fill the
18 position. If no person files a nominating petition or nomination paper for
19 an election to fill a district office, the board of supervisors no earlier
20 than seventy-five days before the election may cancel the election for that
21 office and that office is deemed vacant and shall be filled as provided in
22 section 15-302. A person who is appointed pursuant to this subsection is
23 fully vested with the powers and duties of the office as if elected to that
24 office.

25 E. If two or more candidates receive an equal number of votes for the
26 same office, and a higher number than any other candidate for that office,
27 whether upon the tally by the school election board or canvass of returns by
28 the board of supervisors, or upon recount by a court, the officer or board
29 whose duty it is to declare the result shall determine by lot and in the
30 presence of the candidates which candidate shall be declared elected.

31 F. Position of the names of candidates for each office shall be
32 rotated so that each candidate occupies each position on the ballot an equal
33 number of times, insofar as is possible, for each ballot style. For
34 candidates seeking election to fill a vacancy on the governing board, the
35 ballot shall be designated as provided in section 16-502.

36 G. This section does not require that a school election at which no
37 member is to be elected be held on a general election day.

38 H. All candidates for the office of school district governing board
39 member shall file with the county school superintendent a statement of
40 contributions and expenditures as provided in section ~~16-913~~ 16-926.

1 Sec. 4. Section 15-1442, Arizona Revised Statutes, is amended to read:

2 15-1442. Nominating petitions; election; returns; results;
3 certificate of election; statement of contributions
4 and expenditures

5 A. Candidates for the district board must file nominating petitions,
6 conforming to section 16-314, with the appropriate county officer.

7 B. Members of the district board shall be elected at the time and
8 place, and in the manner, of general elections as provided in title 16.

9 C. If only one person files ~~or no person files~~ a nominating petition
10 or nomination paper for a write-in candidate for an election to fill a
11 community college board office, the county school superintendent no earlier
12 than seventy-five days before the election may cancel the election for the
13 position and appoint the person who filed the nominating petition or
14 nomination paper to fill the position. If no person files a nominating
15 petition or nomination paper **FOR A CANDIDATE OR FOR A WRITE-IN CANDIDATE** for
16 an election to fill a community college board office, the county board of
17 supervisors no earlier than seventy-five days before the election may cancel
18 the election for that office and that office is deemed vacant and shall be
19 filled as provided in section 15-1441. A person who is appointed pursuant to
20 this subsection is fully vested with the powers and duties of the office as
21 if elected to that office.

22 D. The county school superintendent and the chairman of the board of
23 supervisors shall meet on the seventh day following the election to canvass
24 the returns in accordance with procedures for the canvass of returns in a
25 general election. The county school superintendent shall declare the results
26 of the election, declare elected the person receiving the highest number of
27 votes for each office to be filled and issue to that person a certificate of
28 election.

29 E. All candidates for the office of community college district
30 governing board member shall file with the clerk of the board of supervisors
31 a statement of contributions and expenditures as provided in section ~~16-913~~
32 **16-926**.

33 Sec. 5. Section 16-311, Arizona Revised Statutes, is amended to read:

34 16-311. Nomination papers; filing; definitions

35 A. Any person desiring to become a candidate at a primary election for
36 a political party and to have the person's name printed on the official
37 ballot shall be a qualified elector of such party and, not less than ~~ninety~~
38 ~~nor more than~~ one hundred ~~twenty~~ **EIGHTY** days before the primary election,
39 shall sign and cause to be filed a nomination paper giving the person's
40 actual residence address or description of place of residence and post office
41 address, naming the party of which the person desires to become a candidate,
42 stating the office and district or precinct, if any, for which the person
43 offers the person's candidacy, stating the exact manner in which the person
44 desires to have the person's name printed on the official ballot pursuant to
45 subsection G of this section, and giving the date of the primary election

1 and, if nominated, the date of the general election at which the person
2 desires to become a candidate. A candidate for public office shall be a
3 qualified elector at the time of filing and shall reside in the county,
4 district or precinct that the person proposes to represent.

5 B. Any person desiring to become a candidate at any nonpartisan
6 election and to have the person's name printed on the official ballot shall
7 be at the time of filing a qualified elector of such county, city, town or
8 district and, not less than ~~ninety nor more than~~ one hundred ~~twenty~~ EIGHTY
9 days before the election, shall sign and cause to be filed a nomination paper
10 giving the person's actual residence address or description of place of
11 residence and post office address, stating the office and county, city, town
12 or district and ward or precinct, if any, for which the person offers the
13 person's candidacy, stating the exact manner in which the person desires to
14 have the person's name printed on the official ballot pursuant to subsection
15 G of this section and giving the date of the election. A candidate for
16 office shall reside at the time of filing in the county, city, town,
17 district, ward or precinct that the person proposes to represent.

18 C. Notwithstanding subsection B of this section, any city or town may
19 adopt by ordinance for its elections the time frame provided in subsection A
20 of this section for filing nomination petitions. Such ordinance shall be
21 adopted not less than one hundred twenty days before the first election to
22 which it applies.

23 D. All persons desiring to become a candidate shall file with the
24 nomination paper provided for in subsection A of this section ~~an affidavit~~ A
25 DECLARATION, which shall be printed in a form prescribed by the secretary of
26 state. The ~~affidavit~~ DECLARATION shall include facts sufficient to show
27 that, other than the residency requirement provided in subsection A of this
28 section and the satisfaction of any monetary penalties, fines or judgments as
29 prescribed in subsection I of this section, the candidate will be qualified
30 at the time of election to hold the office the person seeks, and that for any
31 monetary penalties, fines or judgments as prescribed in subsection I of this
32 section, the candidate has made complete payment before the time of filing.

33 E. The nomination paper of a candidate for the office of United States
34 senator or representative in Congress, for the office of presidential elector
35 or for a state office, including a member of the legislature, or for any
36 other office for which the electors of the entire state or a subdivision of
37 the state greater than a county are entitled to vote, shall be filed with the
38 secretary of state no later than 5:00 p.m. on the last date for filing.

39 F. The nomination paper of a candidate for superior court judge or for
40 a county, district and precinct office for which the electors of a county or
41 a subdivision of a county other than an incorporated city or town are
42 entitled to vote shall be filed with the county elections officer no later
43 than 5:00 p.m. on the last date for filing as prescribed by subsection A of
44 this section. The nomination paper of a candidate for a city or town office
45 shall be filed with the city or town clerk no later than 5:00 p.m. on the

1 last date for filing. The nomination paper of a candidate for school
2 district office shall be filed with the county school superintendent no later
3 than 5:00 p.m. on the last date for filing.

4 G. The nomination paper shall include the exact manner in which the
5 candidate desires to have the person's name printed on the official ballot
6 and shall be limited to the candidate's surname and given name or names, an
7 abbreviated version of such names or appropriate initials such as "Bob" for
8 "Robert", "Jim" for "James", "Wm." for "William" or "S." for "Samuel".
9 Nicknames are permissible, but in no event shall nicknames, abbreviated
10 versions or initials of given names suggest reference to professional,
11 fraternal, religious or military titles. No other descriptive name or names
12 shall be printed on the official ballot, except as provided in this section.
13 Candidates' abbreviated names or nicknames may be printed within quotation
14 marks. The candidate's surname shall be printed first, followed by the given
15 name or names.

16 H. A person who does not file a timely nomination paper that complies
17 with this section is not eligible to have the person's name printed on the
18 official ballot for that office. The filing officer shall not accept the
19 nomination paper of a candidate for state or local office unless the person
20 provides or has provided all of the following:

21 ~~1. The nomination petition required by this title.~~

22 ~~2. A political committee statement of organization or the five hundred~~
23 ~~dollar threshold exemption statement for that office.~~

24 ~~3.~~ 1. The financial disclosure statement as prescribed for candidates
25 for that office.

26 ~~4.~~ 2. The ~~affidavit~~ **DECLARATION** of qualification and eligibility as
27 prescribed in subsection D of this section.

28 I. Except in cases where the liability is being appealed, the filing
29 officer shall not accept the nomination paper of a candidate for state or
30 local office if the person is liable for an aggregation of one thousand
31 dollars or more in fines, penalties, late fees or administrative or civil
32 judgments, including any interest or costs, in any combination, that have not
33 been fully satisfied at the time of the attempted filing of the nomination
34 paper and the liability arose from failure to comply with or enforcement of
35 chapter 6 of this title.

36 J. For the purposes of this title:

37 1. "Election district" means the state, any county, city, town,
38 precinct or other political subdivision or a special district that is not a
39 political subdivision, that is authorized by statute to conduct an election
40 and that is authorized or required to conduct its election in accordance with
41 this title.

42 2. "Nomination paper" means the form filed with the appropriate office
43 by a person wishing to declare the person's intent to become a candidate for
44 a particular political office.

1 Sec. 6. Section 16-312, Arizona Revised Statutes, is amended to read:

2 16-312. Filing of nomination papers for write-in candidates

3 A. Any person desiring to become a write-in candidate for an elective
4 office in any election shall file a nomination paper, signed by the
5 candidate, giving the person's actual residence address or description of
6 place of residence and post office address, age, length of residence in the
7 state and date of birth.

8 B. A write-in candidate shall file the nomination paper not later than
9 5:00 p.m. on the fortieth day before the election, except that:

10 1. A candidate running as a write-in candidate as provided in section
11 16-343, subsection D shall file the nomination paper not later than 5:00 p.m.
12 on the fifth day before the election.

13 2. A candidate running as a write-in candidate for an election that
14 may be canceled pursuant to section 16-410 shall file the nomination paper
15 not later than 5:00 p.m. on the seventy-sixth day before the election.

16 C. The write-in filing procedure shall be in the same manner as
17 prescribed in section 16-311. Any person who does not file a timely
18 nomination paper shall not be counted in the tally of ballots. The filing
19 officer shall not accept the nomination paper of a candidate for state or
20 local office unless the candidate provides or has provided ~~both of the~~
21 ~~following:~~

22 ~~1. A political committee statement of organization or the five hundred~~
23 ~~dollar threshold exemption statement for that office.~~

24 ~~2.~~ the financial disclosure statement as prescribed for candidates for
25 that office.

26 D. Except in cases where the liability is being appealed, the filing
27 officer shall not accept the nomination paper of a write-in candidate for
28 state or local office if the person is liable for an aggregation of one
29 thousand dollars or more in fines, penalties, late fees or administrative or
30 civil judgments, including any interest or costs, in any combination, that
31 have not been fully satisfied at the time of the attempted filing of the
32 nomination paper and the liability arose from failure to comply with or
33 enforcement of chapter 6 of this title.

34 E. The secretary of state shall notify the various boards of
35 supervisors as to write-in candidates filing with the secretary of state's
36 office. The county school superintendent shall notify the appropriate board
37 of supervisors as to write-in candidates filing with the superintendent's
38 office. The board of supervisors shall notify the appropriate election board
39 inspector of all candidates who have properly filed such statements. In the
40 case of a city or town election, the city or town clerk shall notify the
41 appropriate election board inspector of candidates properly filed. No other
42 write-ins shall be counted. The election board inspector shall post the
43 notice of official write-in candidates in a conspicuous location within the
44 polling place.

1 F. Except as provided in section 16-343, subsection E, a candidate may
2 not file pursuant to this section if any of the following applies:

3 1. For a candidate in the general election, the candidate ran in the
4 immediately preceding primary election and failed to be nominated to the
5 office sought in the current election.

6 2. For a candidate in the general election, the candidate filed a
7 nomination petition for the immediately preceding primary election for the
8 office sought and failed to provide a sufficient number of valid petition
9 signatures as prescribed by section 16-322.

10 3. For a candidate in the primary election, the candidate filed a
11 nomination petition for the current primary election for the office sought
12 and failed to provide a sufficient number of valid petition signatures as
13 prescribed by section 16-322.

14 4. For a candidate in the general election, the candidate filed a
15 nomination petition for nomination other than by primary for the office
16 sought and failed to provide a sufficient number of valid petition signatures
17 as prescribed by section 16-341.

18 G. A person who files a nomination paper pursuant to this section for
19 the office of president of the United States shall designate in writing to
20 the secretary of state at the time of filing the name of the candidate's
21 vice-presidential running mate, the names of presidential electors who will
22 represent that candidate and a statement signed by the vice-presidential
23 running mate and designated presidential electors that indicates their
24 consent to be designated. A nomination paper for each presidential elector
25 designated shall be filed with the candidate's nomination paper. The number
26 of presidential electors shall equal the number of United States senators and
27 representatives in Congress from this state.

28 Sec. 7. Section 16-314, Arizona Revised Statutes, is amended to read:
29 16-314. Filing and form of nomination petitions; definition

30 A. Any person desiring to become a candidate at any election and to
31 have the person's name printed on the official ballot shall file, ~~within the~~
32 ~~same time~~ NOT LESS THAN NINETY NOR MORE THAN ONE HUNDRED TWENTY DAYS BEFORE
33 THE PRIMARY ELECTION and with the same officer as provided by section 16-311,
34 a nomination petition in addition to the nomination paper required.

35 B. For the purposes of this title, "nomination petition" means the
36 form or forms used for obtaining the required number of signatures of
37 qualified electors, which is circulated by or on behalf of the person wishing
38 to become a candidate for a political office.

39 C. Nomination petitions shall be captioned "partisan nomination
40 petition" or "nonpartisan nomination petition", followed by the language of
41 the petition in substantially the following form:

42 Partisan Nomination Petition

43 I, the undersigned, a qualified elector of the county of
44 _____, state of Arizona, and of (here name political
45 division or district from which the nomination is sought) and a

1 member of the _____ party or a person who is
2 registered as no party preference or independent as the party

32 D. The nomination petition of a person seeking to fill an unexpired
33 vacant term for any public office shall designate the expiration date of the
34 term following the name of the office being sought.

35 Sec. 8. Section 16-341, Arizona Revised Statutes, is amended to read:
36 16-341. Nomination petition; method and time of filing; form;
37 qualifications and number of petitioners required

38 A. Any qualified elector who is not a registered member of a political
39 party that is recognized pursuant to this title may be nominated as a
40 candidate for public office otherwise than by primary election or by party
41 committee pursuant to this section.

42 B. This article shall not be used to place on the general election
43 ballot the name of a political party that fails to meet the qualifications
44 specified in section 16-802 or 16-804, or the name of any candidate
45 representing such party or the name of a candidate who has filed a nomination

1 petition in the immediately preceding primary election and has failed to
2 qualify as the result of an insufficient number of valid signatures.

3 C. A nomination petition stating the name of the office to be filled,
4 the name and residence of the candidate and other information required by
5 this section shall be filed with the same officer with whom primary
6 nomination papers and petitions are required to be filed as prescribed in
7 section 16-311. Except for candidates for the office of presidential elector
8 filed pursuant to this section, the petition shall be filed ~~at the same time~~
9 ~~as primary nomination papers and petitions are required to be filed as~~
10 ~~prescribed by section 16-311~~ NOT LESS THAN NINETY NOR MORE THAN ONE HUNDRED
11 TWENTY DAYS BEFORE THE PRIMARY ELECTION. The petition shall be signed only
12 by voters who have not signed the nomination petitions of a candidate for the
13 office to be voted for at that primary election.

14 D. The nomination petition shall be in substantially the following
15 form:

17 state of Arizona, do hereby nominate _____, who resides at
18 _____ in the county of _____, as a candidate for the
19 office of _____ at the general (or special, as the case may
20 be) election to be held on the _____ day of _____, ____.

21 I hereby declare that I have not signed the nomination
22 petitions of any candidate for the office to be voted for at
23 this primary election, and I do hereby select the following
24 designation under which name the said candidate shall be placed
25 on the official ballot (here insert such designation not
26 exceeding three words in length as the signers may select).

27 E. The nomination petition shall conform as nearly as possible to the
28 provisions relating to nomination petitions of candidates to be voted for at
29 primary elections and shall be signed by at least the number of persons who
30 are registered to vote determined by calculating three ~~per-cent~~ PERCENT of

34 ballot at the next ensuing primary election and accorded representation on

36 F. The percentage of persons who are registered to vote necessary to
37 sign the nomination petition shall be determined by the total number of
38 registered voters from other than political parties that are qualified to be
39 represented by an official party ballot at the next ensuing primary election
40 and accorded representation on the general election ballot in the state,
41 county, subdivision or district on March 1 of the year in which the general
42 election is held. Notwithstanding the method prescribed by subsection E of
43 this section and this subsection for calculating the minimum number of
44 signatures necessary, any person who is registered to vote in the state,
45 county, subdivision or district for which the candidate is nominated is

1 eligible to sign the nomination petition without regard to the signer's party
2 affiliation.

3 G. A nomination petition for any candidate may be circulated by a
4 person who is not a resident of this state but who is otherwise eligible to
5 register to vote in this state if that person registers as a circulator with
6 the secretary of state before circulating petitions. The nomination petition
7 for the office of presidential elector shall include a group of names of
8 candidates equal to the number of United States senators and representatives
9 in Congress from this state instead of separate nomination petitions for each

11 petition containing a group of presidential electors candidates is counted as
12 a signature for the nomination of each of the candidates. The presidential

5 TREASURER. FOR A CANDIDATE COMMITTEE, THE CANDIDATE MAY SERVE AS BOTH

7 4. FOR A CANDIDATE COMMITTEE FOR A PARTISAN OFFICE, THE CANDIDATE'S
8 PARTY AFFILIATION.

9 5. A LISTING OF ALL BANKS OR OTHER FINANCIAL INSTITUTIONS USED BY THE
10 COMMITTEE.

11 6. A STATEMENT THAT THE COMMITTEE CHAIRPERSON AND COMMITTEE TREASURER
12 HAVE READ THE FILING OFFICER'S CAMPAIGN FINANCE AND REPORTING GUIDE, AGREE TO

34 INSTRUMENT, INCLUDING A CHECK, CREDIT CARD, PAYROLL DEDUCTION, ONLINE PAYMENT
35 OR ELECTRONIC TRANSFER, IF THE CONTRIBUTOR IS AN ACCOUNT HOLDER OF THE
36 INSTRUMENT. UNLESS DESIGNATED AS A JOINT CONTRIBUTION, A CONTRIBUTION SHALL

25 (c) COST OF INVITATIONS, FOOD OR BEVERAGES.

26 (d) USE OF E-MAIL, INTERNET ACTIVITY OR SOCIAL MEDIA MESSAGES, ONLY IF
27 THE INDIVIDUAL'S USE IS NOT PAID FOR BY THE INDIVIDUAL OR ANY OTHER PERSON
28 AND IF THE E-MAILS, SOCIAL MEDIA MESSAGES OR OTHER INTERNET ACTIVITIES DO NOT
29 CONTAIN OR INCLUDE TRANSMITTAL OF A PAID ADVERTISEMENT OR PAID FUND-RAISING

2 GUIDES, SAMPLE BALLOTS, PINS, BUMPER STICKERS, HANDBILLS, BROCHURES, POSTERS,
3 YARD SIGNS AND OTHER SIMILAR MATERIALS DISTRIBUTED THROUGH THE PARTY.

4 (b) COORDINATED POLITICAL PARTY EXPENDITURES.

5 5. THE PAYMENT BY ANY PERSON TO DEFRAY A POLITICAL PARTY'S OPERATING
6 EXPENSES OR PARTY-BUILDING ACTIVITIES, INCLUDING:

7 (a) PARTY STAFF AND PERSONNEL.

8 (b) STUDIES AND REPORTS.

9 (c) VOTER REGISTRATION, RECRUITMENT, POLLING AND TURNOUT EFFORTS.

10 (d) PARTY CONVENTIONS AND PARTY MEETINGS.

11 (e) CONSTRUCTION, PURCHASE OR LEASE OF PARTY BUILDINGS OR FACILITIES.

12 6. THE VALUE OF ANY OF THE FOLLOWING TO A COMMITTEE:

13 (a) INTEREST EARNED ON THE COMMITTEE'S DEPOSITS OR INVESTMENTS.

14 (b) TRANSFERS BETWEEN COMMITTEES TO REIMBURSE EXPENSES AND DISTRIBUTE
15 MONIES RAISED THROUGH A JOINT FUND-RAISING EFFORT, EXCEPT THAT CONTRIBUTIONS
16 SHALL BE ALLOCATED AS DESCRIBED IN THE FUND-RAISING SOLICITATION AND EXPENSES
17 SHALL BE ALLOCATED IN THE SAME PROPORTION AS CONTRIBUTIONS.

- 8 (d) USE OF E-MAIL, INTERNET ACTIVITY OR SOCIAL MEDIA MESSAGES, ONLY IF
- 9 THE INDIVIDUAL'S USE IS NOT PAID FOR BY THE INDIVIDUAL OR ANY OTHER PERSON
- 10 AND IF THE E-MAILS, SOCIAL MEDIA MESSAGES OR OTHER INTERNET ACTIVITIES DO NOT
- 11 CONTAIN OR INCLUDE TRANSMITTAL OF A PAID ADVERTISEMENT OR PAID FUND-RAISING
- 12 SOLICITATION.

22 A FILING OFFICER OR ENFORCEMENT OFFICER MAY CONSIDER THE FOLLOWING TO BE
23 REBUTTABLE EVIDENCE OF COORDINATION:

24 1. ANY AGENT OF THE PERSON MAKING THE EXPENDITURE IS ALSO AN AGENT OF
25 THE CANDIDATE WHOSE ELECTION OR WHOSE OPPONENT'S DEFEAT IS BEING ADVOCATED BY
26 THE EXPENDITURE.

27 2. IN THE SAME ELECTION CYCLE, THE PERSON MAKING THE EXPENDITURE OR
28 THAT PERSON'S AGENT IS OR HAS BEEN AUTHORIZED TO RAISE OR SPEND MONIES ON THE
29 CANDIDATE'S BEHALF.

30 3. IN THE SAME ELECTION CYCLE, THE CANDIDATE IS OR HAS BEEN AUTHORIZED
31 TO RAISE MONEY OR SOLICIT CONTRIBUTIONS ON BEHALF OF THE PERSON MAKING THE
32 EXPENDITURE.

33 D. NOTWITHSTANDING SUBSECTION C OF THIS SECTION, COORDINATION DOES NOT
34 EXIST UNDER EITHER OF THE FOLLOWING:

35 1. IF THE PERSON MAKING THE EXPENDITURE MAINTAINS A FIREWALL BETWEEN
36 THE PERSON AND THAT PERSON'S AGENT IN COMPLIANCE WITH ALL OF THE FOLLOWING:

37 (a) THE PERSON'S AGENT DID NOT PARTICIPATE IN DECIDING TO MAKE THE
38 EXPENDITURE OR IN DECIDING THE CONTENT, TIMING OR TARGETING OF THE
39 EXPENDITURE.

40 (b) THE PERSON MAKING THE EXPENDITURE HAS A WRITTEN POLICY
41 ESTABLISHING THE FIREWALL AND ITS REQUIREMENTS.

42 (c) THE PERSON MAKING THE EXPENDITURE AND THE PERSON'S AGENT FOLLOWED
43 THE WRITTEN POLICY REGARDING THE FIREWALL.

44 2. SOLELY BECAUSE AN AGENT OF A PERSON MAKING THE EXPENDITURE SERVES

1 E. AN EXPENDITURE THAT IS COORDINATED WITH A CANDIDATE, OTHER THAN A
2 COORDINATED PARTY EXPENDITURE, IS DEEMED AN IN-KIND CONTRIBUTION TO THE
3 CANDIDATE.

4 F. AN ENTITY THAT MAKES AN INDEPENDENT EXPENDITURE, OTHER THAN AN
5 INDIVIDUAL OR A COMMITTEE, SHALL FILE INDEPENDENT EXPENDITURE REPORTS
6 PURSUANT TO SECTION 16-926, SUBSECTION G.

7 ARTICLE 1.4. REPORTING REQUIREMENTS AND DISCLOSURE STATEMENTS

8 16-925. Advertising and fund-raising disclosure statements

9 A. A PERSON THAT MAKES AN EXPENDITURE FOR AN ADVERTISEMENT OR
10 FUND-RAISING SOLICITATION, OTHER THAN AN INDIVIDUAL, SHALL INCLUDE THE
11 FOLLOWING DISCLOSURES IN THE ADVERTISEMENT OR SOLICITATION:

12 1. THE WORDS "PAID FOR BY", FOLLOWED BY THE NAME OF THE PERSON MAKING
13 THE EXPENDITURE FOR THE ADVERTISEMENT OR FUND-RAISING SOLICITATION.

14 2. WHETHER THE EXPENDITURE WAS AUTHORIZED BY ANY CANDIDATE, FOLLOWED
15 BY THE IDENTITY OF THE AUTHORIZING CANDIDATE, IF ANY.

16 B. IN ADDITION TO THE DISCLOSURE REQUIRED BY SUBSECTION A OF THIS
17 SECTION, A POLITICAL ACTION COMMITTEE THAT MAKES AN EXPENDITURE FOR AN
18 ADVERTISEMENT SHALL INCLUDE A DISCLOSURE STATING THE NAMES OF THE THREE
19 POLITICAL ACTION COMMITTEES MAKING THE LARGEST AGGREGATE CONTRIBUTIONS TO THE
20 POLITICAL ACTION COMMITTEE MAKING THE EXPENDITURE AND THAT EXCEED TWENTY
21 THOUSAND DOLLARS DURING THE ELECTION CYCLE, AS CALCULATED AT THE TIME THE
22 ADVERTISEMENT WAS DISTRIBUTED FOR PUBLICATION, DISPLAY, DELIVERY OR
23 BROADCAST.

24 C. IF A DISCLOSURE CONTAINS ANY ACRONYM OR NICKNAME THAT IS NOT
25 COMMONLY KNOWN, THE DISCLOSURE SHALL ALSO SPELL OUT THE ACRONYM OR PROVIDE
26 THE FULL NAME.

27 D. IF THE ADVERTISEMENT IS:

28 1. BROADCAST ON RADIO, THE DISCLOSURE SHALL BE CLEARLY SPOKEN AT THE
29 BEGINNING OR END OF THE ADVERTISEMENT.
