# HOUSE BILL 2613

## AN ACT

AMENDING SECTIONS 3-449, 3-466, 3-492, 3-496, 3-521, 27-102, 32-101, 32-102, 32-103, 32-122 AND 32-122.01, ARIZONA REVISED STATUTES; AMENDING TITLE 32, CHAPTER 1, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 32-132; AMENDING SECTIONS 32-142, 32-144, 32-1301, 32-1394.01 AND 32-2352, ARIZONA REVISED STATUTES; REPEALING SECTION 32-2372, ARIZONA REVISED STATUTES; AMENDING TITLE 32, CHAPTER 23, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 32-2372.01; AMENDING SECTIONS 32-2373, 32-2374 AND 32-2391, ARIZONA REVISED STATUTES; AMENDING SECTION 32-3021, ARIZONA REVISED STATUTES, AS AMENDED BY LAWS 2011, CHAPTER 141, SECTION 1; AMENDING SECTION 32-3021, ARIZONA REVISED STATUTES, AS AMENDED BY LAWS 2015, CHAPTER 262, SECTION 20; AMENDING SECTIONS 41-619.51, 41-1758, 41-1758.01, 41-2571 AND 42-5075, ARIZONA REVISED STATUTES; RELATING TO REGULATORY LICENSING.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Section 3-449, Arizona Revised Statutes, is amended to  
3 read:  
4 3-449. Annual licensing; fees; application; penalty  
5 A. ~~No~~ A person ~~shall~~ MAY NOT transact business as a citrus fruit  
6 dealer, ~~packer~~ or shipper without first obtaining a license as provided in  
7 this article. The license expires on August 1 of each year and is renewable  
8 annually. The license fee shall be determined according to the annual gross  
9 sales based on the dealer's or shipper's previous fiscal year as follows:  
10 1. If the annual gross sales are five hundred thousand dollars or  
11 more, the annual fee is four hundred fifty dollars.  
12 2. If the annual gross sales are between two hundred thousand dollars  
13 and five hundred thousand dollars, the annual fee is three hundred dollars.  
14 3. If the annual gross sales are two hundred thousand dollars or less,  
15 the annual fee is one hundred fifty dollars.  
16 4. If the person was not in business the previous fiscal year, the  
17 annual fee is one hundred fifty dollars.  
18 ~~B. The application for a packer license shall be filed with the~~  
19 ~~supervisor and be accompanied by an annual license fee of one hundred fifty~~  
20 ~~dollars.~~  
21 ~~C.~~ B. If a person engages in business in more than one category as a  
22 dealer, ~~OR~~ shipper ~~or packer~~, the license designation shall be based on the  
23 category in which most of the licensee's business is conducted.  
24 ~~D.~~ C. The license fees collected by the supervisor shall be paid into  
25 the citrus, fruit and vegetable trust fund.  
26 ~~E.~~ D. The application for a dealer, ~~OR~~ shipper ~~or packer~~ license  
27 shall contain the following information:  
28 1. The full name of the person applying for the license.  
29 2. Whether the applicant is an individual, partnership, firm,  
30 corporation, association, trust or cooperative association and the full name  
31 of each member of the partnership or firm, the full name of each officer and  
32 director of the association or corporation or the full name of each trustee.  
33 3. The principal business address of the applicant in this state and  
34 elsewhere and the address where the applicant conducts the described  
35 business.  
36 4. The name of the statutory agent in this state for service of legal  
37 notice.  
38 5. The category of license for which the applicant is applying.  
39 6. A statement of the facts, signed under penalty of perjury,  
40 entitling the applicant to a license under the applicable category and  
41 stating whether the applicant has ever had any license to handle citrus,  
42 fruit or vegetables in any state denied, suspended or revoked.  
43 7. If the applicant acts as a commission merchant, a schedule of  
44 commissions and charges for services, which may not be altered during the  
45 term of the license except by written agreement between the parties involved.

1           ~~F.~~ E. The supervisor shall issue to the applicant a license to  
2 conduct the business described for a period of one year unless it is revoked  
3 for cause.

4           ~~G.~~ F. An applicant who tenders a renewal application for a license  
5 that is received by the supervisor after August 15 shall pay a penalty of  
6 twenty-five dollars. An applicant who tenders a renewal application for a  
7 license that is received after September 1 shall pay a penalty of fifty  
8 dollars. All penalties shall be deposited in the citrus, fruit and vegetable  
9 trust fund.

10           Sec. 2. Section 3-466, Arizona Revised Statutes, is amended to read:

11           3-466. Civil penalties; hearing

12           A. A person is subject to a civil penalty of not more than five  
13 hundred dollars~~;~~ if the person does either of the following:

14           1. Acts as a dealer~~;~~ OR shipper ~~or packer~~ without a valid license.

15           2. Knowingly falsifies or causes to be falsified information in a  
16 record intended to show proof of ownership.

17           B. A person shall be subject to a civil penalty of not more than three  
18 hundred dollars~~;~~ if the person does any of the following:

19           1. Makes a written or oral false, deceptive or misleading  
20 representation or assertion concerning the quality, size, maturity or  
21 condition of citrus fruit.

22           2. Alters, removes or destroys a warning notice from a lot or part of  
23 a lot to which it was affixed except on written authorization of an  
24 inspector, the supervisor or the director or by court order.

31           C. A commission merchant is subject to a civil penalty of not more  
32 than five hundred dollars~~;~~ if the commission merchant does any of the  
33 following:

34           1. Knowingly makes a false or misleading statement as to the condition  
35 of any citrus fruit.

36           2. Makes a fraudulent charge or return for handling or selling citrus  
37 fruit or for rendering any service in connection with handling or selling  
38 citrus fruit.

39           3. Reconsigns a consignment to receive, collect or charge more than  
40 one commission without the consent of the consignor.

41           4. Sells citrus fruit at less than market price to a person with whom  
42 the consignment merchant has a direct or indirect financial connection.

43           5. Makes a sale and directly or indirectly receives a portion of the  
44 purchase price other than the commission specified in the contract.

1 D. A person who is charged with violating this article or rules  
2 adopted pursuant to this article may request a hearing pursuant to title 41,  
3 chapter 6, article 10.

4 E. Civil penalties collected pursuant to this section shall be  
5 deposited in the citrus, fruit and vegetable trust fund.

6 Sec. 3. Section 3-492, Arizona Revised Statutes, is amended to read:  
7 3-492. Licensing dealers and shippers; application; fees;  
8 penalty

9 A. ~~No~~ A person ~~shall~~ MAY NOT act as a dealer or shipper without first  
10 obtaining a license as provided in this article. Application for the license  
11 shall be filed with the supervisor and accompanied by a license fee  
12 determined according to the annual gross sales based on the dealer's or  
13 shipper's previous fiscal year as follows:

14 1. If the annual gross sales are five hundred thousand dollars or  
15 more, the annual fee is five hundred dollars.

16 2. If the annual gross sales are between two hundred thousand dollars  
17 and five hundred thousand dollars, the annual fee is three hundred fifty  
18 dollars.

19 3. If the annual gross sales are two hundred thousand dollars or less,  
20 the annual fee is two hundred dollars.

21 4. If the person was not in business the previous fiscal year, the  
22 annual fee is two hundred dollars.

23 ~~B. A person may not act as a packer without first obtaining a license~~  
24 ~~as provided in this article. The application for a packer license shall be~~  
25 ~~filed with the supervisor and accompanied by an annual license fee of two~~  
26 ~~hundred dollars.~~

27 ~~C.~~ B. If a person engages in business in more than one category as a  
28 dealer, ~~OR~~ shipper ~~or packer~~, the license designation shall be based on the  
29 category in which most of the licensee's business is conducted.

30 ~~D.~~ C. The monies received as license fees under this section shall be  
31 paid into the citrus, fruit and vegetable trust fund. The license shall  
32 expire on September 1 of each year and is renewable annually.

33 ~~E.~~ D. The application for a dealer, ~~OR~~ shipper ~~or packer~~ license  
34 shall contain the following information:

17          Sec. 4. Section 3-496, Arizona Revised Statutes, is amended to read:

18          3-496. List of licensees; display of license

19          A. The supervisor may publish a pamphlet containing a list of all  
20          licensed dealers, ~~AND~~ shippers ~~and packers~~ and the rules pertaining to the  
21          enforcement of this article.

22          B. Each licensed dealer, ~~AND~~ shipper ~~and packer~~ shall keep the  
23          license in ~~his~~ THE DEALER'S OR SHIPPER'S office or at ~~his~~ THE DEALER'S OR  
24          SHIPPER'S principal place of business.

25          Sec. 5. Section 3-521, Arizona Revised Statutes, is amended to read:

26          3-521. Civil penalties; hearing

27          A. A person is subject to a civil penalty of not more than five  
28          hundred dollars, ~~if~~ the person does either of the following:

29                  1. Acts as a dealer, ~~OR~~ shipper ~~or packer~~ without a valid license.

30                  2. Knowingly falsifies or causes to be falsified information in a  
31          record intended to show proof of ownership.

32          B. A person shall be subject to a civil penalty of not more than three  
33          hundred dollars, ~~if~~ the person does any of the following:

34                  1. Makes a written or oral false, deceptive or misleading  
35          representation or assertion concerning the quality, size, maturity or

20 as provided by title 41, chapter 6, article 10.

21 E. Civil penalties collected pursuant to this section shall be  
22 deposited in the citrus, fruit and vegetable trust fund.

23 Sec. 6. Section 27-102, Arizona Revised Statutes, is amended to read:  
24 27-102. Arizona geological survey; state geologist; powers

25 A. The Arizona geological survey is established with offices located  
26 in proximity to the university of Arizona in Tucson. The governor shall  
27 appoint a state geologist, pursuant to section 38-211, to be the  
28 administrative head of the Arizona geological survey and to serve at the  
29 pleasure of the governor. The state geologist shall be EITHER registered as  
30 a geologist by the state board of technical registration OR A TRAINED  
31 GEOLOGIST AS DEFINED IN SECTION 32-144, a graduate of an accredited  
32 institution and otherwise qualified by education and experience to direct the  
33 research and information functions of the Arizona geological survey.

34 B. The state geologist may organize the Arizona geological survey into  
35 such administrative units, and, subject to title 41, chapter 4, article 4,  
36 employ professional and support staff, as necessary to achieve the objectives  
37 and promote the policies prescribed by this article.

38 C. The state geologist may:

39 1. Retain the services of faculty members or students, and shall have  
40 reasonable access to the data and other resources, of the university of  
41 Arizona or any other state university in this state to conduct or supervise  
42 research, experimentation or other related work of the Arizona geological  
43 survey.

1           2. Organize field expeditions to perform work for the Arizona  
2 geological survey using university students who are sufficiently advanced in  
3 their study of geology to be able to perform satisfactory work.

4           3. Establish and appoint an advisory board consisting of independent  
5 practicing geologists, university or college faculty, mining geologists and  
6 others who use and rely on data, information and other services of the  
7 Arizona geological survey.

8           4. Employ volunteer staff as necessary.

9           D. The expenses of the Arizona geological survey shall be paid by  
10 annual appropriation from the state general fund and as otherwise provided by  
11 this article.

12           Sec. 7. Heading change

13           The chapter heading of title 32, chapter 1, Arizona Revised Statutes,  
14 is changed from "ARCHITECTS, ASSAYERS, ENGINEERS, GEOLOGISTS, HOME  
15 INSPECTORS, LANDSCAPE ARCHITECTS AND SURVEYORS" to "ARCHITECTS, ENGINEERS,  
16 GEOLOGISTS, HOME INSPECTORS, LANDSCAPE ARCHITECTS AND SURVEYORS".

17           Sec. 8. Section 32-101, Arizona Revised Statutes, is amended to read:

18           32-101. Purpose; definitions

19           A. The purpose of this chapter is to provide for the safety, health  
20 and welfare of the public through the promulgation and enforcement of  
21 standards of qualification for those individuals WHO ARE registered or  
22 certified and seeking registration or certification pursuant to this chapter.

23           B. In this chapter, unless the context otherwise requires:

24           1. "Advertising" includes business cards, signs or letterhead provided  
25 by a person to the public.

26           2. "Alarm" or "alarm system":

27           (a) Means any mechanical or electrical device that is designed to emit  
28 an audible alarm or transmit a signal or message if activated and that is  
29 used to detect an unauthorized entry into a building or other facility or  
30 alert other persons of the occurrence of a medical emergency or the  
31 commission of an unlawful act against a person or in a building or other  
32 facility.

33           (b) Includes a silent, panic, holdup, robbery, duress, burglary,  
34 medical alert or proprietor alarm that requires emergency personnel to  
35 respond.

36           (c) Does not include a telephone call diverter or a system that is  
37 designed to report environmental and other occurrences and that is not  
38 designed or used to alert or cause other persons to alert public safety  
39 personnel.

40           3. "Alarm agent":

41           (a) Means a person, whether an employee, an independent contractor or  
42 otherwise, who acts on behalf of an alarm business and who tests, maintains,  
43 services, repairs, sells, rents, leases or installs alarm systems.

44           (b) Does not include any action by a person that:

- 1 (i) Is performed in connection with an alarm system located on the  
2 person's own property or the property of the person's employer.
- 3 (ii) Is acting on behalf of an alarm business whose work duties do not  
4 include visiting the location where an alarm system installation occurs.
- 5 4. "Alarm business":
- 6 (a) Means any person who, either alone or through a third party,  
7 engages in the business of either of the following:
- 8 (i) Providing alarm monitoring services.
- 9 (ii) Selling, leasing, renting, maintaining, repairing or installing a  
10 nonproprietor alarm system or service.
- 11 (b) Does not include any of the following:
- 12 (i) A person or company that purchases, rents or uses an alarm that is  
13 affixed to a motor vehicle.
- 14 (ii) A person who owns or conducts a business of selling, leasing,  
15 renting, installing, maintaining or monitoring an alarm that is affixed to a  
16 motor vehicle.
- 17 (iii) A person who installs a nonmonitored proprietor alarm for a  
18 business that the person owns, is employed by or manages.
- 19 (iv) The installation or monitoring of fire alarm systems.
- 20 (v) An alarm system that is operated by a city or town.
- 21 5. "Alarm subscriber" means any person who:
- 22 (a) Leases, rents or purchases any monitored alarm system or service  
23 from an alarm business.
- 24 (b) Leases or rents an alarm system.
- 25 (c) Contracts with an alarm business for alarm monitoring,  
26 installation, repair or maintenance services.
- 27 6. "Architect" means a person who, by reason of knowledge of the  
28 mathematical and physical sciences and the principles of architecture and  
29 architectural engineering acquired by professional education and practical  
30 experience, is qualified to engage in the practice of architecture as  
31 attested by registration as an architect.
- 32 7. "Architect-in-training" means a candidate for registration as a  
33 professional architect who is a graduate of a school approved by the board or  
34 who has five years or more of education or experience, or both, in  
35 architectural work ~~which~~ THAT meets standards specified by the board in its  
36 rules. In addition, the candidate shall have passed the architect-in-training  
37 examination.
- 38 8. "Architectural practice" means any professional service or creative  
39 work requiring architectural education, training and experience, and the  
40 application of the mathematical and physical sciences and the principles of  
41 architecture and architectural engineering to such professional services or  
42 creative work as consultation, evaluation, design and review of construction  
43 for conformance with contract documents and design, in connection with any  
44 building, planning or site development. A person shall be deemed to practice  
45 or offer to practice architecture who in any manner represents that the



1 person is an architect, or is able to perform any architectural service or  
2 other services recognized by educational authorities as architecture.

3 ~~9. "Assayer" means a person who analyzes metals, ores, minerals, or~~  
4 ~~alloys in order to ascertain the quantity of gold or silver or any other~~  
5 ~~substance present in them. A person employed on a full time basis as an~~  
6 ~~assayer by an employer engaged in the business of developing, mining or~~  
7 ~~treating ores or other minerals shall not be deemed to be engaged in assaying~~  
8 ~~practice for the purposes of this chapter if the person engages in assaying~~  
9 ~~practice exclusively for and as an employee of such employer and does not~~  
10 ~~represent that the person is available and is not represented as being~~  
11 ~~available to perform any assaying services for anyone other than the person's~~  
12 ~~employer.~~

13 ~~10. "Assayer-in-training" means a candidate for registration as a~~  
14 ~~professional assayer who is a graduate of a school and curriculum approved by~~  
15 ~~the board or who has four years or more of education or experience, or both,~~  
16 ~~in assaying work which meets standards specified by the board in its rules.~~  
17 ~~In addition, the candidate shall have passed the assayer-in-training~~  
18 ~~examination.~~

19 ~~11. "Assaying practice" means any professional service or work~~  
20 ~~requiring assaying education, training and experience and the application of~~  
21 ~~special knowledge of the mineral sciences to such service or work as~~  
22 ~~consultation and the evaluation of minerals. A person is deemed to practice~~  
23 ~~or offer to practice assaying who in any manner represents that the person is~~  
24 ~~an assayer or is able to perform any assaying service or other services~~  
25 ~~recognized by educational authorities as assaying.~~

26 ~~12.~~ 9. "Board" means the state board of technical registration.

27 ~~13.~~ 10. "Certified remediation specialist" means a person who has been  
28 certified by the board to perform, supervise and review environmental  
29 remediations if the use of a certified remediation specialist is specifically  
30 authorized by title 49 and rules adopted pursuant to title 49.

31 ~~14.~~ 11. "Controlling person":

32 (a) Means a person who is designated by an alarm business.

33 (b) Does not include an alarm agent.

34 ~~15.~~ 12. "Drug laboratory site remediation firm" means a firm that is  
35 licensed by the registrar of contractors pursuant to chapter 10 of this title  
36 and that performs remediation of residual contamination from the manufacture  
37 of methamphetamine, ecstasy or LSD or the storage of chemicals or equipment  
38 used in manufacturing methamphetamine, ecstasy or LSD. For the purposes of  
39 this paragraph:

40 (a) "Ecstasy" has the same meaning prescribed in section 13-3401,  
41 paragraph 6 and includes any of the precursor chemicals, regulated chemicals,  
42 other substances or equipment used in the unlawful manufacture of the  
43 dangerous drug.

44 (b) "LSD" has the same meaning prescribed in section 13-3401,  
45 paragraph 6 and includes any of the precursor chemicals, regulated chemicals,

1 other substances or equipment used in the unlawful manufacture of the

3 (c) "Methamphetamine" has the same meaning prescribed in section  
4 13-3401, paragraph 6 and includes any of the precursor chemicals, regulated  
5 chemicals, other substances or equipment used in the unlawful manufacture of  
6 the dangerous drug.

7 ~~16-~~ 13. "Engineer" means a person who, by reason of special knowledge  
8 of the mathematical and physical sciences and the principles and methods of  
9 engineering analysis and design acquired by professional education and  
10 practical experience, is qualified to practice engineering as attested by  
11 registration as a professional engineer.

12 ~~17-~~ 14. "Engineering practice" means any professional service or  
13 creative work requiring engineering education, training and experience and  
14 the application of special knowledge of the mathematical, physical and  
15 engineering sciences to such professional services or creative work as  
16 consultation, research investigation, evaluation, planning, surveying as  
17 defined in paragraph ~~27~~ 24, subdivisions (d) and (e) of this subsection,  
18 design, location, development, and review of construction for conformance  
19 with contract documents and design, in connection with any public or private  
20 utility, structure, building, machine, equipment, process, work or project.  
21 Such services and work include plans and designs relating to the location,  
22 development, mining and treatment of ore and other minerals. A person shall  
23 be deemed to be practicing or offering to practice engineering if the person  
24 practices any branch of the profession of engineering, or by verbal claim,  
25 sign, advertisement, letterhead, card or any other manner represents that the  
26 person is a professional engineer, or is able to perform or does perform any  
27 engineering service or other service recognized by educational authorities as  
28 engineering. A person employed on a full-time basis as an engineer by an  
29 employer engaged in the business of developing, mining and treating ores and  
30 other minerals shall not be deemed to be practicing engineering for the  
31 purposes of this chapter if the person engages in the practice of engineering  
32 exclusively for and as an employee of such employer and does not represent  
33 that the person is available and is not represented as being available to  
34 perform any engineering services for persons other than the person's  
35 employer.

36 ~~18-~~ 15. "Engineer-in-training" means a candidate for registration as a  
37 professional engineer who is a graduate in an approved engineering curriculum  
38 of four years or more of a school approved by the board or who has ~~had~~ four  
39 years or more of education or experience, or both, in engineering work ~~which~~  
40 ~~THAT~~ meets standards specified by the board in its rules. In addition, the  
41 candidate shall have passed the engineer-in-training examination.

42 ~~19-~~ 16. "Firm" means any individual or partnership, corporation or  
43 other type of association, including the association of a nonregistrant and a  
44 registrant who offers to the public professional services regulated by the  
45 board.

1       ~~20-~~ 17. "Geological practice" means any professional service or work  
2 requiring geological education, training and experience, and the application  
3 of special knowledge of the earth sciences to such professional services as  
4 consultation, evaluation of mining properties, petroleum properties and  
5 groundwater resources, professional supervision of exploration for mineral  
6 natural resources including metallic and nonmetallic ores, petroleum and

11 information contained in the certificate is not accurate or complete.

12 2. A person who does not comply with paragraph 1 of this subsection  
13 may establish entitlement to the deduction by presenting facts necessary to  
14 support the entitlement, but the burden of proof is on that person.

15 3. The department may prescribe a form for the certificate described  
16 in paragraph 1, subdivision (b) of this subsection. The department may also  
17 adopt rules that describe the transactions with respect to which a person is  
18 not entitled to rely solely on the information contained in the certificate  
19 provided in paragraph 1, subdivision (b) of this subsection but must instead  
20 obtain such additional information as required in order to be entitled to the  
21 deduction.

22 4. If a prime contractor is entitled to a deduction by complying with  
23 paragraph 1 of this subsection, the department may require the purchaser who  
24 caused the execution of the certificate to establish the accuracy and  
25 completeness of the information required to be contained in the certificate  
26 that would entitle the prime contractor to the deduction. If the purchaser  
27 cannot establish the accuracy and completeness of the information, the  
28 purchaser is liable in an amount equal to any tax, penalty and interest that  
29 the prime contractor would have been required to pay under article 1 of this  
30 chapter if the prime contractor had not complied with paragraph 1 of this  
31 subsection. Payment of the amount under this paragraph exempts the purchaser  
32 from liability for any tax imposed under article 4 of this chapter. The  
33 amount shall be treated as a transaction privilege tax to the purchaser and  
34 as tax revenues collected from the prime contractor in order to designate the  
35 distribution base for purposes of section 42-5029.

36 D. Subcontractors or others who perform modification activities are  
37 not subject to tax if they can demonstrate that the job was within the  
38 control of a prime contractor or contractors or a dealership of manufactured  
39 buildings and that the prime contractor or dealership is liable for the tax  
40 on the gross income, gross proceeds of sales or gross receipts attributable  
41 to the job and from which the subcontractors or others were paid.

42 E. Amounts received by a contractor for a project are excluded from  
43 the contractor's gross proceeds of sales or gross income derived from the  
44 business if the person who hired the contractor executes and provides a  
45 certificate to the contractor stating that the person providing the

1 certificate is a prime contractor and is liable for the tax under article 1  
2 of this chapter. The department shall prescribe the form of the certificate.  
3 If the contractor has reason to believe that the information contained on the  
4 certificate is erroneous or incomplete, the department may disregard the  
5 certificate. If the person who provides the certificate is not liable for  
6 the tax as a prime contractor, that person is nevertheless deemed to be the  
7 prime contractor in lieu of the contractor and is subject to the tax under  
8 this section on the gross receipts or gross proceeds received by the  
9 contractor.

10 F. Every person engaging or continuing in this state in the business  
11 of prime contracting or dealership of manufactured buildings shall present to  
12 the purchaser of such prime contracting or manufactured building a written  
13 receipt of the gross income or gross proceeds of sales from such activity and  
14 shall separately state the taxes to be paid pursuant to this section.

15 G. For the purposes of section 42-5032.01, the department shall  
16 separately account for revenues collected under the prime contracting  
17 classification from any prime contractor engaged in the preparation or  
18 construction of a multipurpose facility, and related infrastructure, that is  
19 owned, operated or leased by the tourism and sports authority pursuant to  
20 title 5, chapter 8.

21 H. For the purposes of section 42-5032.02, from and after  
22 September 30, 2013, the department shall separately account for revenues  
23 reported and collected under the prime contracting classification from any  
24 prime contractor engaged in the construction of any buildings and associated  
25 improvements that are for the benefit of a manufacturing facility. For the  
26 purposes of this subsection, "associated improvements" and "manufacturing  
27 facility" have the same meanings prescribed in section 42-5032.02.

28 I. The gross proceeds of sales or gross income derived from a contract  
29 for lawn maintenance services are not subject to tax under this section if  
30 the contract does not include landscaping activities. Lawn maintenance  
31 service is a service pursuant to section 42-5061, subsection A, paragraph 1,  
32 and includes lawn mowing and edging, weeding, repairing sprinkler heads or  
33 drip irrigation heads, seasonal replacement of flowers, refreshing gravel,  
34 lawn de-thatching, seeding winter lawns, leaf and debris collection and  
35 removal, tree or shrub pruning or clipping, garden and gravel raking and  
36 applying pesticides, as defined in section 3-361, and fertilizer materials,  
37 as defined in section 3-262.

38 J. Except as provided in subsection 0 of this section, the gross  
39 proceeds of sales or gross income derived from landscaping activities are  
40 subject to tax under this section. Landscaping includes installing lawns,  
41 grading or leveling ground, installing gravel or boulders, planting trees and  
42 other plants, felling trees, removing or mulching tree stumps, removing other  
43 imbedded plants, building irrigation berms, installing railroad ties and  
44 installing underground sprinkler or watering systems.

1 K. The portion of gross proceeds of sales or gross income attributable  
2 to the actual direct costs of providing architectural or engineering services  
3 that are incorporated in a contract is not subject to tax under this section.  
4 For the purposes of this subsection, "direct costs" means the portion of the  
5 actual costs that are directly expended in providing architectural or  
6 engineering services.

7 L. Operating a landfill or a solid waste disposal facility is not  
8 subject to taxation under this section, including filling, compacting and  
9 creating vehicle access to and from cell sites within the landfill.  
10 Constructing roads to a landfill or solid waste disposal facility and  
11 constructing cells within a landfill or solid waste disposal facility may be  
12 deemed prime contracting under this section.

13 M. The following apply in determining the taxable situs of sales of  
14 manufactured buildings:

15 1. For sales in this state where the manufactured building dealer  
16 contracts to deliver the building to a setup site or to perform the setup in  
17 this state, the taxable situs is the setup site.

18 2. For sales in this state where the manufactured building dealer does  
19 not contract to deliver the building to a setup site or does not perform the  
20 setup, the taxable situs is the location of the dealership where the building  
21 is delivered to the buyer.

22 3. For sales in this state where the manufactured building dealer  
23 contracts to deliver the building to a setup site that is outside this state,  
24 the situs is outside this state and the transaction is excluded from tax.

25 N. The gross proceeds of sales or gross income attributable to a  
26 written contract for design phase services or professional services, executed  
27 before modification begins and with terms, conditions and pricing of all of  
28 these services separately stated in the contract from those for construction  
29 phase services, is not subject to tax under this section, regardless of  
30 whether the services are provided sequential to or concurrent with prime  
31 contracting activities that are subject to tax under this section. This  
32 subsection does not include the gross proceeds of sales or gross income  
33 attributable to construction phase services. For the purposes of this  
34 subsection:

35 1. "Construction phase services" means services for the execution and  
36 completion of any modification, including the following:

37 (a) Administration or supervision of any modification performed on the  
38 project, including team management and coordination, scheduling, cost  
39 controls, submittal process management, field management, safety program,  
40 close-out process and warranty period services.

41 (b) Administration or supervision of any modification performed  
42 pursuant to a punch list. For the purposes of this subdivision, "punch list"  
43 means minor items of modification work performed after substantial completion  
44 and before final completion of the project.

1 (c) Administration or supervision of any modification performed  
2 pursuant to change orders. For the purposes of this subdivision, "change  
3 order" means a written instrument issued after execution of a contract for  
4 modification work, providing for all of the following:  
5 (i) The scope of a change in the modification work, contract for  
6 modification work or other contract documents.  
7 (ii) The amount of an adjustment, if any, to the guaranteed maximum  
8 price as set in the contract for modification work. For the purposes of this  
9 item, "guaranteed maximum price" means the amount guaranteed to be the  
10 maximum amount due to a prime contractor for the performance of all  
11 modification work for the project.  
12 (iii) The extent of an adjustment, if any, to the contract time of  
13 performance set forth in the contract.  
14 (d) Administration or supervision of any modification performed  
15 pursuant to change directives. For the purposes of this subdivision, "change  
16 directive" means a written order directing a change in modification work  
17 before agreement on an adjustment of the guaranteed maximum price or contract  
18 time.  
19 (e) Inspection to determine the dates of substantial completion or  
20 final completion.  
21 (f) Preparation of any manuals, warranties, as-built drawings, spares  
22 or other items the prime contractor must furnish pursuant to the contract for  
23 modification work. For the purposes of this subdivision, "as-built drawing"  
24 means a drawing that indicates field changes made to adapt to field  
25 conditions, field changes resulting from change orders or buried and  
26 concealed installation of piping, conduit and utility services.  
27 (g) Preparation of status reports after modification work has begun  
28 detailing the progress of work performed, including preparation of any of the  
29 following:  
30 (i) Master schedule updates.  
31 (ii) Modification work cash flow projection updates.  
32 (iii) Site reports made on a periodic basis.  
33 (iv) Identification of discrepancies, conflicts or ambiguities in  
34 modification work documents that require resolution.  
35 (v) Identification of any health and safety issues that have arisen in  
36 connection with the modification work.  
37 (h) Preparation of daily logs of modification work, including  
38 documentation of personnel, weather conditions and on-site occurrences.  
39 (i) Preparation of any submittals or shop drawings used by the prime  
40 contractor to illustrate details of the modification work performed.  
41 (j) Administration or supervision of any other activities for which a  
42 prime contractor receives a certificate for payment or certificate for final  
43 payment based on the progress of modification work performed on the project.

1           2. "Design phase services" means services for developing and  
2 completing a design for a project that are not construction phase services,  
3 including the following:

4           (a) Evaluating surveys, reports, test results or any other information  
5 on-site conditions for the project, including physical characteristics, legal  
6 limitations and utility locations for the site.

7           (b) Evaluating any criteria or programming objectives for the project  
8 to ascertain requirements for the project, such as physical requirements  
9 affecting cost or projected utilization of the project.

10          (c) Preparing drawings and specifications for architectural program  
11 documents, schematic design documents, design development documents,  
12 modification work documents or documents that identify the scope of or  
13 materials for the project.

14          (d) Preparing an initial schedule for the project, excluding the  
15 preparation of updates to the master schedule after modification work has  
16 begun.

17          (e) Preparing preliminary estimates of costs of modification work  
18 before completion of the final design of the project, including an estimate  
19 or schedule of values for any of the following:

20           (i) Labor, materials, machinery and equipment, tools, water, heat,  
21 utilities, transportation and other facilities and services used in the  
22 execution and completion of modification work, regardless of whether they are  
23 temporary or permanent or whether they are incorporated in the modifications.

24           (ii) The cost of labor and materials to be furnished by the owner of  
25 the real property.

26           (iii) The cost of any equipment of the owner of the real property to  
27 be assigned by the owner to the prime contractor.

28           (iv) The cost of any labor for installation of equipment separately  
29 provided by the owner of the real property that has been designed, specified,  
30 selected or specifically provided for in any design document for the project.

31           (v) Any fee paid by the owner of the real property to the prime  
32 contractor pursuant to the contract for modification work.

33           (vi) Any bond and insurance premiums.

34           (vii) Any applicable taxes.

35           (viii) Any contingency fees for the prime contractor that may be used  
36 before final completion of the project.

37          (f) Reviewing and evaluating cost estimates and project documents to  
38 prepare recommendations on site use, site improvements, selection of  
39 materials, building systems and equipment, modification feasibility,  
40 availability of materials and labor, local modification activity as related  
41 to schedules and time requirements for modification work.

42          (g) Preparing the plan and procedures for selection of subcontractors,  
43 including any prequalification of subcontractor candidates.

44          3. "Professional services" means architect services, ~~assayer services,~~  
45 engineer services, geologist services, land surveying services or landscape

1 architect services that are within the scope of those services as provided in  
2 title 32, chapter 1 and for which gross proceeds of sales or gross income has  
3 not otherwise been deducted under subsection K of this section.

4 0. The gross proceeds of sales or gross income derived from a contract  
5 with the owner of real property or improvements to real property for the  
6 maintenance, repair, replacement or alteration of existing property is not  
7 subject to tax under this section if the contract does not include  
8 modification activities, except as specified in this subsection. The gross  
9 proceeds of sales or gross income derived from a de minimis amount of  
10 modification activity does not subject the contract or any part of the  
11 contract to tax under this section. For the purposes of this subsection:

12 1. Tangible personal property that is incorporated or fabricated into  
13 a project described in this subsection may be subject to the amount  
14 prescribed in section 42-5008.01.

15 2. Each contract is independent of any other contract, except that any  
16 change order that directly relates to the scope of work of the original  
17 contract shall be treated the same as the original contract under this  
18 chapter, regardless of the amount of modification activities included in the  
19 change order. If a change order does not directly relate to the scope of  
20 work of the original contract, the change order shall be treated as a new  
21 contract, with the tax treatment of any subsequent change order to follow the  
22 tax treatment of the contract to which the scope of work of the subsequent  
23 change order directly relates.

24 P. Notwithstanding subsection 0 of this section, a contract that  
25 primarily involves surface or subsurface improvements to land and that is  
26 subject to title 28, chapter 19, 20 or 22 or title 34, chapter 2 or 6 is  
27 taxable under this section, even if the contract also includes vertical  
28 improvements. Agencies that are subject to procurement processes under those  
29 provisions shall include in the request for proposals a notice to bidders  
30 when those projects are subject to this section. This subsection does not  
31 apply to contracts with:

32 1. Community facilities districts, fire districts, county television  
33 improvement districts, community park maintenance districts, cotton pest  
34 control districts, hospital districts, pest abatement districts, health  
35 service districts, agricultural improvement districts, county free library  
36 districts, county jail districts, county stadium districts, special health  
37 care districts, public health services districts, theme park districts,  
38 regional attraction districts or revitalization districts.

39 2. Any special taxing district not specified in paragraph 1 of this  
40 subsection if the district does not substantially engage in the modification,  
41 maintenance, repair, replacement or alteration of surface or subsurface  
42 improvements to land.

43 Q. Notwithstanding subsection R, paragraph 10 of this section, a  
44 person owning real property who enters into a contract for sale of the real  
45 property, who is responsible to the new owner of the property for

1 modifications made to the property in the period subsequent to the transfer  
2 of title and who receives a consideration for the modifications is considered  
3 a prime contractor solely for purposes of taxing the gross proceeds of sale  
4 or gross income received for the modifications made subsequent to the  
5 transfer of title. The original owner's gross proceeds of sale or gross  
6 income received for the modifications shall be determined according to the  
7 following methodology:

8 1. If any part of the contract for sale of the property specifies  
9 amounts to be paid to the original owner for the modifications to be made in  
10 the period subsequent to the transfer of title, the amounts are included in  
11 the original owner's gross proceeds of sale or gross income under this  
12 section. Proceeds from the sale of the property that are received after  
13 transfer of title and that are unrelated to the modifications made subsequent  
14 to the transfer of title are not considered gross proceeds of sale or gross  
15 income from the modifications.

16 2. If the original owner enters into an agreement separate from the  
17 contract for sale of the real property providing for amounts to be paid to  
18 the original owner for the modifications to be made in the period subsequent  
19 to the transfer of title to the property, the amounts are included in the  
20 original owner's gross proceeds of sale or gross income received for the  
21 modifications made subsequent to the transfer of title.

22 3. If the original owner is responsible to the new owner for  
23 modifications made to the property in the period subsequent to the transfer  
24 of title and derives any gross proceeds of sale or gross income from the  
25 project subsequent to the transfer of title other than a delayed disbursement  
26 from escrow unrelated to the modifications, it is presumed that the amounts  
27 are received for the modifications made subsequent to the transfer of title  
28 unless the contrary is established by the owner through its books, records  
29 and papers kept in the regular course of business.

30 4. The tax base of the original owner is computed in the same manner  
31 as a prime contractor under this section.

32 R. For the purposes of this section:

33 1. "Alteration" means an activity or action that causes a direct  
34 physical change to existing property. For the purposes of this paragraph:

35 (a) For existing property that is properly classified as class two  
36 property under section 42-12002, paragraph 1, subdivision (c) or paragraph 2,  
37 subdivision (c) and that is used for residential purposes, class three  
38 property under section 42-12003 or class four property under 42-12004, this  
39 paragraph does not apply if the contract amount is more than twenty-five  
40 percent of the most recent full cash value established under chapter 13,  
41 article 2 of this title as of the date of any bid for the work or the date of  
42 the contract, whichever value is higher.

43 (b) For all existing property other than existing property described  
44 in subdivision (a) of this paragraph, this paragraph does not apply if any of  
45 the following is true:

- 1 (i) The contract amount is more than seven hundred fifty thousand  
2 dollars.
- 3 (ii) The scope of work directly relates to more than forty percent of  
4 the existing square footage of the existing property.

- 22 (f) Alteration does not include maintenance, repair or replacement.
- 23 2. "Contracting" means engaging in business as a contractor.
- 24 3. "Contractor" is synonymous with the term "builder" and means any  
25 person or organization that undertakes to or offers to undertake to, or  
26 purports to have the capacity to undertake to, or submits a bid to, or does  
27 personally or by or through others, modify any building, highway, road,  
28 railroad, excavation, manufactured building or other structure, project,  
29 development or improvement, or to do any part of such a project, including  
30 the erection of scaffolding or other structure or works in connection with  
31 such a project, and includes subcontractors and specialty contractors. For  
32 all purposes of taxation or deduction, this definition shall govern without

- 35 4. "Manufactured building" means a manufactured home, mobile home or  
36 factory-built building, as defined in section 41-2142.
- 37 5. "Manufactured building dealer" means a dealer who either:
- 38 (a) Is licensed pursuant to title 41, chapter 16 and who sells  
39 manufactured buildings to the final consumer.
- 40 (b) Supervises, performs or coordinates the excavation and completion  
41 of site improvements or the setup or moving of a manufactured building,  
42 including the contracting, if any, with any subcontractor or specialty  
43 contractor for the completion of the contract.
- 44 6. "Modification" means construction, grading and leveling ground,  
45 wreckage or demolition. Modification does not include:



1 (a) Any project described in subsection 0 of this section.

2 (b) Any wreckage or demolition of existing property, or any other  
3 activity that is a necessary component of a project described in subsection 0  
4 of this section.

5 (c) Any mobilization or demobilization related to a project described  
6 in subsection 0 of this section, such as the erection or removal of temporary  
7 facilities to be used by those persons working on the project.

8 7. "Modify" means to make a modification or cause a modification to be  
9 made.

10 8. "Owner" means the person that holds title to the real property or  
11 improvements to real property that is the subject of the work, as well as an  
12 agent of the title holder and any person with the authority to perform or  
13 authorize work on the real property or improvements, including a tenant and a  
14 property manager. For the purposes of subsection 0 of this section, a person  
15 who is hired by a general contractor that is hired by an owner, or a  
16 subcontractor of a general contractor that is hired by an owner, is  
17 considered to be hired by the owner.

18 9. "Prime contracting" means engaging in business as a prime  
19 contractor.

20 10. "Prime contractor" means a contractor who supervises, performs or  
21 coordinates the modification of any building, highway, road, railroad,  
22 excavation, manufactured building or other structure, project, development or  
23 improvement, including the contracting, if any, with any subcontractors or  
24 specialty contractors and who is responsible for the completion of the  
25 contract. Except as provided in subsections E and Q of this section, a  
26 person who owns real property, who engages one or more contractors to modify  
27 that real property and who does not itself modify that real property is not a  
28 prime contractor within the meaning of this paragraph regardless of the  
29 existence of a contract for sale or the subsequent sale of that real  
30 property.

31 11. "Replacement" means the removal from service of one component or  
32 system of existing property or tangible personal property installed in  
33 existing property, including machinery or equipment, and the installation of  
34 a new component or system or new tangible personal property, including  
35 machinery or equipment, that provides the same similar or upgraded design or  
36 functionality, regardless of the contract amount and regardless of whether  
37 the existing component or system or existing tangible personal property is  
38 physically removed from the existing property.

39 12. "Sale of a used manufactured building" does not include a lease of  
40 a used manufactured building.

41 Sec. 31. Department of administration; transfer of nonhealth  
42 regulatory boards and occupational licenses; study;  
43 report

44 A. The department of administration shall conduct a study relating to  
45 the transfer of all nonhealth regulatory boards and occupational licenses

1 issued by state agencies to a new licensing and regulatory division in the  
2 department of administration. The study shall include the costs and benefits  
3 associated with the transfer. The department may consult with any board,  
4 agency or industry group necessary to complete the study.

5 B. The department of administration shall submit a report of its  
6 findings and recommendations to the governor, the president of the senate and  
7 the speaker of the house of representatives on or before September 1, 2016  
8 and shall provide a copy of this report to the secretary of state.

9 Sec. 32. Retention of members

10 Notwithstanding section 32-102, Arizona Revised Statutes, as amended by  
11 this act, all persons serving as members of the state board of technical  
12 registration on the effective date of this act may continue to serve until  
13 the expiration of their normal terms. The governor shall make all subsequent  
14 appointments as prescribed by statute.
