**CHAPTER 100**  
**HOUSE BILL 2306**

AN ACT

AMENDING TITLE 20, CHAPTER 4, ARTICLE 3, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-841.11; AMENDING TITLE 20, CHAPTER 4, ARTICLE 9, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-1057.16; AMENDING TITLE 20, CHAPTER 6, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-1376.08; AMENDING TITLE 20, CHAPTER 6, ARTICLE 5, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-1406.08; RELATING TO HEALTH INSURANCE COVERAGE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 20, chapter 4, article 3, Arizona Revised Statutes,  
3 is amended by adding section 20-841.11, to read:

5 ALL CONTRACTS ISSUED, DELIVERED OR RENEWED ON OR AFTER JULY 1, 2017 BY  
6 A CORPORATION IN THIS STATE MUST PROVIDE COVERAGE FOR LAWFUL HEALTH CARE  
7 SERVICES THAT ARE PROVIDED BY A HEALTH CARE PROVIDER TO A SUBSCRIBER  
8 REGARDLESS OF THE FAMILIAL RELATIONSHIP OF THE HEALTH CARE PROVIDER TO THE  
9 SUBSCRIBER IF THE HEALTH CARE SERVICE WOULD BE COVERED WERE IT PROVIDED TO A  
10 SUBSCRIBER WHO WAS NOT RELATED TO THE HEALTH CARE PROVIDER. THE CONTRACT MAY  
11 LIMIT THE COVERAGE TO THOSE HEALTH CARE PROVIDERS WHO ARE MEMBERS OF THE  
12 CORPORATION'S PROVIDER NETWORK.

13 Sec. 2. Title 20, chapter 4, article 9, Arizona Revised Statutes, is  
14 amended by adding section 20-1057.16, to read:

15 20-1057.16. Coverage of health care services

16 ANY EVIDENCE OF COVERAGE ISSUED, DELIVERED OR RENEWED ON OR AFTER  
17 JULY 1, 2017 BY A HEALTH CARE SERVICES ORGANIZATION IN THIS STATE MUST  
18 PROVIDE COVERAGE FOR LAWFUL HEALTH CARE SERVICES THAT ARE PROVIDED BY A  
19 HEALTH CARE PROVIDER TO AN ENROLLEE REGARDLESS OF THE FAMILIAL RELATIONSHIP  
20 OF THE HEALTH CARE PROVIDER TO THE ENROLLEE IF THE HEALTH CARE SERVICE WOULD  
21 BE COVERED WERE IT PROVIDED TO AN ENROLLEE WHO WAS NOT RELATED TO THE HEALTH  
22 CARE PROVIDER. THE EVIDENCE OF COVERAGE MAY LIMIT THE COVERAGE TO THOSE  
23 HEALTH CARE PROVIDERS WHO ARE MEMBERS OF THE HEALTH CARE SERVICES  
24 ORGANIZATION'S PROVIDER NETWORK.

25 Sec. 3. Title 20, chapter 6, article 4, Arizona Revised Statutes, is  
26 amended by adding section 20-1376.08, to read:

27 20-1376.08. Coverage of health care services

28 ALL POLICIES ISSUED, DELIVERED OR RENEWED ON OR AFTER JULY 1, 2017 BY A  
29 DISABILITY INSURER IN THIS STATE MUST PROVIDE COVERAGE FOR LAWFUL HEALTH CARE  
30 SERVICES THAT ARE PROVIDED BY A HEALTH CARE PROVIDER TO AN INSURED REGARDLESS  
31 OF THE FAMILIAL RELATIONSHIP OF THE HEALTH CARE PROVIDER TO THE INSURED IF  
32 THE HEALTH CARE SERVICE WOULD BE COVERED WERE IT PROVIDED TO AN INSURED WHO  
33 WAS NOT RELATED TO THE HEALTH CARE PROVIDER. THE POLICY MAY LIMIT THE  
34 COVERAGE TO THOSE HEALTH CARE PROVIDERS WHO ARE MEMBERS OF THE DISABILITY  
35 INSURER'S PROVIDER NETWORK.

36 Sec. 4. Title 20, chapter 6, article 5, Arizona Revised Statutes, is  
37 amended by adding section 20-1406.08, to read:

38 20-1406.08. Coverage of health care services

39 ALL POLICIES ISSUED, DELIVERED OR RENEWED ON OR AFTER JULY 1, 2017 BY A  
40 GROUP OR BLANKET DISABILITY INSURER IN THIS STATE MUST PROVIDE COVERAGE FOR  
41 LAWFUL HEALTH CARE SERVICES THAT ARE PROVIDED BY A HEALTH CARE PROVIDER TO AN  
42 INSURED REGARDLESS OF THE FAMILIAL RELATIONSHIP OF THE HEALTH CARE PROVIDER  
43 TO THE INSURED IF THE HEALTH CARE SERVICE WOULD BE COVERED WERE IT PROVIDED  
44 TO AN INSURED WHO WAS NOT RELATED TO THE HEALTH CARE PROVIDER. THE POLICY  
45 MAY LIMIT THE COVERAGE TO THOSE HEALTH CARE PROVIDERS WHO ARE MEMBERS OF THE  
46 INSURER'S PROVIDER NETWORK.
