**CHAPTER 64**  
**SENATE BILL 1338**

AN ACT

AMENDING SECTION 28-2414, ARIZONA REVISED STATUTES; RELATING TO SPECIAL PLATES.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Section 28-2414, Arizona Revised Statutes, is amended to  
3 read:  
4 28-2414. Veteran special plates  
5 A. The department shall issue veteran special plates to:  
6 1. A person who submits satisfactory proof to the department that  
7 the person is a veteran.  
8 2. The immediate family member of a person who has been issued a  
9 license plate pursuant to this section.  
10 B. The department shall issue veteran special plates for  
11 motorcycles ~~if an outside source pays thirty-two thousand dollars to the~~  
12 ~~department by December 31, 2004 for the establishment of the veteran~~  
13 ~~special plate for motorcycles.~~  
14 C. THE DEPARTMENT SHALL DESIGN the veteran special plates. EACH  
15 VETERAN SPECIAL PLATE shall contain:  
16 ~~1. a red, white and blue design.~~  
17 ~~2. An American flag in the center of the plate. AND~~  
18 ~~3. the designation "veteran" at the bottom of the plate. THE~~  
19 ~~DEPARTMENT SHALL DESIGN SEVEN DIFFERENT VETERAN SPECIAL PLATES AS FOLLOWS:~~  
20 1. ONE PLATE SHALL CONTAIN AN AMERICAN FLAG IN THE CENTER OF THE  
21 PLATE.  
22 2. ONE PLATE SHALL CONTAIN AN ARMY SEAL.  
23 3. ONE PLATE SHALL CONTAIN A NAVY SEAL.  
24 4. ONE PLATE SHALL CONTAIN A UNITED STATES MARINE CORPS SEAL.  
25 5. ONE PLATE SHALL CONTAIN AN AIR FORCE SEAL.  
26 6. ONE PLATE SHALL CONTAIN A COAST GUARD SEAL.  
27 7. ONE PLATE SHALL CONTAIN A NATIVE AMERICAN CODE TALKERS SEAL.  
28 D. A PERSON WHO MEETS THE QUALIFICATIONS OF SUBSECTION A OF THIS  
29 SECTION MAY SELECT WHICH VETERAN SPECIAL PLATE DESIGN PRESCRIBED BY  
30 SUBSECTION C OF THIS SECTION THAT THE PERSON RECEIVES FROM THE DEPARTMENT.  
31 ~~D. E. Of the twenty-five dollar~~ \$25 fee required by section  
32 28-2402 for original veteran special plates and for renewal of veteran  
33 special plates, ~~eight dollars~~ \$8 is a special plate administration fee and  
34 ~~seventeen dollars~~ \$17 is a veteran plate annual donation.  
35 ~~E. F.~~ F. The department shall deposit, pursuant to sections 35-146  
36 and 35-147, all special plate administration fees in the state highway  
37 fund established by section 28-6991 and shall deposit the veteran plate  
38 annual donations in the veterans' donations fund established by section  
39 41-608.  
40 ~~F. G.~~ G. A request for special plates issued under this section may  
41 be combined with a request for a personalized special plate issued  
42 pursuant to section 28-2406. The department shall prescribe the form for

1 the request. The initial combined request is subject to the fee required  
2 for veteran special plates and the fee required for the other special  
3 plate issued pursuant to section 28-2406. On renewal of the combined  
4 special plates, the fee is ~~twenty-five dollars~~ \$25 and shall be divided  
5 and deposited as prescribed in subsections ~~D~~ E and ~~E~~ F of this section.

7 This act is effective from and after September 30, 2019.
