CHAPTER 66
SENATE BILL 1351

AN ACT

AMENDING SECTION 41-1829, ARIZONA REVISED STATUTES; RELATING TO THE
ARIZONA PEACE OFFICERS MEMORIAL BOARD.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 41-1829, Arizona Revised Statutes, is amended to
3 read:

4 41-1829. Arizona peace officers memorial board; board
5 termination

6 A. ~~At~~ THE Arizona peace officers memorial board is established
7 consisting of the following members:

8 1. The attorney general or the attorney general's designee, who
9 shall serve as permanent chairman.

10 2. The director of the department of public safety or the
11 director's designee.

12 3. The director of the state department of corrections or the
13 director's designee.

14 4. The executive director of the Arizona criminal justice
15 commission or the executive director's designee.

16 5. Eleven members appointed pursuant to subsection B of this
17 section.

18 6. As advisory members, the chairmen of the appropriations and
19 judiciary committees of the house of representatives and the senate. For
20 the purposes of this paragraph, "advisory member" means a member who gives
21 advice to the other members of the peace officers memorial board at
22 meetings of the board but who is not eligible to vote and is not a member
23 for purposes of determining whether a quorum is present.

24 B. The permanent chairman shall appoint one private citizen who is
25 knowledgeable in the history of law enforcement in this state, one county
26 sheriff or the county sheriff's designee, one local police chief or the
27 police chief's designee, two members selected from a recognized fraternal
28 organization for law enforcement personnel, two representatives from the
29 business community, two family members of peace officers who have lost
30 their lives in the line of duty and two members from a statewide
31 organization representing law enforcement personnel.

32 C. The board shall meet at the call of the permanent chairman.

33 D. Members of the board are not eligible to receive compensation,
34 but members appointed pursuant to subsection B of this section are
35 entitled to reimbursement from the Arizona peace officers memorial fund
36 for reasonable expenses in traveling on and attending to official board
37 business.

38 E. The board established by this section ends on July 1, ~~2019~~ 2027
39 pursuant to section 41-3103.

40 Sec. 2. Retroactivity

41 This act applies retroactively to from and after June 30, 2019.
