CHAPTER 69
SENATE BILL 1530

AN ACT

AMENDING LAWS 2018, CHAPTER 230, SECTION 1; RELATING TO THE TOWING SAFETY
TASK FORCE.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Laws 2018, chapter 230, section 1 is amended to read:

3 Section 1. Towing safety task force; membership; duties;
4 report; delayed repeal

5 A. The towing safety task force is established consisting of the
6 following members:

7 1. Two members of the house of representatives who are appointed by
8 the speaker of the house of representatives and who are members of
9 different political parties. The speaker of the house of representatives
10 shall designate one of these members to serve as chairperson of the task
11 force.

12 2. Two members of the senate who are appointed by the president of
13 the senate and who are members of different political parties. The
14 president of the senate shall designate one of these members to serve as
15 vice chairperson of the task force.

16 3. The director of the department of public safety or the
17 director's designee.

18 4. Two members who represent the towing industry, one of whom is
19 appointed by the speaker of the house of representatives and one of whom
20 is appointed by the president of the senate.

21 5. One member who represents a local law enforcement agency who is
22 appointed by the speaker of the house of representatives.

23 6. One at-large member who is appointed by the president of the
24 senate.

25 B. The task force shall:

26 1. Review the safety efficacy of existing towing laws.

27 2. Receive data, reports and testimony regarding towing and
28 roadside safety.

29 3. Recommend driver education measures to improve driver awareness
30 of existing laws and promote driving habits that emphasize roadside
31 safety.

32 4. Recommend policy proposals to improve towing safety in this
33 state.

34 5. Engage in any other related duties as determined by the task
35 force members.

36 6. Submit a final report of its findings and recommendations to the
37 governor, the president of the senate and the speaker of the house of
38 representatives on or before December 31, 2018 AND DECEMBER 1, 2019 and
39 shall provide a copy of this report to the secretary of state.

40 C. The task force may hold hearings, conduct fact-finding tours and
41 take testimony from witnesses who may assist the task force in fulfilling
42 its responsibilities. All hearings of the task force shall be open to the
43 public.

1 D. The legislature shall provide staff and support services to the
2 task force.

3 E. Task force members are not eligible to receive compensation.

4 F. This section is repealed from and after ~~September 30, 2019~~
5 DECEMBER 31, 2019.
