SENATE BILL 1062

AN ACT

AMENDING TITLE 32, CHAPTER 32, ARTICLE 1, ARIZONA REVISED STATUTES, BY
ADDING SECTION 32-3226, ARIZONA REVISED STATUTES; AMENDING SECTION
32-3801, ARIZONA REVISED STATUTES; RELATING TO HEALTH PROFESSION
REGULATORY BOARDS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 32, chapter 32, article 1, Arizona Revised
3 Statutes, is amended by adding section 32-3226, to read:

4 32-3226. Address of record; disclosure; telephone number or
5 e-mail address; definition

6 A. A HEALTH PROFESSION REGULATORY BOARD SHALL HAVE, FOR EACH
7 LICENSEE UNDER THE BOARD'S REGULATION, AN ADDRESS OF RECORD DESIGNATED BY
8 THE LICENSEE THAT MAY BE DISCLOSED TO THE PUBLIC. IF THE LICENSEE
9 DESIGNATES THE LICENSEE'S RESIDENTIAL ADDRESS AS THE ADDRESS OF RECORD,
10 THE BOARD SHALL NOTIFY THE LICENSEE OF THE PUBLIC DISCLOSURE AND ALLOW THE
11 LICENSEE TO OPT OUT OF THE DISCLOSURE.

12 B. EACH LICENSEE WHO IS REQUIRED TO MAINTAIN PATIENT MEDICAL
13 RECORDS MUST HAVE ON FILE WITH THE LICENSEE'S HEALTH PROFESSION REGULATORY
14 BOARD A TELEPHONE NUMBER OR E-MAIL ADDRESS FOR THE BOARD TO PROVIDE TO A
15 PATIENT WHO IS SEEKING MEDICAL RECORDS.

16 C. A HEALTH PROFESSION REGULATORY BOARD SHALL DESIGNATE
17 ASSOCIATIONS OF LICENSED HEALTH PROFESSIONALS THAT MAY RECEIVE ON REQUEST
18 THE CONTACT INFORMATION AND ADDRESSES OF RECORD FOR ALL HEALTH
19 PROFESSIONALS UNDER THE BOARD'S REGULATION, INCLUDING HEALTH PROFESSIONALS
20 WHO HAVE OPTED OUT OF PUBLIC DISCLOSURE. AN ASSOCIATION OF LICENSED
21 HEALTH PROFESSIONS THAT RECEIVES CONTACT INFORMATION AND ADDRESSES OF
22 RECORD FROM A HEALTH PROFESSION REGULATORY BOARD MAY NOT TRANSFER OR SELL
23 THAT INFORMATION.

24 D. THIS SECTION DOES NOT PROHIBIT A HEALTH PROFESSION REGULATORY
25 BOARD FROM PROVIDING TO THE DEPARTMENT OF HEALTH SERVICES OR A UNIVERSITY
26 UNDER THE JURISDICTION OF THE ARIZONA BOARD OF REGENTS INFORMATION AND
27 DATA CONCERNING THE HEALTH PROFESSION REGULATORY BOARD'S LICENSEES FOR
28 RESEARCH PURPOSES IF THE INFORMATION AND DATA ARE NOT DISTRIBUTED TO THE
29 PUBLIC IN A FORMAT THAT INCLUDES A LICENSEE'S PERSONALLY IDENTIFIABLE
30 INFORMATION.

31 E. FOR THE PURPOSES OF THIS SECTION, "ADDRESS OF RECORD" MEANS
32 EITHER:

33 1. THE ADDRESS WHERE A HEALTH PROFESSIONAL PRACTICES THE PERSON'S
34 HEALTH PROFESSION OR IS OTHERWISE EMPLOYED.

35 2. THE HEALTH PROFESSIONAL'S RESIDENTIAL ADDRESS.

36 Sec. 2. Section 32-3801, Arizona Revised Statutes, is amended to
37 read:

38 32-3801. Personal information maintained by regulatory
39 entities; confidentiality

40 Notwithstanding any law to the contrary, EXCEPT AS PROVIDED IN
41 SECTION 32-3226, a professional's residential address and residential
42 telephone number or numbers maintained by a ~~professional board~~ REGULATORY
43 ENTITY established pursuant to this title are not available to the public
44 unless they are the only address and numbers of record.
