22 ACCREDITING ORGANIZATION APPROVED BY THE SECRETARY OF THE UNITED STATES
23 DEPARTMENT OF HEALTH AND HUMAN SERVICES.

1 2. THE FACILITY HAS NOT BEEN SUBJECT TO AN ENFORCEMENT ACTION
2 PURSUANT TO SECTION 36-427 OR 36-431.01 WITHIN THE YEAR PRECEDING THE
3 ANNUAL LICENSING FEE ANNIVERSARY DATE"

5 "Sec. 5. Emergency

6 This act is an emergency measure that is necessary to preserve the
7 public peace, health or safety and is operative immediately as provided by
8 law."
