AN ACT

AMENDING SECTION 41-1365, ARIZONA REVISED STATUTES; APPROPRIATING MONIES;
RELATING TO STATE MONUMENTS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 41-1365, Arizona Revised Statutes, is amended to
3 read:
4 41-1365. State monument and memorial repair fund; purpose;
5 report; exemption
6 A. The state monument and memorial repair fund is established
7 consisting of:
8 1. Donations.
9 2. Monies from fund-raising activities.
10 3. Monies that are collected by the proponents of a monument or
11 memorial and that are deposited pursuant to section 41-1363.
12 4. Grants received for monuments or memorials, except for otherwise
13 specifically dedicated grants.
14 5. Legislative appropriations.
15 B. The department of administration shall administer the fund. All
16 monies in the fund are subject to legislative appropriation. Subject to
17 this section, the department shall use monies appropriated from the fund
18 ~~for TO:~~
19 1. ~~The maintenance~~ MAINTAIN, repair, ~~reconditioning~~ RECONDITION or
20 ~~relocation of~~ RELOCATE monuments or memorials ~~and for~~.
21 2. ~~Supporting~~ SUPPORT mechanical equipment in the governmental
22 mall.
23 3. ALTER OR MODIFY THE ENDURING FREEDOM MEMORIAL TO ADD ADDITIONAL
24 NAMES TO THE MEMORIAL.
25 C. The department shall separately account for monies to a specific
26 monument or memorial that is dedicated to this state for maintenance,
27 repair, reconditioning or relocation of that monument or memorial as
28 follows:
29 1. Monies that are donated for the benefit of the specific monument
30 or memorial.
31 2. Monies that are derived from fund-raising activities and that
32 are collected for the benefit of a specific monument or memorial.
33 3. Monies that are collected and deposited pursuant to subsection
34 A, paragraph 3 of this section.
35 D. On or before November 1 of each year, the department of
36 administration shall submit to the joint legislative budget committee a
37 report that accounts for all monies deposited in the fund. The report
38 shall include the sources of the monies received for deposit, by category,
39 and the purposes for which the monies were used during the preceding
40 fiscal year.
41 E. The department of administration shall hold the monies in the
42 fund in trust for the citizens of this state until spent on an authorized
43 monument or memorial, and monies in the fund shall not be spent or
44 appropriated for any other purpose.

1 F. Monies in the fund are exempt from the provisions of section
2 35-190 relating to lapsing of appropriations.

3 Sec. 2. Appropriation; department of administration; Enduring
4 Freedom Memorial

5 The sum of \$21,422.91 is appropriated from the state monument and
6 memorial repair fund established by section 41-1365, Arizona Revised
7 Statutes, as added by this act, in fiscal year 2020-2021 to the department
8 of administration to alter or modify the Enduring Freedom Memorial to add
9 additional names to the memorial.
