AN ACT

REPEALING SECTIONS 41-3020.04, 41-3020.05 AND 41-3020.08, ARIZONA REVISED STATUTES; AMENDING TITLE 41, CHAPTER 27, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTIONS 41-3028.04, 41-3028.05 AND 41-3028.08; RELATING TO AGENCY CONTINUATION.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Repeal

3 Sections 41-3020.04, 41-3020.05 and 41-3020.08, Arizona Revised
4 Statutes, are repealed.

5 Sec. 2. Title 41, chapter 27, article 2, Arizona Revised Statutes,
6 is amended by adding sections 41-3028.04, 41-3028.05 and 41-3028.08, to
7 read:

8 41-3028.04. Arizona state library, archives and public
9 records; termination July 1, 2028

10 A. THE ARIZONA STATE LIBRARY, ARCHIVES AND PUBLIC RECORDS
11 TERMINATES ON JULY 1, 2028.

12 B. TITLE 41, CHAPTER 1, ARTICLE 2.1 AND THIS SECTION ARE REPEALED
13 ON JANUARY 1, 2029.

14 41-3028.05. State board on geographic and historic names;
15 termination July 1, 2028

16 A. THE STATE BOARD ON GEOGRAPHIC AND HISTORIC NAMES TERMINATES ON
17 JULY 1, 2028.

18 B. TITLE 41, CHAPTER 4.1, ARTICLE 3 AND THIS SECTION ARE REPEALED
19 ON JANUARY 1, 2029.

20 41-3028.08. Board of library examiners; termination July 1,
21 2028

22 A. THE BOARD OF LIBRARY EXAMINERS TERMINATES ON JULY 1, 2028.

23 B. SECTION 11-906 AND THIS SECTION ARE REPEALED ON JANUARY 1, 2029.

24 Sec. 3. Purpose

25 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
26 the legislature continues the Arizona state library, archives and public
27 records to provide library, archives and public records services to the
28 public.

29 Sec. 4. Purpose

30 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
31 the legislature continues the state board on geographic and historic names
32 to ensure that the historical record of this state is protected and
33 preserved.

34 Sec. 5. Purpose

35 Pursuant to section 41-2955, subsection B, Arizona Revised Statutes,
36 the legislature continues the board of library examiners to pass on the
37 qualifications of persons desiring to become county librarians.

38 Sec. 6. Retroactivity

39 Sections 1 and 2 of this act apply retroactively to from and after
40 July 1, 2020.
