AN ACT

AMENDING TITLE 41, CHAPTER 14, ARIZONA REVISED STATUTES, BY ADDING ARTICLE 6; RELATING TO THE DEPARTMENT OF ECONOMIC SECURITY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 41, chapter 14, Arizona Revised Statutes, is
3 amended by adding article 6, to read:

4 ARTICLE 6. OFFICE OF NEW AMERICANS

5 41-2031. Office of new Americans; duties

6 A. THE OFFICE OF NEW AMERICANS IS ESTABLISHED WITHIN THE
7 DEPARTMENT.

8 B. THE OFFICE SHALL:

9 1. RESPOND TO INQUIRES FROM STATE AGENCIES, THE MEDIA,
10 IMMIGRATION-SERVING ORGANIZATIONS AND THE PUBLIC REGARDING IMMIGRATION
11 ISSUES IN THIS STATE.

12 2. SERVE AS THE POINT OF CONTACT FOR STATE LICENSING BOARDS AND AS
13 AN INFORMATION CLEARINGHOUSE FOR STATE AGENCIES ON IMMIGRATION-RELATED
14 POLICY ISSUES AND COORDINATE AMONG STATE AGENCIES AS APPROPRIATE.

15 3. ANALYZE ECONOMIC AND DEMOGRAPHIC TRENDS AND MAKE POLICY
16 RECOMMENDATIONS TO THE GOVERNOR.

17 4. DEVELOP STRATEGIES TO ATTRACT, RETAIN AND INCORPORATE IMMIGRANTS
18 INTO THIS STATE.

19 5. ENSURE THAT THIS STATE IS GATHERING RELEVANT DATA TO INFORM ITS
20 POLICYMAKERS ON IMMIGRANT ISSUES.

21 6. CONVENE STAKEHOLDERS IN BUSINESS DEVELOPMENT AND INTERNATIONAL
22 TRADE PROMOTION PROGRAMS TO INCREASE THEIR CAPACITY TO DRAW ON IMMIGRANT
23 CONTRIBUTORS.

24 7. DISSEMINATE INFORMATION TO NEW AND PROSPECTIVE IMMIGRANT
25 RESIDENTS OF THIS STATE WHO WISH TO INVEST CAPITAL, LAUNCH BUSINESSES OR
26 APPLY THEIR SKILLS IN THIS STATE.

27 8. CONVENE MUNICIPAL OFFICIALS TO BOOST PEER LEARNING ON
28 IMMIGRATION POSSIBILITIES AMONG CITIES AND TOWNS STRUGGLING WITH
29 POPULATION LOSS AND ECONOMIC DECLINE.

30 9. CONVENE COLLEGE AND UNIVERSITY OFFICIALS TO FOSTER LEARNING ON
31 STRATEGIES FOR IMMIGRANT AND INTERNATIONAL STUDENT RETENTION.

32 10. PROVIDE MATCHING GRANTS FOR HIGH-QUALITY IMMIGRATION AND
33 ECONOMIC DEVELOPMENT PROGRAMS THAT CAN DEMONSTRATE CORPORATE OR
34 PHILANTHROPIC INVESTMENT.

35 11. EVALUATE SUCCESS OF ACTIVITIES AND ADJUST COURSES AS
36 APPROPRIATE.

37 41-2031.01. Advisory committee to the office of new
38 Americans; membership; duties; committee
39 termination

40 A. THE ADVISORY COMMITTEE TO THE OFFICE OF NEW AMERICANS IS
41 ESTABLISHED WITHIN THE OFFICE AND SHALL SERVE IN AN ADVISORY CAPACITY TO
42 THE OFFICE IN MATTERS REGARDING IMMIGRANTS IN THIS STATE. THE OFFICE
43 SHALL STAFF AND ADMINISTER THE COMMITTEE.

1 B. THE COMMITTEE CONSISTS OF THE FOLLOWING MEMBERS:
2 1. THE DIRECTOR OF THE DEPARTMENT OF ECONOMIC SECURITY OR THE
3 DIRECTOR'S DESIGNEE. THE DIRECTOR SHALL SERVE AS CHAIRPERSON OF THE
4 COMMITTEE.
5 2. THE DIRECTOR OF THE DEPARTMENT OF ADMINISTRATION OR THE
6 DIRECTOR'S DESIGNEE.
7 3. THE SUPERINTENDENT OF PUBLIC INSTRUCTION OR THE SUPERINTENDENT'S
8 DESIGNEE.
9 4. THE DIRECTOR OF THE DEPARTMENT OF HEALTH SERVICES OR THE
10 DIRECTOR'S DESIGNEE.
11 5. THE CHIEF EXECUTIVE OFFICER OF THE ARIZONA COMMERCE AUTHORITY OR
12 THE CHIEF EXECUTIVE OFFICER'S DESIGNEE.
13 6. THE DIRECTOR OF THE DEPARTMENT OF TRANSPORTATION OR THE
14 DIRECTOR'S DESIGNEE.
15 7. THE DIRECTOR OF THE DEPARTMENT OF PUBLIC SAFETY OR THE
16 DIRECTOR'S DESIGNEE.
17 8. TWO MEMBERS FROM AN ORGANIZATION THAT ATTRACTS, RETAINS AND
18 INTEGRATES IMMIGRANTS INTO THIS STATE. THE GOVERNOR SHALL APPOINT THIS
19 MEMBER.
20 9. ONE MEMBER OF AN IMMIGRATION LAWYERS ASSOCIATION. THE GOVERNOR
21 SHALL APPOINT THIS MEMBER.
22 10. ONE MEMBER FROM AN INSTITUTION OF HIGHER EDUCATION WHO HAS A
23 PRIMARY FOCUS ON IMMIGRATION ISSUES. THE GOVERNOR SHALL APPOINT THIS
24 MEMBER.
25 11. ONE MEMBER FROM A CHAMBER OF COMMERCE. THE GOVERNOR SHALL
26 APPOINT THIS MEMBER.
27 12. ONE MEMBER WITH EXPERTISE IN ACCESSING LANGUAGE RESOURCES FOR
28 THOSE WHO USE ENGLISH AS A SECOND LANGUAGE. THE GOVERNOR SHALL APPOINT
29 THIS MEMBER.
30 13. ONE MEMBER FROM THE BANKING INDUSTRY. THE GOVERNOR SHALL
31 APPOINT THIS MEMBER.
32 14. ONE MEMBER FROM A WORKFORCE TRAINING AGENCY. THE GOVERNOR
33 SHALL APPOINT THIS MEMBER.
34 15. ONE MEMBER FROM THE HEALTH CARE INDUSTRY. THE GOVERNOR SHALL
35 APPOINT THIS MEMBER.
36 16. ONE MEMBER FROM THE HEALTH INSURANCE INDUSTRY. THE GOVERNOR
37 SHALL APPOINT THIS MEMBER.
38 17. ONE MEMBER FROM A HUMAN SERVICES AGENCY. THE GOVERNOR SHALL
39 APPOINT THIS MEMBER.
40 18. ONE MEMBER FROM A REFUGEE RESETTLEMENT AGENCY. THE GOVERNOR
41 SHALL APPOINT THIS MEMBER.
42 C. MEMBERS WHO ARE APPOINTED PURSUANT TO SUBSECTION B, PARAGRAPHS 8
43 THROUGH 18 SERVE THREE-YEAR TERMS AS LONG AS THEY REPRESENT THE INTEREST
44 OF THE MEMBERSHIP CLASS FOR WHICH THEY WERE APPOINTED.

1 D. COMMITTEE MEMBERS ARE NOT ELIGIBLE TO RECEIVE COMPENSATION, BUT
2 MEMBERS APPOINTED BY THE GOVERNOR ARE ELIGIBLE FOR REIMBURSEMENT OF
3 EXPENSES UNDER TITLE 38, CHAPTER 4, ARTICLE 2.
4 E. THE COMMITTEE SHALL:
5 1. MAKE RECOMMENDATIONS TO THE GOVERNOR AND THE DIRECTOR ON
6 POLICIES, PROCEDURES, REGULATIONS AND LEGISLATION THAT HELP ATTRACT,
7 RETAIN AND INTEGRATE IMMIGRANTS INTO THIS STATE.
8 2. SERVE AS THE GOVERNOR'S LIAISON TO NEW AMERICANS ON POLICIES,
9 PROCEDURES, REGULATIONS AND LEGISLATION THAT AFFECT IMMIGRANTS, IN ORDER
10 TO ENSURE THAT STATE GOVERNMENT IS ACCESSIBLE, ACCOUNTABLE AND RESPONSIVE
11 TO THEIR NEEDS.
12 3. SERVE AS A RESOURCE TO ALL AGENCIES, COMMISSIONS AND BOARDS TO
13 ENSURE THAT THESE GOVERNMENT ENTITIES ARE COGNIZANT OF THE NEEDS OF
14 IMMIGRANTS AND THAT THEIR RESPECTIVE SERVICES AND PROGRAMS ARE ACCESSIBLE
15 TO IMMIGRANTS.
16 4. WORK WITH THE OFFICE TO MONITOR THE PRACTICES OF STATE AGENCIES
17 RELATING TO ATTRACTING, RETAINING AND INTEGRATING IMMIGRANTS IN ORDER TO
18 MAXIMIZE THE EFFICIENCY OF AND ACCESSIBILITY TO STATE GOVERNMENT.
19 5. PERFORM OTHER DUTIES AS THE GOVERNOR AND DIRECTOR MAY ASSIGN IN
20 PLANNING FOR SERVICES AND PROGRAMS FOR IMMIGRANTS.
21 F. THE COMMITTEE MAY CONDUCT STUDIES AND ISSUE REPORTS ON REQUEST,
22 AND AS IT DEEMS NECESSARY, ON ISSUES AFFECTING IMMIGRANTS.
23 G. THE COMMITTEE SHALL CONDUCT AT LEAST ONE PUBLIC HEARING EACH
24 YEAR TO RECEIVE TESTIMONY AND PUBLIC COMMENTS ON HOW STATE GOVERNMENT CAN
25 IMPROVE IN ATTRACTING, RETAINING AND INTEGRATING IMMIGRANTS IN THIS STATE.
26 H. THE COMMITTEE MAY ESTABLISH AD HOC WORK GROUPS OR LOCAL
27 COMMITTEES TO ASSIST IN RESEARCH AND OTHER DUTIES NECESSARY TO CARRY OUT
28 THE MISSION OF THE OFFICE.
29 I. THE COMMITTEE ESTABLISHED BY THIS SECTION ENDS ON JULY 1, 2028
30 PURSUANT TO SECTION 41-3103.
