**CHAPTER 83**  
**SENATE BILL 1446**

AN ACT

AMENDING TITLE 15, CHAPTER 1, ARTICLE 5, ARIZONA REVISED STATUTES, BY  
ADDING SECTION 15-160; AMENDING TITLE 15, CHAPTER 14, ARIZONA REVISED  
STATUTES, BY ADDING ARTICLE 14; RELATING TO STUDENT SAFETY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 15, chapter 1, article 5, Arizona Revised  
3 Statutes, is amended by adding section 15-160, to read:

4 15-160. Student identification cards; suicide prevention;  
5 contact information required

6 A. BEGINNING JULY 1, 2021, IF A SCHOOL DISTRICT GOVERNING BOARD OR  
7 CHARTER SCHOOL GOVERNING BODY ISSUES IDENTIFICATION CARDS TO STUDENTS IN  
8 GRADES NINE THROUGH TWELVE, THE SCHOOL DISTRICT GOVERNING BOARD OR CHARTER  
9 SCHOOL GOVERNING BODY SHALL INCLUDE AT LEAST ONE OF THE FOLLOWING ON EACH  
10 NEW IDENTIFICATION CARD ISSUED TO A STUDENT IN GRADE NINE THROUGH TWELVE:

11 1. THE TELEPHONE NUMBER FOR A NATIONAL SUICIDE PREVENTION LIFELINE.  
12 2. THE TELEPHONE NUMBER FOR A NATIONAL NETWORK OF LOCAL CRISIS  
13 CENTERS.

14 3. A STATEMENT DESCRIBING HOW TO ACCESS A TEXT-BASED EMOTIONAL  
15 SUPPORT SERVICE.

16 4. THE TELEPHONE NUMBER FOR A LOCAL SUICIDE PREVENTION HOTLINE.

17 B. A SCHOOL DISTRICT GOVERNING BOARD OR CHARTER SCHOOL GOVERNING  
18 BODY MAY INCLUDE THE INFORMATION DESCRIBED IN SUBSECTION A OF THIS SECTION  
19 ON STUDENT IDENTIFICATION CARDS BY PRINTING THE INFORMATION ON, OR BY  
20 AFFIXING A STICKER THAT CONTAINS THE INFORMATION TO, THE IDENTIFICATION  
21 CARDS.

22 Sec. 2. Title 15, chapter 14, Arizona Revised Statutes, is amended  
23 by adding article 14, to read:

24 ARTICLE 14. SAFETY REQUIREMENTS

25 15-1899. Student identification cards; suicide prevention;  
26 contact information required; definition

27 A. BEGINNING JULY 1, 2021, IF AN INSTITUTION OF HIGHER EDUCATION  
28 ISSUES IDENTIFICATION CARDS TO STUDENTS, THE INSTITUTION OF HIGHER  
29 EDUCATION SHALL INCLUDE ON EACH NEW IDENTIFICATION CARD ISSUED TO A  
30 STUDENT AT LEAST ONE OF THE FOLLOWING:

31 1. THE TELEPHONE NUMBER FOR A NATIONAL SUICIDE PREVENTION LIFELINE.  
32 2. THE TELEPHONE NUMBER FOR A NATIONAL NETWORK OF LOCAL CRISIS  
33 CENTERS.

34 3. A STATEMENT DESCRIBING HOW TO ACCESS A TEXT-BASED EMOTIONAL  
35 SUPPORT SERVICE.

36 4. THE TELEPHONE NUMBER FOR A LOCAL SUICIDE PREVENTION HOTLINE.

37 B. AN INSTITUTION OF HIGHER EDUCATION MAY INCLUDE THE INFORMATION  
38 DESCRIBED IN SUBSECTION A OF THIS SECTION ON STUDENT IDENTIFICATION CARDS  
39 BY PRINTING THE INFORMATION ON, OR BY AFFIXING A STICKER THAT CONTAINS THE  
40 INFORMATION TO, THE IDENTIFICATION CARDS.

41 C. FOR THE PURPOSES OF THIS SECTION, "INSTITUTION OF HIGHER  
42 EDUCATION" MEANS BOTH:

43 1. A UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF  
44 REGENTS.

45 2. A COMMUNITY COLLEGE AS DEFINED IN SECTION 15-1401.
