**CHAPTER 28**  
**SENATE BILL 1061**

AN ACT

AMENDING SECTIONS 28-2351 AND 28-2403, ARIZONA REVISED STATUTES; AMENDING TITLE 28, CHAPTER 7, ARTICLE 12, ARIZONA REVISED STATUTES, BY ADDING SECTION 28-2470.10; AMENDING SECTIONS 28-6501, 28-6991, 28-6993 AND 41-608, ARIZONA REVISED STATUTES; RELATING TO SPECIAL PLATES.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 28-2351, Arizona Revised Statutes, is amended to  
3 read:

4 28-2351. License plate provided; design

5 A. Notwithstanding any other law, the department shall provide to  
6 every owner one license plate for each vehicle registered. At the request  
7 of the owner and on payment of a fee in an amount prescribed by the  
8 director by rule, the department shall provide one additional license  
9 plate for a vehicle for which a special plate is requested pursuant to  
10 this chapter.

11 B. The license plate shall display the number assigned to the  
12 vehicle and to the owner of the vehicle and the name of this state, which  
13 may be abbreviated. The director shall coat the license plate with a  
14 reflective material that is consistent with the determination of the  
15 department regarding the color and design of license plates and special  
16 plates. The director shall design the license plate and the letters and  
17 numerals on the license plate to be of sufficient size to be plainly  
18 readable during daylight from a distance of one hundred feet. In addition  
19 to the standard license plate issued for a trailer before August 12, 2005,  
20 the director shall issue a license plate for trailers that has a design  
21 that is similar to the standard size license plate for trailers but that  
22 is the same size as the license plate for motorcycles. The trailer owner  
23 shall notify the department which size license plate the owner wants for  
24 the trailer.

25 C. Notwithstanding any other law, the department shall not contract  
26 with a nongovernmental entity to purchase or secure reflective material  
27 for the plates issued by the department unless the department has made a  
28 reasonable effort to secure qualified bids or proposals from as many  
29 individual responsible respondents as possible.

30 D. The department shall determine the color and design of the  
31 license plate. All other plates issued by the department, except the  
32 plates issued pursuant to sections 28-2404, 28-2412, 28-2413, 28-2414,  
33 28-2416, 28-2416.01, 28-2417 through ~~28-2470.09~~ 28-2470.10, 28-2472,  
34 28-2473, 28-2474, 28-2475, 28-2476 and 28-4533 and article 14 of this  
35 chapter, shall be the same color as and similar in design to the license  
36 plate as determined by the department.

37 E. A passenger motor vehicle that is rented without a driver shall  
38 receive the same type of license plate as is issued for a private  
39 passenger motor vehicle.

40 Sec. 2. Section 28-2403, Arizona Revised Statutes, is amended to  
41 read:

42 28-2403. Special plates; transfers; violation; classification

43 A. Except as otherwise provided in this article, the department  
44 shall issue or renew special plates in lieu of the regular license plates  
45 pursuant to the following conditions and procedures and only if the

1 requirements prescribed by this article for the requested special plates  
2 are met:

3 1. Except as provided in sections 28-2416 and 28-2416.01, a person  
4 who is the registered owner of a vehicle registered with the department or  
5 who applies for an original or renewal registration of a vehicle may  
6 submit to the department a completed application form as prescribed by the  
7 department with the fee prescribed by section 28-2402 for special plates  
8 in addition to the registration fee prescribed by section 28-2003.

9 2. Except for plates issued pursuant to sections 28-2404, 28-2412,  
10 28-2413, 28-2414, 28-2416, 28-2416.01, 28-2417 through ~~28-2470.09~~  
11 ~~28-2470.10~~, 28-2472, 28-2473, 28-2474, 28-2475 and 28-2476 and article 14  
12 of this chapter, the special plates shall be the same color as and similar  
13 to the design of the regular license plates that is determined by the  
14 department.

15 3. Except as provided in section 28-2416, the department shall  
16 issue special plates only to the owner or lessee of a vehicle that is  
17 currently registered, including any vehicle that has a declared gross  
18 weight, as defined in section 28-5431, of twenty-six thousand pounds or  
19 less.

20 4. Except as provided in sections 28-2416 and 28-2416.01, the  
21 department shall charge the fee prescribed by section 28-2402 for each  
22 annual renewal of special plates in addition to the registration fee  
23 prescribed by section 28-2003.

24 B. Except as provided in sections 28-2416 and 28-2416.01, on  
25 notification to the department and on payment of the transfer fee  
26 prescribed by section 28-2402, a person who is issued special plates may  
27 transfer the special plates to another vehicle the person owns or leases.  
28 Persons who are issued special plates for hearing impaired persons  
29 pursuant to section 28-2408 and international symbol of access special  
30 plates pursuant to section 28-2409 are exempt from the transfer fee. If a  
31 person who is issued special plates sells, trades or otherwise releases  
32 ownership of the vehicle on which the plates have been displayed, the  
33 person shall immediately report the transfer of the plates to the  
34 department or the person shall surrender the plates to the department as  
35 prescribed by the director. It is unlawful for a person to whom the  
36 plates have been issued to knowingly allow them to be displayed on a  
37 vehicle except the vehicle authorized by the department.

38 C. The special plates shall be affixed to the vehicle for which  
39 registration is sought in lieu of the regular license plates.

40 D. A person is guilty of a class 3 misdemeanor who:

41 1. Violates subsection B of this section.

42 2. Fraudulently gives false or fictitious information in the  
43 application for or renewal of special plates or placards issued pursuant  
44 to this article.

1           3. Conceals a material fact or otherwise commits fraud in the  
2 application for or renewal of special plates or placards issued pursuant  
3 to this article.

4           Sec. 3. Title 28, chapter 7, article 12, Arizona Revised Statutes,  
5 is amended by adding section 28-2470.10, to read:

6           28-2470.10. Army scholarship special plates; fund

7           A. IF, BY DECEMBER 31, 2022, A PERSON PAYS \$32,000 TO THE  
8 DEPARTMENT FOR THE IMPLEMENTATION OF THIS SECTION, THE DEPARTMENT SHALL  
9 ISSUE ARMY SCHOLARSHIP SPECIAL PLATES. THE PERSON THAT PROVIDES THE  
10 \$32,000 SHALL DESIGN THE ARMY SCHOLARSHIP SPECIAL PLATES. THE DESIGN AND  
11 COLOR OF THE ARMY SCHOLARSHIP SPECIAL PLATES ARE SUBJECT TO THE APPROVAL  
12 OF THE DEPARTMENT. THE DIRECTOR MAY ALLOW A REQUEST FOR ARMY SCHOLARSHIP  
13 SPECIAL PLATES TO BE COMBINED WITH A REQUEST FOR PERSONALIZED SPECIAL  
14 PLATES. IF THE DIRECTOR ALLOWS SUCH A COMBINATION, THE REQUEST SHALL BE  
15 IN A FORM PRESCRIBED BY THE DIRECTOR AND IS SUBJECT TO THE FEES FOR THE  
16 PERSONALIZED SPECIAL PLATES IN ADDITION TO THE FEES REQUIRED FOR THE ARMY  
17 SCHOLARSHIP SPECIAL PLATES.

18           B. OF THE \$25 FEE REQUIRED BY SECTION 28-2402 FOR THE ORIGINAL  
19 SPECIAL PLATES AND FOR RENEWAL OF SPECIAL PLATES, \$8 IS A SPECIAL PLATE  
20 ADMINISTRATION FEE AND \$17 IS AN ANNUAL DONATION.

21           C. THE DEPARTMENT SHALL DEPOSIT, PURSUANT TO SECTIONS 35-146 AND  
22 35-147, ALL SPECIAL PLATE ADMINISTRATION FEES IN THE STATE HIGHWAY FUND  
23 ESTABLISHED BY SECTION 28-6991 AND ALL DONATIONS COLLECTED PURSUANT TO  
24 THIS SECTION IN THE VETERANS' DONATIONS FUND ESTABLISHED BY SECTION  
25 41-608.

26           Sec. 4. Section 28-6501, Arizona Revised Statutes, is amended to  
27 read:

28           28-6501. Definition of highway user revenues

29           In this article, unless the context otherwise requires or except as  
30 otherwise provided by statute, "highway user revenues" means all monies  
31 received in this state from licenses, taxes, penalties, interest and fees  
32 authorized by the following:

33           1. Chapters 2, 7, 8 and 15 of this title, except for:

34           (a) The special plate administration fees prescribed in sections  
35 28-2404, 28-2407, 28-2412 through ~~28-2470.09~~ 28-2470.10 and 28-2514.

36           (b) The donations prescribed in sections 28-2404, 28-2407, 28-2412  
37 through 28-2415, 28-2417 through ~~28-2470.09~~ 28-2470.10, 28-2473, 28-2474,  
38 28-2475 and 28-2476.

39           2. Section 28-1177.

40           3. Chapters 10 and 11 of this title.

41           4. Chapter 16, articles 1, 2 and 4 of this title, except as  
42 provided in sections 28-5926 and 28-5927.

1           Sec. 5. Section 28-6991, Arizona Revised Statutes, is amended to  
2 read:

3           28-6991. State highway fund; sources

4           The state highway fund is established that consists of:

5           1. Monies distributed from the Arizona highway user revenue fund  
6 pursuant to chapter 18 of this title.

7           2. Monies appropriated by the legislature.

8           3. Monies received from donations for the construction, improvement  
9 or maintenance of state highways or bridges. These monies shall be  
10 credited to a special account and shall be spent only for the purpose  
11 indicated by the donor.

12           4. Monies received from counties or cities under cooperative  
13 agreements, including proceeds from bond issues. The state treasurer  
14 shall deposit these monies to the credit of the fund in a special account  
15 on delivery to the treasurer of a concise written agreement between the  
16 department and the county or city stating the purposes for which the  
17 monies are surrendered by the county or city, and these monies shall be  
18 spent only as stated in the agreement.

19           5. Monies received from the United States under an act of Congress  
20 to provide aid for the construction of rural post roads, but monies  
21 received on projects for which the monies necessary to be provided by this  
22 state are wholly derived from sources mentioned in paragraphs 2 and 3 of  
23 this section shall be allotted by the department and deposited by the  
24 state treasurer in the special account within the fund established for  
25 each project. On completion of the project, on the satisfaction and  
26 discharge in full of all obligations of any kind created and on request of  
27 the department, the treasurer shall transfer the unexpended balance in the  
28 special account for the project into the state highway fund, and the  
29 unexpended balance and any further federal aid thereafter received on  
30 account of the project may be spent under the general provisions of this  
31 title.

32           6. Monies in the custody of an officer or agent of this state from  
33 any source that is to be used for the construction, improvement or  
34 maintenance of state highways or bridges.

35           7. Monies deposited in the state general fund and arising from the  
36 disposal of state personal property belonging to the department.

37           8. Receipts from the sale or disposal of any or all other property  
38 held by the department and purchased with state highway monies.

39           9. Monies generated pursuant to section 28-410.

40           10. Monies distributed pursuant to section 28-5808, subsection B,  
41 paragraph 2, subdivision (d).

42           11. Monies deposited pursuant to sections 28-1143, 28-2353 and  
43 28-3003.

1 12. Except as provided in section 28-5101, the following monies:

2 (a) Monies deposited pursuant to section 28-2206 and section  
3 28-5808, subsection B, paragraph 2, subdivision (e).

4 (b) \$1 of each registration fee and \$1 of each title fee collected  
5 pursuant to section 28-2003.

6 (c) \$2 of each late registration penalty collected by the director  
7 pursuant to section 28-2162.

8 (d) The air quality compliance fee collected pursuant to section  
9 49-542.

10 (e) The special plate administration fees collected pursuant to  
11 sections 28-2404, 28-2407, 28-2412 through 28-2416, 28-2416.01, 28-2417  
12 through ~~28-2470-09~~ 28-2470.10 and 28-2514.

13 (f) Monies collected pursuant to sections 28-372, 28-2155 and  
14 28-2156 if the director is the registering officer.

15 13. Monies deposited pursuant to chapter 5, article 5 of this  
16 title.

17 14. Donations received pursuant to section 28-2269.

18 15. Dealer and registration monies collected pursuant to section  
19 28-4304.

20 16. Abandoned vehicle administration monies deposited pursuant to  
21 section 28-4804.

22 17. Monies deposited pursuant to section 28-710, subsection D,  
23 paragraph 2.

24 18. Monies deposited pursuant to section 28-2065.

25 19. Monies deposited pursuant to section 28-7311.

26 20. Monies deposited pursuant to section 28-7059.

27 21. Monies deposited pursuant to section 28-1105.

28 22. Monies deposited pursuant to section 28-2448, subsection D.

29 23. Monies deposited pursuant to section 28-3415.

30 24. Monies deposited pursuant to section 28-3002, subsection A,  
31 paragraph 14.

32 25. Monies deposited pursuant to section 28-7316.

33 26. Monies deposited pursuant to section 28-4302.

34 27. Monies deposited pursuant to section 28-3416.

35 28. Monies deposited pursuant to section 28-4504.

36 29. Monies deposited pursuant to section 28-2098.

37 30. Monies deposited pursuant to sections 28-2321, 28-2324,

39 Sec. 6. Section 28-6993, Arizona Revised Statutes, is amended to  
40 read:

41 28-6993. State highway fund; authorized uses

42 A. Except as provided in subsection B of this section and section  
43 28-6538, the state highway fund shall be used for any of the following  
44 purposes in strict conformity with and subject to the budget as provided  
45 by this section and by sections 28-6997 through 28-7003:

- 1           1. To pay salaries, wages, necessary travel expenses and other  
2 expenses of officers and employees of the department and the incidental  
3 office expenses, including telegraph, telephone, postal and express  
4 charges and printing, stationery and advertising expenses.
- 5           2. To pay for both:
  - 6           (a) Equipment, supplies, machines, tools, department offices and  
7 laboratories established by the department.
  - 8           (b) The construction and repair of buildings or yards of the  
9 department.
- 10          3. To pay the cost of both:
  - 11          (a) Engineering, construction, improvement and maintenance of state  
12 highways and parts of highways forming state routes.
  - 13          (b) Highways under cooperative agreements with the United States  
14 that are entered into pursuant to this chapter and an act of Congress  
15 providing for the construction of rural post roads.
- 16          4. To pay land damages incurred by reason of establishing, opening,  
17 altering, relocating, widening or abandoning portions of a state route or  
18 state highway.
- 19          5. To reimburse the department revolving account.
- 20          6. To pay premiums on authorized indemnity bonds and on  
21 compensation insurance under the workers' compensation act.
- 22          7. To defray lawful expenses and costs required to administer and  
23 carry out the intent, purposes and provisions of this title, including  
24 repayment of obligations entered into pursuant to this title, payment of  
25 interest on obligations entered into pursuant to this title, repayment of  
26 loans and other financial assistance, including repayment of advances and  
27 interest on advances made to the department pursuant to section 28-7677,  
28 and payment of all other obligations and expenses of the board and  
29 department pursuant to chapter 21 of this title.
- 30          8. To pay lawful bills and charges incurred by the state engineer.
- 31          9. To acquire, construct or improve entry roads to state parks or  
32 roads within state parks.
- 33          10. To acquire, construct or improve entry roads to state prisons.
- 34          11. To pay the cost of relocating a utility facility pursuant to  
35 section 28-7156.
- 36          12. For the purposes provided in subsections C, D and E of this  
37 section and sections 28-1143, 28-2353 and 28-3003.
- 38          13. To pay the cost of issuing an Arizona centennial special plate  
39 pursuant to section 28-2448.
- 40          14. To pay for all of the following:
  - 41          (a) The enforcement by the department of public safety and the  
42 department of transportation of vehicle safety requirements within  
43 twenty-five miles of the border between this state and Mexico.
  - 44          (b) Costs related to procuring electronic equipment, automated  
45 systems or improvements to existing electronic equipment or automated

1 systems for relieving vehicle congestion at ports of entry on the border  
2 between this state and Mexico.

3 (c) Constructing, maintaining and upgrading transportation  
4 facilities, including roads, streets and highways, approved by the board  
5 within twenty-five miles of the border between this state and Mexico.

6 (d) As approved by the board, constructing and maintaining  
7 transportation facilities in the CANAMEX high priority corridor as defined  
8 in section 332 of the national highway system designation act of 1995  
9 (P.L. 104-59; 109 Stat. 568).

10 (e) Activities of the department that include collecting  
11 transportation and trade data in the United States and Mexico for the  
12 purposes of constructing transportation facilities, improving public  
13 safety, improving truck processing time and relieving congestion at ports  
14 of entry on the border between this state and Mexico. The department may  
15 enter into an agreement with the Arizona-Mexico commission and provide  
16 funding to the commission for the purposes of this subdivision.

17 (f) A commitment or investment necessary for the department or  
18 another agency of this state to obtain federal monies that are designated  
19 for expenditure pursuant to this section.

20 B. For each fiscal year, the department of transportation shall  
21 allocate and transfer monies in the state highway fund to the department  
22 of public safety for funding a portion of highway patrol costs in eight  
23 installments in each of the first eight months of a fiscal year that do  
24 not exceed \$10,000,000.

25 C. Subject to legislative appropriation, the department may use the  
26 monies in the state highway fund as prescribed in section 28-6991,  
27 paragraph 12 to carry out the duties imposed by this title for  
28 registration or titling of vehicles, to operate joint title, registration  
29 and driver licensing offices, to cover the administrative costs of issuing  
30 the air quality compliance sticker, modifying the year validating tab and  
31 issuing the windshield sticker and to cover expenses and costs in issuing  
32 special plates pursuant to sections 28-2404, 28-2407, 28-2412 through  
33 ~~28-2470.09~~ 28-2470.10 and 28-2514.

34 D. The department shall use monies deposited in the state highway  
35 fund pursuant to chapter 5, article 5 of this title only as prescribed by  
36 that article.

37 E. Monies deposited in the state highway fund pursuant to section  
38 28-2269 shall be used only as prescribed by that section.

39 F. Monies deposited in the state highway fund pursuant to section  
40 28-710, subsection D, paragraph 2 shall only be used for state highway  
41 work zone traffic control devices.

42 G. The department may exchange monies distributed to the state  
43 highway fund pursuant to section 28-6538, subsection A, paragraph 1 for  
44 local government surface transportation program federal monies  
45 suballocated to councils of government and metropolitan planning



1 organizations if the local government scheduled to receive the federal  
2 monies concurs. An exchange of state highway fund monies pursuant to this  
3 subsection shall be in an amount that is at least equal to ninety percent  
4 of the federal obligation authority that exists in the project for which  
5 the exchange is proposed.

6 H. The department shall use monies deposited in the state highway  
7 fund pursuant to section 28-1105, subsection A, paragraph 2, subdivision  
8 (a) only for a transportation facility that is located within twenty  
9 drivable miles of the international port of entry and shall spend the  
10 monies proportionally based on the amount of total monies collected  
11 pursuant to section 28-1105, subsection A, paragraph 2, subdivision (a).  
12 For the purposes of this subsection, "transportation facility" means a  
13 highway or a state route or a county, city or town road that is used by a  
14 commercial vehicle or a commercial vehicle combination for which an axle  
15 fee is paid pursuant to section 28-5474.

16 Sec. 7. Section 41-608, Arizona Revised Statutes, is amended to  
17 read:

18 41-608. Veterans' donations fund; grants

19 A. The veterans' donations fund is established consisting of  
20 monies, gifts and contributions donated to the department and monies  
21 deposited pursuant to sections 28-2414, 28-2428, 28-2431, 28-2447,  
22 28-2454, 28-2470.10, 28-2473, 28-2474, 28-2475, 28-2476 and 43-620. The  
23 department shall administer the fund. Monies in the fund are continuously  
24 appropriated. The monies in the fund are exempt from the provisions of  
25 section 35-190 relating to lapsing of appropriations. The department  
26 shall adopt rules or policies for grants of less than \$5,000 that  
27 encourage as much competition as practicable.

28 B. The director or the director's designee may solicit and receive  
29 donations, including in-kind donations, from the public for veterans. The  
30 director shall deposit, pursuant to sections 35-146 and 35-147, the  
31 monetary donations in the veterans' donations fund. Monies in the fund  
32 are subject to state auditing procedures. Except for monies deposited  
33 pursuant to sections 28-2431 and 28-2447, the donations may be used for  
34 the benefit of the veterans within this state as grants, subject to  
35 chapter 24 of this title, if applicable.

36 C. The director shall establish a separate subaccount in the  
37 veterans' donations fund for the deposit of monies received pursuant to  
38 section 28-2431, subsection C. The monies in the subaccount shall be used  
39 for the construction and maintenance of the enduring freedom memorial  
40 authorized pursuant to section 41-1363 for placement in Wesley Bolin  
41 Plaza.

42 D. The director shall establish a separate subaccount in the  
43 veterans' donations fund for the deposit of monies received pursuant to  
44 section 28-2447, subsection F. The monies in the subaccount shall be used  
45 for the benefit of women veterans in this state, including providing

1 shelter to homeless women veterans as grants, subject to chapter 24 of  
2 this title, if applicable.

3 E. The director shall establish a separate subaccount in the  
4 veterans' donations fund for the deposit of monies received pursuant to  
5 section 28-2454, subsection C. The first \$32,000 in the subaccount shall  
6 be reimbursed to the person that provides the \$32,000 pursuant to section  
7 28-2454, subsection A. The director shall annually allocate monies from  
8 the subaccount to a foundation that is qualified under section 501(c)(3)  
9 of the United States internal revenue code for federal income tax purposes  
10 and that is the nation's oldest and largest provider of need-based  
11 scholarships to children of United States military members. The  
12 foundation must:

- 13 1. Have been in existence for at least fifty-two years.
- 14 2. Have provided more than thirty-three thousand scholarships that  
15 are valued at almost \$90,000,000.
- 16 3. Have a mission that includes honoring marines and educating  
17 their children.
- 18 4. Award scholarship monies to children of marines and navy  
19 corpsmen who were killed or wounded in combat or who have demonstrated  
20 financial need.

21 F. THE DIRECTOR SHALL ESTABLISH A SEPARATE SUBACCOUNT IN THE  
22 VETERANS' DONATIONS FUND FOR THE DEPOSIT OF MONIES RECEIVED PURSUANT TO  
23 SECTION 28-2470.10, SUBSECTION C. THE FIRST \$32,000 IN THE SUBACCOUNT  
24 SHALL BE REIMBURSED TO THE PERSON THAT PROVIDES THE \$32,000 PURSUANT TO  
25 SECTION 28-2470.10, SUBSECTION A. THE DIRECTOR SHALL ANNUALLY ALLOCATE  
26 MONIES FROM THE SUBACCOUNT TO A FOUNDATION THAT IS QUALIFIED UNDER SECTION  
27 501(c)(3) OF THE UNITED STATES INTERNAL REVENUE CODE FOR FEDERAL INCOME  
28 TAX PURPOSES. THE FOUNDATION MUST:

- 29 1. HAVE BEEN IN EXISTENCE FOR AT LEAST TWENTY YEARS.
- 30 2. HAVE A MISSION THAT INCLUDES PROVIDING COLLEGE SCHOLARSHIPS TO:
  - 31 (a) THE SONS AND DAUGHTERS OF THOSE WHO HAVE SERVED THE UNITED  
32 STATES HONORABLY AS SOLDIERS IN THE UNITED STATES ARMY.
  - 33 (b) THE SPOUSES OF ENLISTED SOLDIERS ON ACTIVE DUTY IN THE UNITED  
34 STATES ARMY.
- 35 3. ENVISION INCREASING ITS FUNDRAISING AND VISIBILITY TO ENCOURAGE  
36 MORE APPLICANTS TO APPLY FOR SCHOLARSHIPS AND TO PROVIDE LARGER  
37 SCHOLARSHIPS TO AN INCREASING NUMBER OF DESERVING APPLICANTS TO BOTH:
  - 38 (a) REWARD ARMY FAMILIES FOR THE SACRIFICES THAT ARMY SOLDIERS MAKE  
39 EVERY DAY TO SERVE THEIR NATION.
  - 40 (b) HELP THE SPOUSES AND CHILDREN OF ARMY SOLDIERS BECOME LEADERS  
41 IN SOCIETY.
- 42 4. AWARD SCHOLARSHIP MONIES TO:
  - 43 (a) CHILDREN OF FORMER UNITED STATES ARMY MEMBERS WHO WERE KILLED  
44 WHILE SERVING IN THE UNITED STATES ARMY OR WHO RECEIVED AN HONORABLE  
45 DISCHARGE OR MEDICAL DISCHARGE.
