## CHAPTER 61

# HOUSE BILL 2649

AN ACT

AMENDING SECTION 37-620, ARIZONA REVISED STATUTES; RELATING TO  
JURISDICTION ON FEDERALLY ADMINISTERED LANDS.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 37-620, Arizona Revised Statutes, is amended to  
3 read:

4 37-620. Vesting of concurrent criminal jurisdiction in the  
5 United States over certain lands and areas

6 A. Concurrent criminal jurisdiction over any lands in this state  
7 heretofore reserved from public domain or acquired by the United States as  
8 identified in subsection D of this section, and any additions made to such  
9 lands, is hereby vested in the United States on completion of the  
10 conditions set forth in subsection B of this section, except that the  
11 jurisdiction of this state over such lands shall continue.

12 B. Concurrent criminal jurisdiction vests as to the lands in each  
13 area identified in subsection D of this section when the United States  
14 submits to the governor of this state a formal written request for  
15 concurrent criminal jurisdiction accompanied by a satisfactory legal  
16 description and plat of the area, and on approval by the governor granting  
17 concurrent jurisdiction the legal description and plat shall be filed by  
18 the governor with the county recorder of each county in which the land is  
19 situated. This state may withdraw jurisdiction over any land or area  
20 three years after written notification by the governor to the UNITED  
21 STATES secretary of the interior.

22 C. The concurrent criminal jurisdiction hereby vested continues  
23 only as long as the United States continues to own or control the lands  
24 within those areas. In the case of any lands included within the  
25 boundaries of the areas set forth in subsection D of this section that are  
26 not owned or controlled by the United States, the jurisdiction does not  
27 change by operation of this section.

28 D. The lands subject to this section are all those lands that are  
29 owned or controlled by the United States and that are now or hereafter  
30 included within the exterior boundaries of:

- 31 1. The national park service lands consisting of:  
32 (a) Canyon de Chelly national monument.  
33 (b) Casa Grande Ruins national monument.  
34 (c) Chiricahua national monument.  
35 (d) Coronado national memorial.  
36 (e) Fort Bowie national historic site.  
37 (f) Glen Canyon national recreation area.  
38 (g) Grand Canyon national park.  
39 (h) Hohokam Pima national monument.  
40 (i) Hubbell Trading Post national historic site.  
41 (j) Lake Mead national recreation area.  
42 (k) Montezuma Castle national monument.  
43 (l) Navajo national monument.  
44 (m) Organ Pipe Cactus national monument.  
45 (n) Petrified Forest national park.

- 1 (o) Pipe Spring national monument.
- 2 (p) Saguaro national monument.
- 3 (q) Sunset Crater national monument.
- 4 (r) Tonto national monument.
- 5 (s) Tumacacori national monument.
- 6 (t) Tuzigoot national monument.
- 7 (u) Walnut Canyon national monument.
- 8 (v) Wupatki national monument.

9 2. Those lands administered by the bureau of reclamation or its  
10 successor agency of the United States department of the interior  
11 consisting of:

- 12 (a) Davis dam.
- 13 (b) Glen Canyon dam.
- 14 (c) Hoover dam.
- 15 (d) Imperial dam.
- 16 (e) Laguna dam.
- 17 (f) Parker dam.

18 3. Lands administered by the United States department of defense or  
19 its successor land management agency consisting of:

20 (a) The Barry M. Goldwater range. This **paragraph SUBDIVISION** is  
21 effective only after a memorandum of understanding has been completed with  
22 the sheriff of a county that has territory within the Barry M. Goldwater  
23 range to address lead investigative agency responsibilities on specific  
24 crimes and other coordinating matters. For the purposes of this **paragraph**  
25 **SUBDIVISION**, the Barry M. Goldwater range is defined by the military lands  
26 withdrawal act of 1999 (P.L. 106-65) and federal register volume 66,  
27 number 231, Friday, November 30, 2001.

28 (b) **THE YUMA PROVING GROUND. THIS SUBDIVISION IS EFFECTIVE ONLY**  
29 **AFTER A MEMORANDUM OF UNDERSTANDING HAS BEEN COMPLETED WITH THE SHERIFF OF**  
30 **A COUNTY THAT HAS TERRITORY WITHIN THE YUMA PROVING GROUND TO ADDRESS LEAD**  
31 **INVESTIGATIVE AGENCY RESPONSIBILITIES ON SPECIFIC CRIMES AND OTHER**  
32 **COORDINATING MATTERS.**
