**AN ACT**

**AMENDING TITLE 8, CHAPTER 4, ARTICLE 8, ARIZONA REVISED STATUTES, BY  
ADDING SECTION 8-812; RELATING TO THE DEPARTMENT OF CHILD SAFETY.**

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Title 8, chapter 4, article 8, Arizona Revised Statutes,  
3 is amended by adding section 8-812, to read:  
4 8-812. Investigation; schools; children with disabilities;  
5 definitions  
6 A. A CHILD SAFETY WORKER OR A CHILD SAFETY INVESTIGATOR MAY ENTER A  
7 SCHOOL THAT TEACHES A CHILD WITH A DISABILITY TO INVESTIGATE A REPORT OF  
8 ABUSE OF SUCH A CHILD AT THE SCHOOL.  
9 B. FOR THE PURPOSES OF THIS SECTION:  
10 1. "CHILD" MEANS EITHER OF THE FOLLOWING:  
11 (a) AN INDIVIDUAL WHO IS UNDER EIGHTEEN YEARS OF AGE.  
12 (b) AN INDIVIDUAL WHO IS AT LEAST EIGHTEEN AND UNDER TWENTY-THREE  
13 YEARS OF AGE AND WHO IS ENROLLED IN HIGH SCHOOL.  
14 2. "CHILD WITH A DISABILITY" MEANS A CHILD WHO IS ANY OF THE  
15 FOLLOWING:  
16 (a) IDENTIFIED AS HAVING A DISABILITY UNDER SECTION 504 OF THE  
17 REHABILITATION ACT OF 1973 (29 UNITED STATES CODE SECTION 794).  
18 (b) IDENTIFIED BY A SCHOOL DISTRICT OR BY AN INDEPENDENT THIRD  
19 PARTY PURSUANT TO SECTION 15-2403, SUBSECTION I AS A CHILD WITH A  
20 DISABILITY AS DEFINED IN SECTION 15-731 OR 15-761.  
21 (c) A CHILD WITH A DISABILITY WHO IS ELIGIBLE TO RECEIVE SERVICES  
22 FROM A SCHOOL DISTRICT UNDER SECTION 15-763.  
23 (d) A CHILD WITH A DISABILITY AS DEFINED IN 42 UNITED STATES CODE  
24 SECTION 12102.
