SENATE AMENDMENTS TO H.B. 2190
(Reference to House engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 36, Arizona Revised Statutes, is amended by adding
3 chapter 16, to read:

4 CHAPTER 16

5 VACCINE REQUIREMENTS PROHIBITED

6 ARTICLE 1. GENERAL PROVISIONS

7 36-1801. Business entities

8 A BUSINESS ENTITY DOING BUSINESS IN THIS STATE MAY NOT REFUSE TO
9 PROVIDE ANY SERVICE, PRODUCT, ADMISSION TO A VENUE OR TRANSPORTATION TO A
10 PERSON BECAUSE THAT PERSON HAS OR HAS NOT RECEIVED A VACCINE.

11 36-1802. Ticket issuers

12 A TICKET ISSUER MAY NOT PENALIZE, DISCRIMINATE AGAINST OR DENY ACCESS
13 TO AN ENTERTAINMENT EVENT TO A TICKET HOLDER BECAUSE THE TICKET HOLDER HAS
14 OR HAS NOT RECEIVED A VACCINE.

15 36-1803. Government vaccine requirements prohibited;
16 exceptions

17 NOTWITHSTANDING SECTION 36-787, SUBSECTION C, PARAGRAPH 1 THIS STATE
18 OR A COUNTY OR LOCAL GOVERNMENT ENTITY OR OFFICIAL IN THIS STATE MAY NOT
19 REQUIRE A PERSON TO RECEIVE A VACCINE, EXCEPT FOR THE FOLLOWING:

20 1. EMPLOYEES OF A HOSPITAL OR ANY OTHER HEALTH CARE INSTITUTION.

21 2. STUDENTS OR FACULTY OF A PUBLIC PRIMARY OR SECONDARY SCHOOL.

22 THIS PARAGRAPH DOES NOT APPLY TO A STUDENT IF THE STUDENT'S PARENT OR
23 GUARDIAN IS OPPOSED TO A VACCINE AND OBJECTS BY A WRITTEN SWORN STATEMENT
24 TO THE STUDENT RECEIVING THE VACCINE BASED ON RELIGIOUS GROUNDS OR
25 CONSCIENTIOUSLY HELD BELIEFS.

36-1804. Government services; condition on vaccine prohibited

THIS STATE OR A COUNTY OR LOCAL GOVERNMENT ENTITY OR OFFICIAL IN THIS STATE MAY NOT REQUIRE A PERSON TO RECEIVE A VACCINE AS A CONDITION FOR ANY OF THE FOLLOWING:

- 1. RECEIPT OF A GOVERNMENT BENEFIT.
- 2. RECEIPT OF A GOVERNMENT SERVICE.
- 3. RECEIPT OF A GOVERNMENT-ISSUED LICENSE, PERMIT OR CERTIFICATION.
- 4. ENTRANCE INTO A PUBLIC BUILDING.
- 5. USE OF PUBLIC TRANSPORTATION.

36-1805. Vaccine incentives prohibited

THIS STATE OR A COUNTY OR LOCAL GOVERNMENT ENTITY OR OFFICIAL IN THIS STATE MAY NOT PROVIDE A SPECIAL PRIVILEGE, FINANCIAL BENEFIT OR OTHER INCENTIVE TO A PERSON FOR RECEIVING A VACCINE.

36-1806. Violation; classification

A PERSON THAT VIOLATES THIS CHAPTER IS GUILTY OF A CLASS 5 FELONY.

36-1807. Business entities; violation; license, permit or certification suspension

IF A BUSINESS ENTITY VIOLATES SECTION 36-1801 OR 36-1802, THE COURT SHALL ORDER THE SUSPENSION OF ALL LICENSES, PERMITS OR CERTIFICATIONS ISSUED BY THIS STATE OR A POLTIICAL SUBDIVISION OF THIS STATE THAT ARE HELD BY THE BUSINESS ENTITY FOR AT LEAST THIRTY DAYS AND NOT MORE THAN ONE YEAR."
