SENATE AMENDMENTS TO S.C.R. 1006
(Reference to printed resolution)

1 Strike everything after the resolving clause and insert:

2 "1. Article IV, part 2, section 3, Constitution of Arizona, is
3 proposed to be amended as follows if approved by the voters and on
4 proclamation of the Governor:

5 3. Sessions of legislature; special sessions; limitation
6 of subjects for consideration; presidential
7 electors

8 Section 3. A. The sessions of the legislature shall be
9 held annually at the capitol of the state, ~~and~~ and shall commence
10 on the second Monday of January of each year. The governor may
11 call a special session, whenever in ~~his~~ THE GOVERNOR'S judgment
12 it is advisable. In calling a special session, the governor
13 shall specify the subjects to be considered, and at such
14 special session no laws shall be enacted except such as relate
15 to the subjects mentioned in the call.

16 B. THE LEGISLATURE SHALL HOLD A SPECIAL SESSION AT THE
17 STATE CAPITOL COMMENCING ON THE MONDAY FOLLOWING THE DATE
18 DESIGNATED FOR THE ELECTION OF THE PRESIDENT AND VICE PRESIDENT
19 OF THE UNITED STATES. THE PURPOSE OF THE SPECIAL SESSION IS TO
20 REVIEW OR INVESTIGATE THE RESULTS OF THE ELECTION IN THIS
21 STATE, AS NEEDED, BEFORE CERTIFYING THE RESULTS OF THE
22 SELECTION OF PRESIDENTIAL ELECTORS. THE LEGISLATURE HAS SOLE
23 AUTHORITY TO APPOINT THE PRESIDENTIAL ELECTORS WHO WILL CAST
24 THIS STATE'S VOTES IN THE ELECTORAL COLLEGE AND SHALL EXERCISE
25 THAT AUTHORITY WITHOUT INTERFERENCE AND CONSISTENT WITH

1 ARTICLE II, SECTION 1 OF THE CONSTITUTION OF THE UNITED STATES.
2 THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND THE PRESIDENT
3 OF THE SENATE SHALL JOINTLY CERTIFY TO THE GOVERNOR THE NAMES
4 OF THE APPOINTED PRESIDENTIAL ELECTORS, AND THE GOVERNOR SHALL
5 SUBMIT THOSE NAMES TO THE PRESIDENT OF THE UNITED STATES
6 SENATE.

7 2. Article V, section 10, Constitution of Arizona, is proposed to be
8 amended as follows if approved by the voters and on proclamation of the
9 Governor:

10 10. Canvass of election returns for state officers;
11 certificates of election

12 Section 10. EXCEPT AS OTHERWISE PROVIDED FOR
13 PRESIDENTIAL ELECTORS, the returns of the election for all
14 state officers shall be canvassed, and certificates of election
15 issued by the secretary of state, in such manner as may be
16 provided by law.

17 3. The Secretary of State shall submit this proposition to the
18 voters at the next general election as provided by article XXI,
19 Constitution of Arizona."
