# SENATE BILL 1604

AN ACT

AMENDING SECTION 32-1934, ARIZONA REVISED STATUTES; RELATING TO THE  
ARIZONA STATE BOARD OF PHARMACY.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 32-1934, Arizona Revised Statutes, is amended to  
3 read:

4 32-1934. Pharmacies operated in connection with hospitals;  
5 requirements

6 A. A pharmacy operating in connection with a hospital shall comply  
7 with all the provisions of this chapter requiring registration and  
8 regulation of pharmacies and with board rules.

9 B. FOR a pharmacy operating in connection with a hospital, ~~shall~~  
10 ~~also meet~~ ALL OF the following ~~requirements~~ APPLY:

11 1. In hospitals with fifty beds or more, the pharmacy shall be  
12 under the continuous supervision of a pharmacist during the time it is  
13 open for pharmacy services, except that the board by rule may establish  
14 requirements to allow a pharmacist who is engaged in hospital business to  
15 be in other areas of the hospital that are located outside the pharmacy.

16 2. EXCEPT AS OTHERWISE PROVIDED IN THIS PARAGRAPH, in hospitals  
17 with ~~less~~ FEWER than fifty beds, with the written approval and  
18 recommendations of the board, the services of a pharmacist shall be  
19 required on a part-time basis according to the needs of the hospital,  
20 provided that this approval does not ~~permit the compounding,~~  
21 ~~manufacturing, dispensing, labeling, packaging or processing of drugs by~~  
22 ALLOW A PERSON other than a pharmacist TO COMPOUND, MANUFACTURE, DISPENSE,  
23 LABEL, PACKAGE, OR PROCESS DRUGS. HOSPITALS WITH FEWER THAN FIFTY BEDS  
24 THAT ARE LOCATED IN A COUNTY WITH A POPULATION OF LESS THAN FIVE HUNDRED  
25 THOUSAND PERSONS WITH THE WRITTEN APPROVAL AND RECOMMENDATIONS OF THE  
26 BOARD, MAY OPERATE A REMOTE DISPENSING SITE PHARMACY UNDER THE REMOTE  
27 SUPERVISION OF A PHARMACIST PURSUANT TO SECTION 32-1961.01 DURING THE TIME  
28 THE PHARMACY IS OPEN FOR PHARMACY SERVICES.

29 3. In the pharmacist's absence from the hospital, the supervisory  
30 registered nurse may obtain from the pharmacy necessary doses of drugs  
31 that are ordered by a medical practitioner and that are needed by a  
32 patient in an emergency, according to procedures recommended and approved  
33 by the board for each hospital.

34 4. All drugs and medications furnished from the pharmacy to  
35 patients on discharge from the hospital shall be dispensed by a  
36 pharmacist, and the medication shall be properly labeled.

37 5. The pharmacist in charge shall initiate procedures to provide  
38 for the administrative and technical guidance in all matters pertaining to  
39 ~~the~~ acquiring, stocking, ~~record keeping~~ and dispensing ~~of~~ drugs and  
40 devices AND RECORDKEEPING REQUIREMENTS.
