**AMENDING TITLE 36, CHAPTER 1, ARTICLE 2, ARIZONA REVISED STATUTES, BY
ADDING SECTION 36-149; RELATING TO THE DEPARTMENT OF HEALTH SERVICES.**

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 36, chapter 1, article 2, Arizona Revised
3 Statutes, is amended by adding section 36-149, to read:

4 36-149. Contract limits; applicant eligibility; personal
5 responsibility education program; sexual risk
6 avoidance education grant program; rules;
7 definition

8 A. THE DEPARTMENT MAY NOT ENTER INTO ANY CONTRACT ON OR AFTER THE
9 EFFECTIVE DATE OF THIS SECTION TO ADMINISTER THE PERSONAL RESPONSIBILITY
10 EDUCATION PROGRAM AS SPECIFIED IN 42 UNITED STATES CODE SECTION 713 OR THE
11 SEXUAL RISK AVOIDANCE EDUCATION GRANT PROGRAM AUTHORIZED PURSUANT TO 42
12 UNITED STATES CODE SECTION 710 WITH ANY APPLICANT ENTITY THAT PERFORMS
13 ABORTIONS, PROMOTES ABORTIONS, MAINTAINS OR OPERATES A FACILITY WHERE
14 ABORTIONS ARE PERFORMED OR PROMOTED OR CONTRACTS OR SUBCONTRACTS WITH AN
15 ENTITY THAT PERFORMS OR PROMOTES ABORTIONS.

16 B. THE DEPARTMENT SHALL ADOPT RULES REQUIRING THAT, AS A CONDITION
17 OF ELIGIBILITY AS AN APPLICANT, GRANTEE OR GRANTEE CONTRACTOR OR
18 SUBCONTRACTOR UNDER THE PERSONAL RESPONSIBILITY EDUCATION PROGRAM OR
19 SEXUAL RISK AVOIDANCE EDUCATION GRANT PROGRAM, EACH DISTINCT LOCATION OF
20 THE APPLICANT, GRANTEE OR GRANTEE CONTRACTOR OR SUBCONTRACTOR BE ASSIGNED
21 A DISTINCT IDENTIFICATION NUMBER AND COMPLETE AN ATTESTATION THAT
22 ABORTIONS ARE NOT PERFORMED AT THAT DISTINCT LOCATION.

23 C. FOR THE PURPOSES OF THIS SECTION, "ABORTION" HAS THE SAME
24 MEANING PRESCRIBED IN SECTION 36-2151.
