SENATE AMENDMENTS TO S.B. 1036
(Reference to printed bill)

1 Page 1, between lines 24 and 25, insert:

2 "C. THE DEPARTMENT OF EDUCATION SHALL ESTABLISH A PROCESS FOR ANY
3 PERSON TO FILE A COMPLAINT WITH THE DEPARTMENT FOR ANY VIOLATION OF
4 SUBSECTION A, PARAGRAPH 3 OR 4 OF THIS SECTION. AFTER RECEIVING A
5 COMPLAINT, THE DEPARTMENT SHALL NOTIFY THE SCHOOL DISTRICT SUPERINTENDENT
6 OR THE PRINCIPAL OF THE CHARTER SCHOOL AND THE SCHOOL DISTRICT GOVERNING
7 BOARD OR CHARTER SCHOOL GOVERNING BODY OF THE SCHOOL DISTRICT OR CHARTER
8 SCHOOL AGAINST WHICH THE COMPLAINT WAS FILED. THE SCHOOL DISTRICT OR
9 CHARTER SCHOOL SHALL CORRECT THE VIOLATION WITHIN THIRTY DAYS AFTER BEING
10 NOTIFIED OF THE COMPLAINT UNDER THIS SUBSECTION AND SHALL NOTIFY THE
11 DEPARTMENT ONCE THE VIOLATION HAS BEEN CORRECTED. IF THE SCHOOL DISTRICT
12 OR CHARTER SCHOOL DOES NOT CORRECT THE VIOLATION WITHIN THIRTY DAYS AFTER
13 BEING NOTIFIED OF THE COMPLAINT UNDER THIS SUBSECTION, THE DEPARTMENT SHALL
14 NOTIFY THE ATTORNEY GENERAL FOR THE PURPOSES OF SUBSECTION D OF THIS
15 SECTION. IF THE SCHOOL DISTRICT OR CHARTER SCHOOL CORRECTS THE VIOLATION
16 AND THE DEPARTMENT RECEIVES A SUBSEQUENT COMPLAINT WITHIN THE SAME SCHOOL
17 YEAR OF THE SAME VIOLATION AT THE SAME SCHOOL AND IN THE SAME CLASSROOM OR,
18 IF APPLICABLE, OUTSIDE OF THE SAME SCHOOL BUILDING, THE DEPARTMENT SHALL
19 NOTIFY THE ATTORNEY GENERAL FOR THE PURPOSES OF SUBSECTION D OF THIS
20 SECTION."

21 Reletter to conform

22 Line 25, strike "VIOLATES" insert "FAILS TO CORRECT A VIOLATION OF SUBSECTION
23 A, PARAGRAPH 3 OR 4 OF"; after "SECTION" insert "WITHIN THIRTY DAYS AFTER
24 BEING NOTIFIED UNDER SUBSECTION C OF THIS SECTION"

1 Page 1, line 26, after the period insert "IF THE SCHOOL DISTRICT OR CHARTER
2 SCHOOL CORRECTS A VIOLATION AS PRESCRIBED IN SUBSECTION C OF THIS SECTION
3 AND THE DEPARTMENT OF EDUCATION RECEIVES A SUBSEQUENT COMPLAINT UNDER
4 SUBSECTION C OF THIS SECTION WITHIN THE SAME SCHOOL YEAR OF THE SAME
5 VIOLATION AT THE SAME SCHOOL AND IN THE SAME CLASSROOM OR, IF APPLICABLE,
6 OUTSIDE OF THE SAME SCHOOL BUILDING, THE SCHOOL DISTRICT OR CHARTER SCHOOL
7 THAT VIOLATES SUBSECTION A, PARAGRAPH 3 OR 4 OF THIS SECTION IS SUBJECT TO
8 A CIVIL PENALTY OF NOT MORE THAN \$1,000 FOR EACH VIOLATION."
